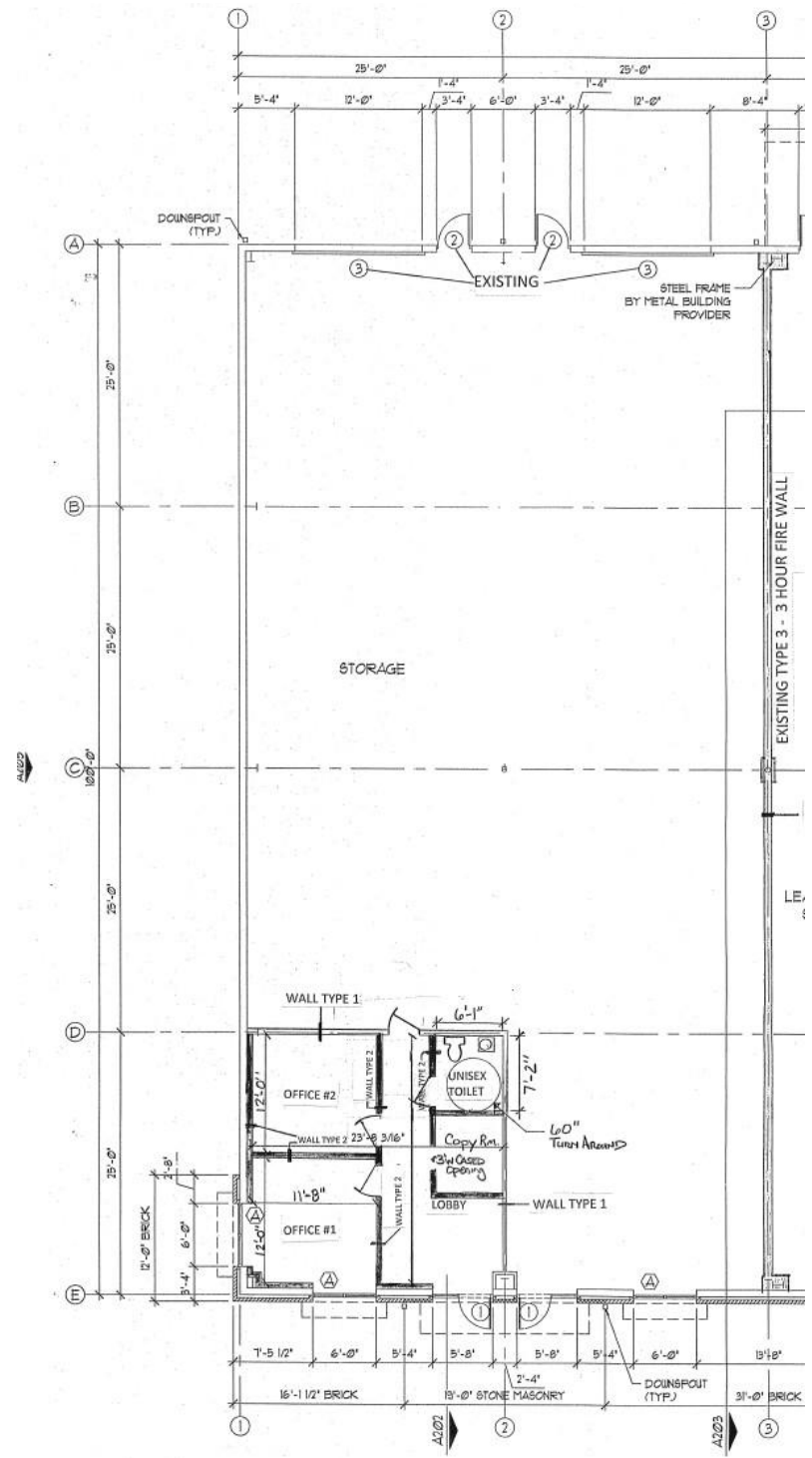

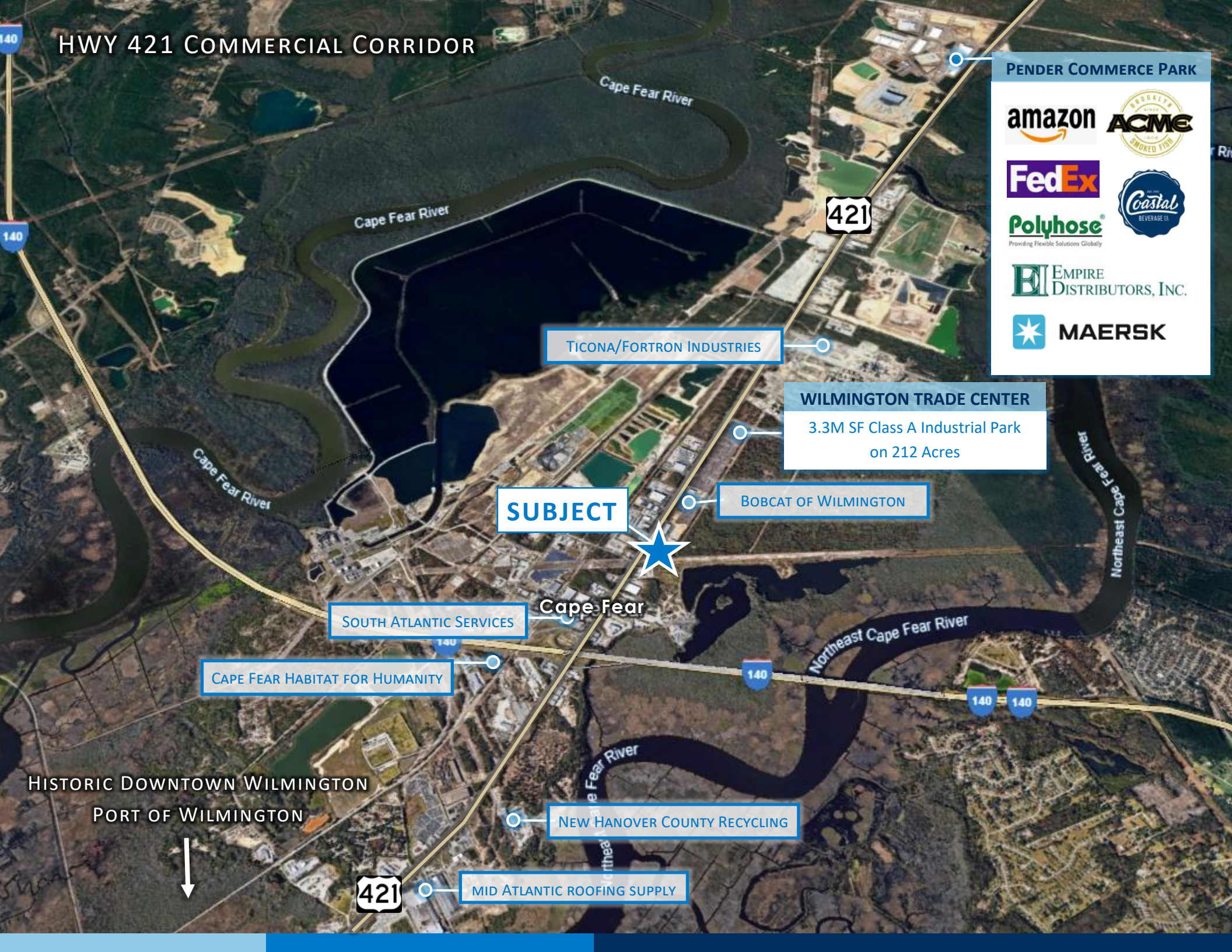


FLOORPLAN

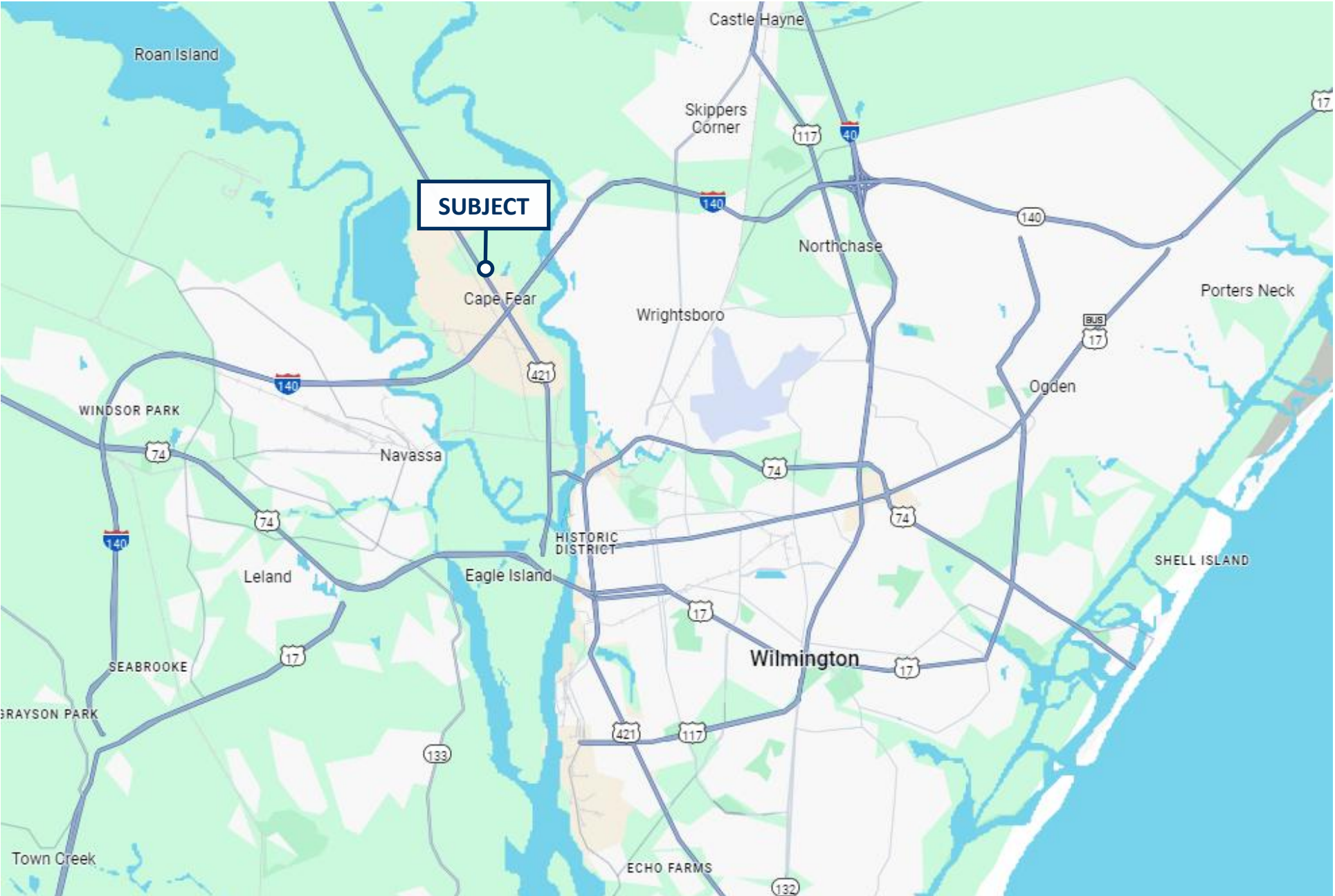
