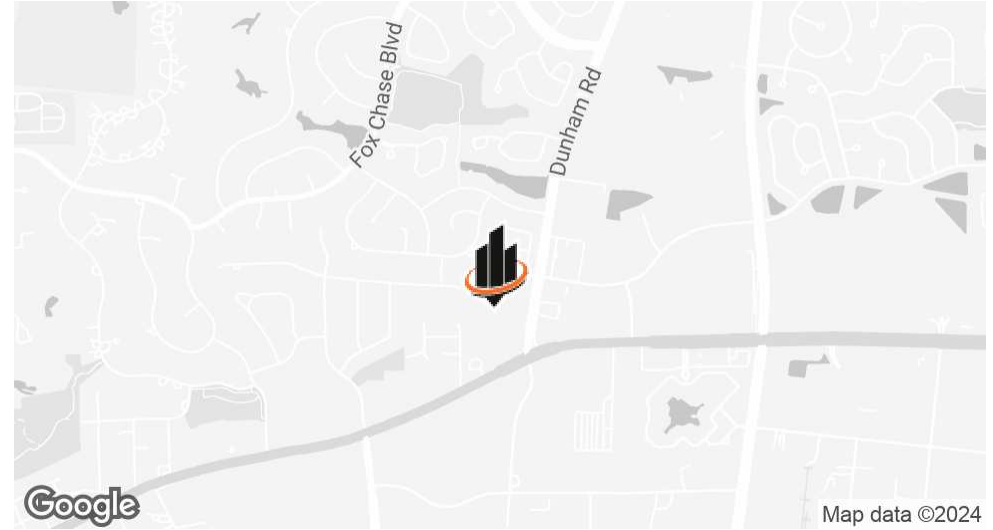

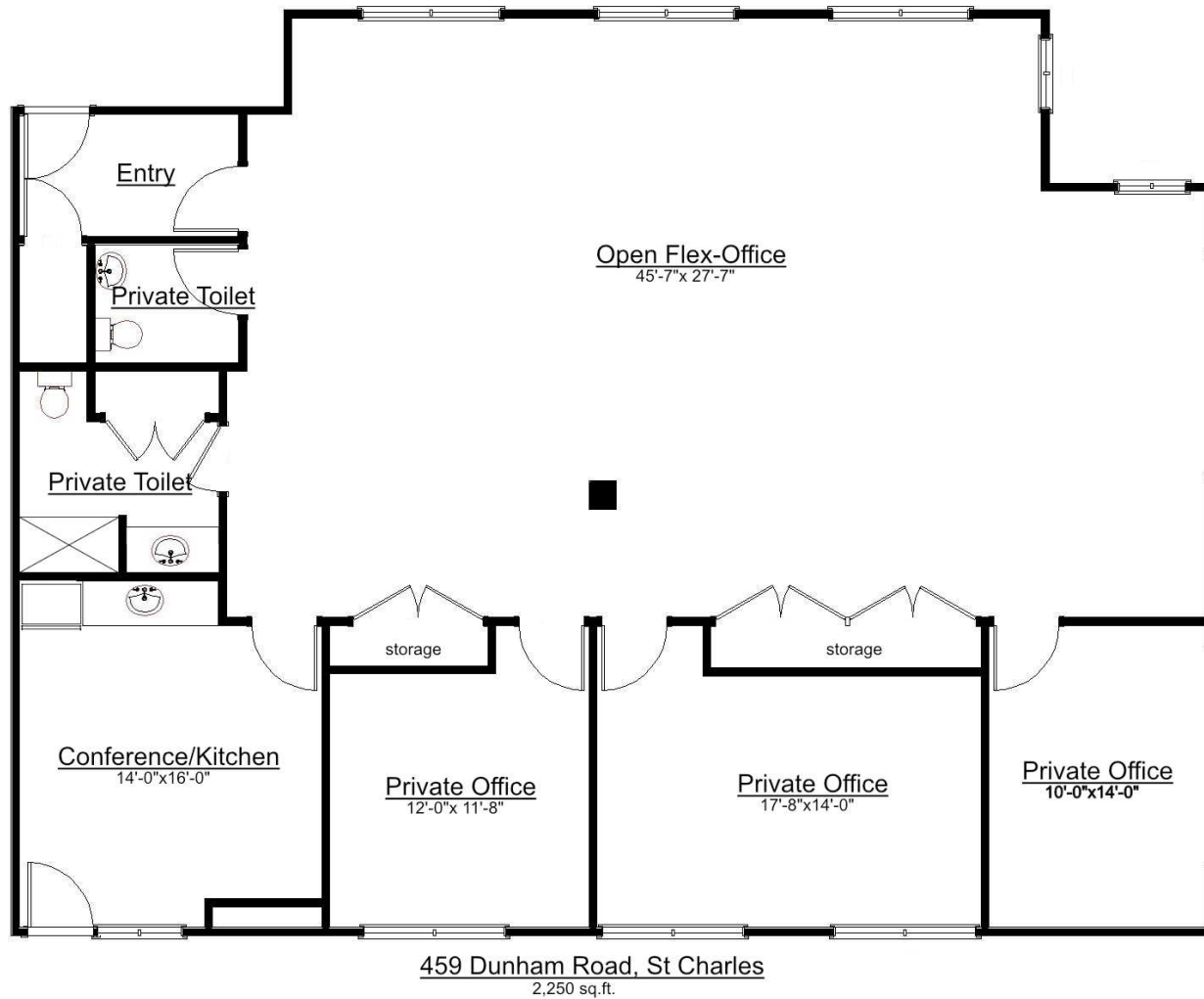

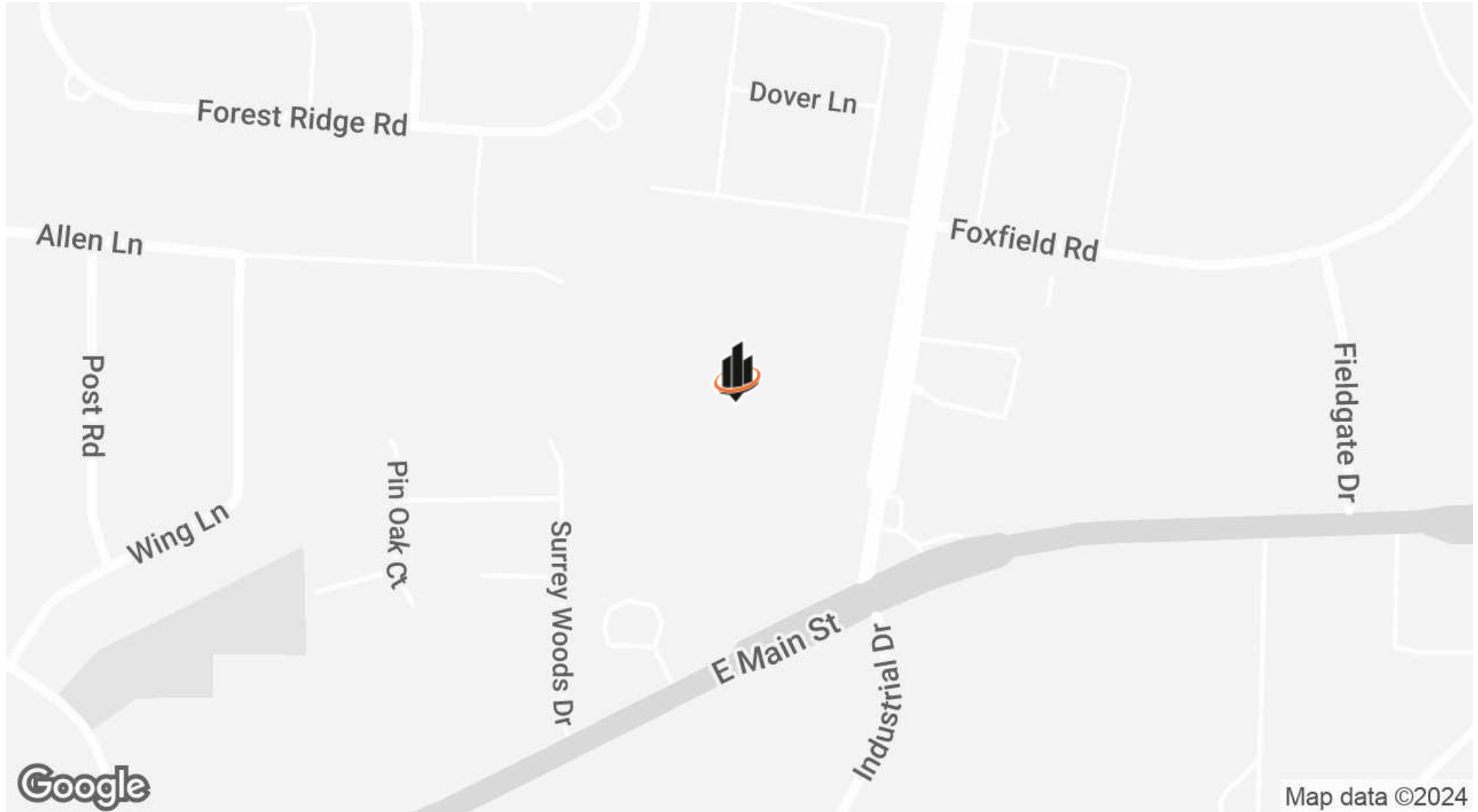
FLOOR PLAN

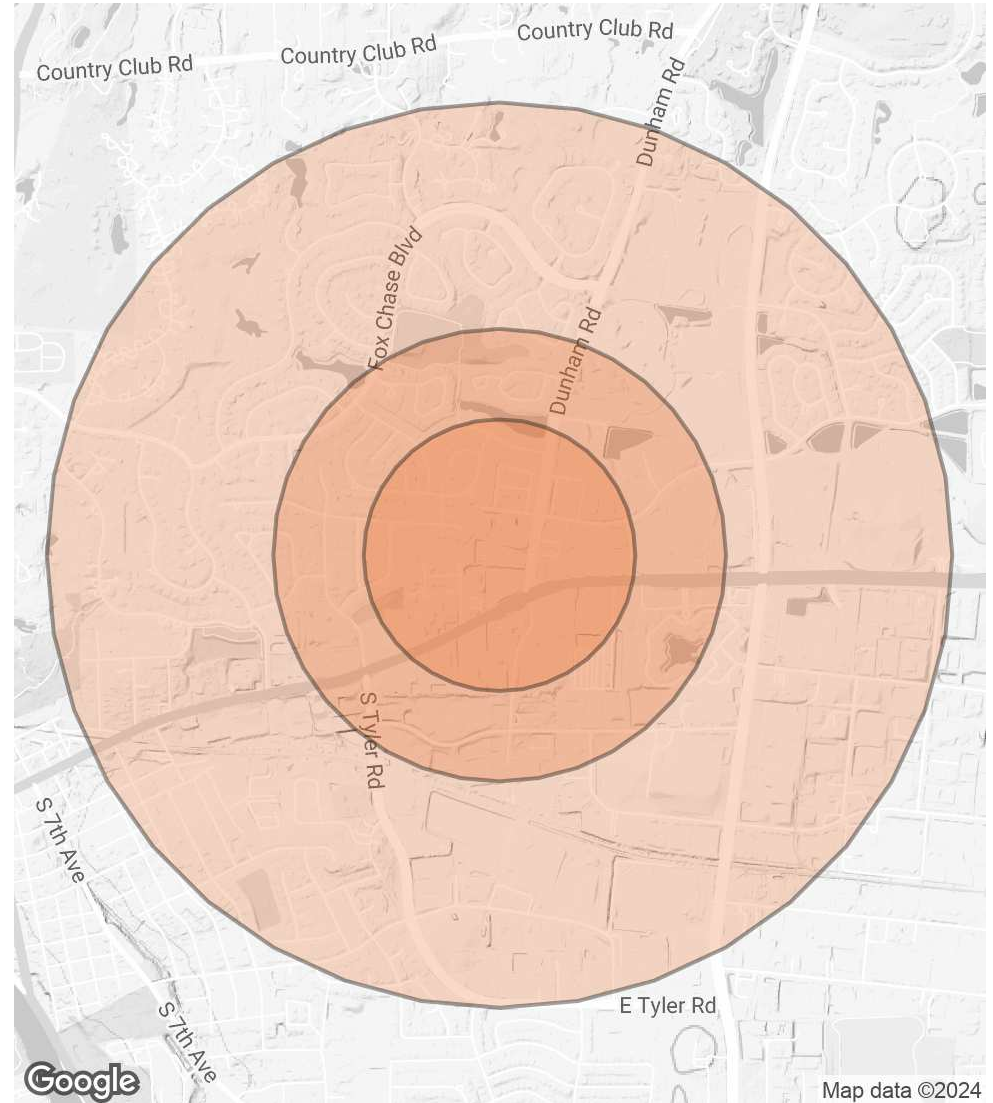
