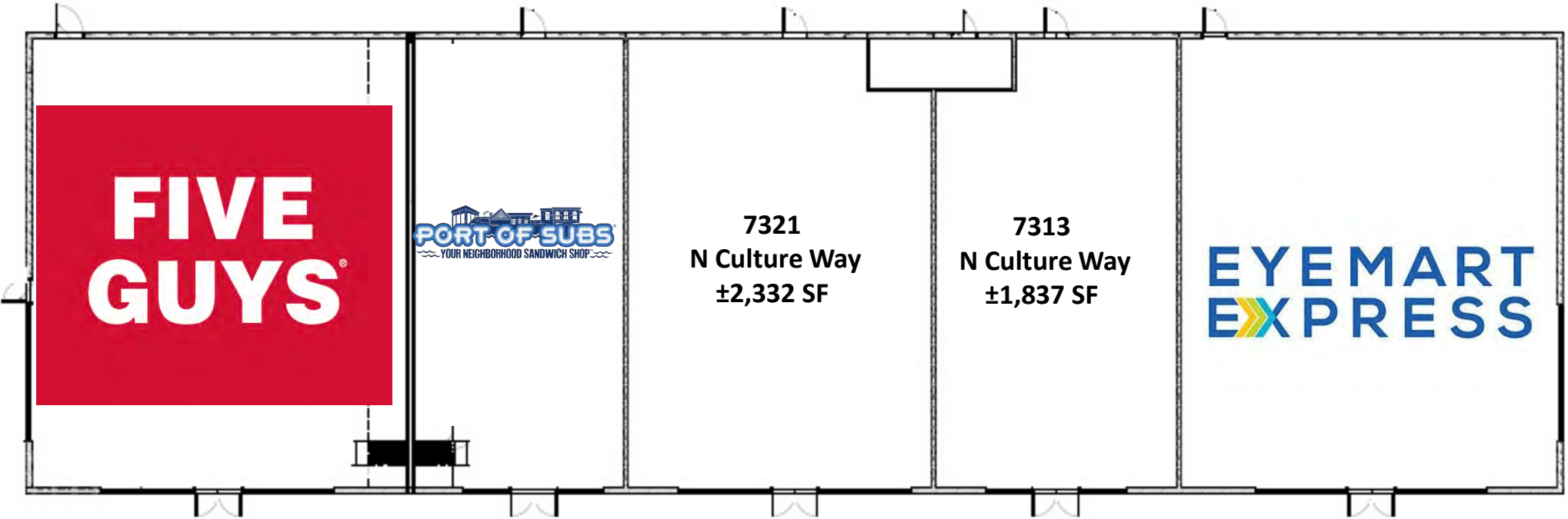

Proposed Floor Plan



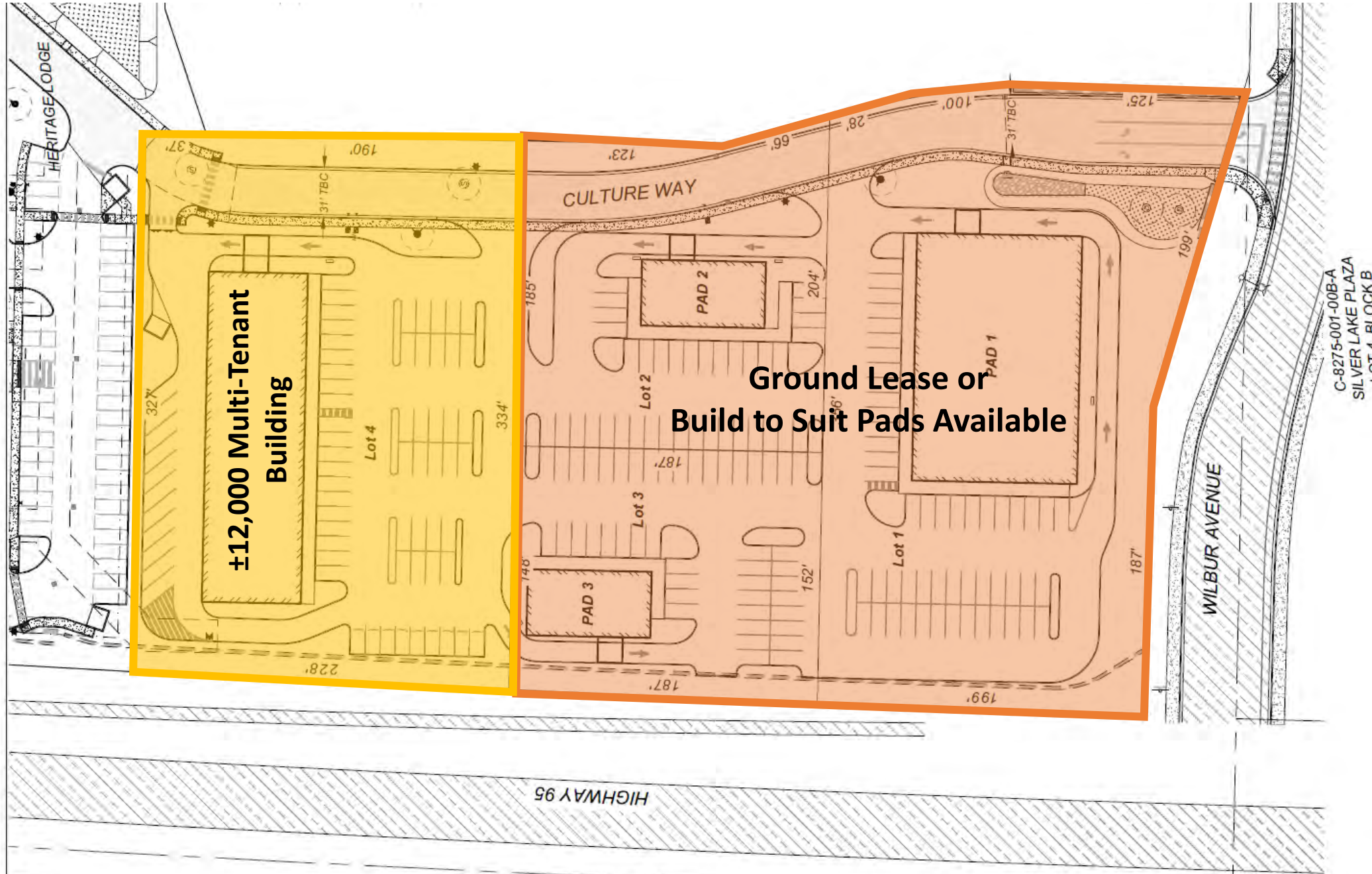

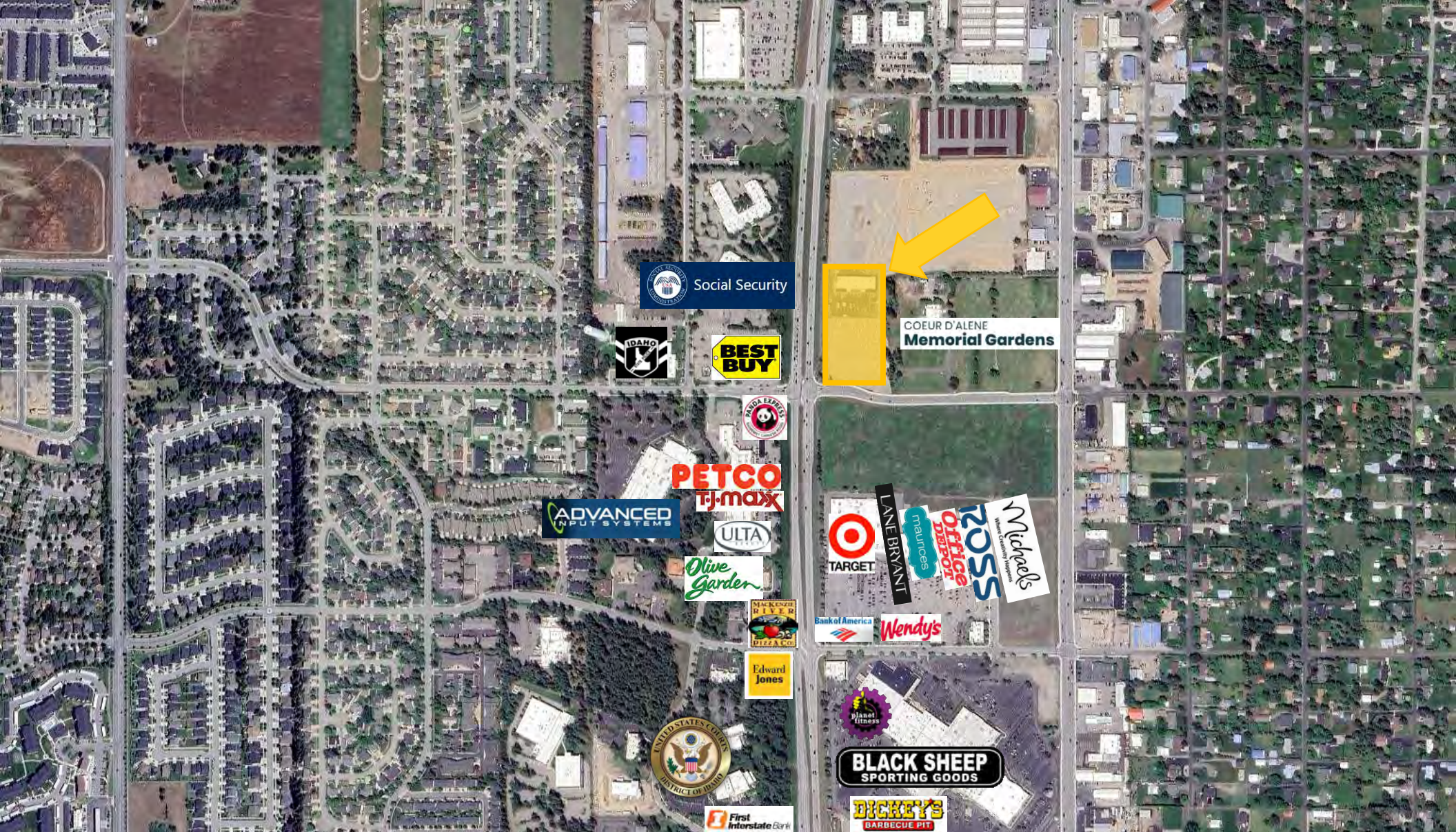
