SITE PLAN | N95 W25901 COUNTY LINE ROAD



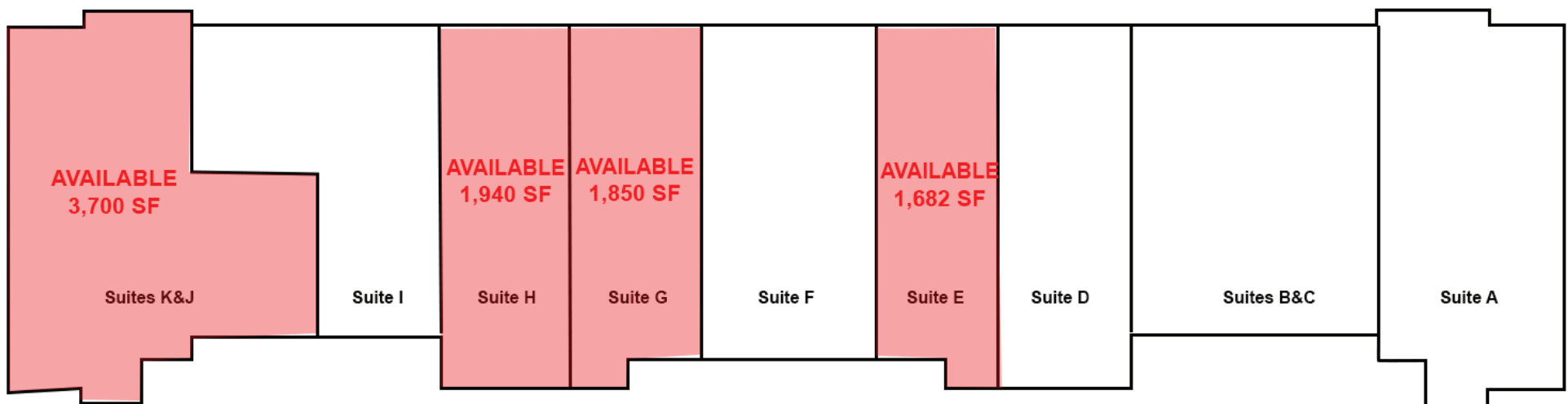

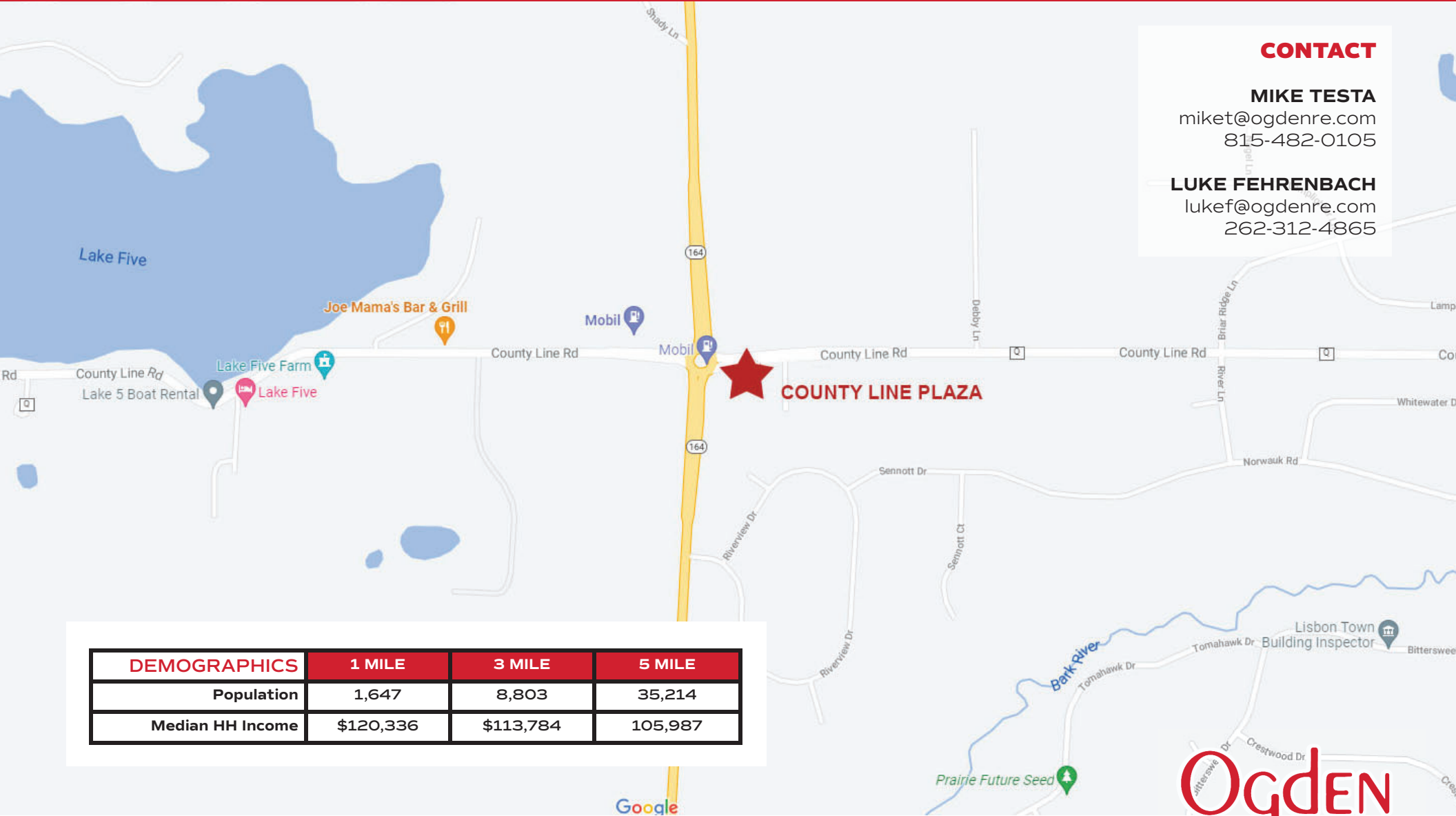
