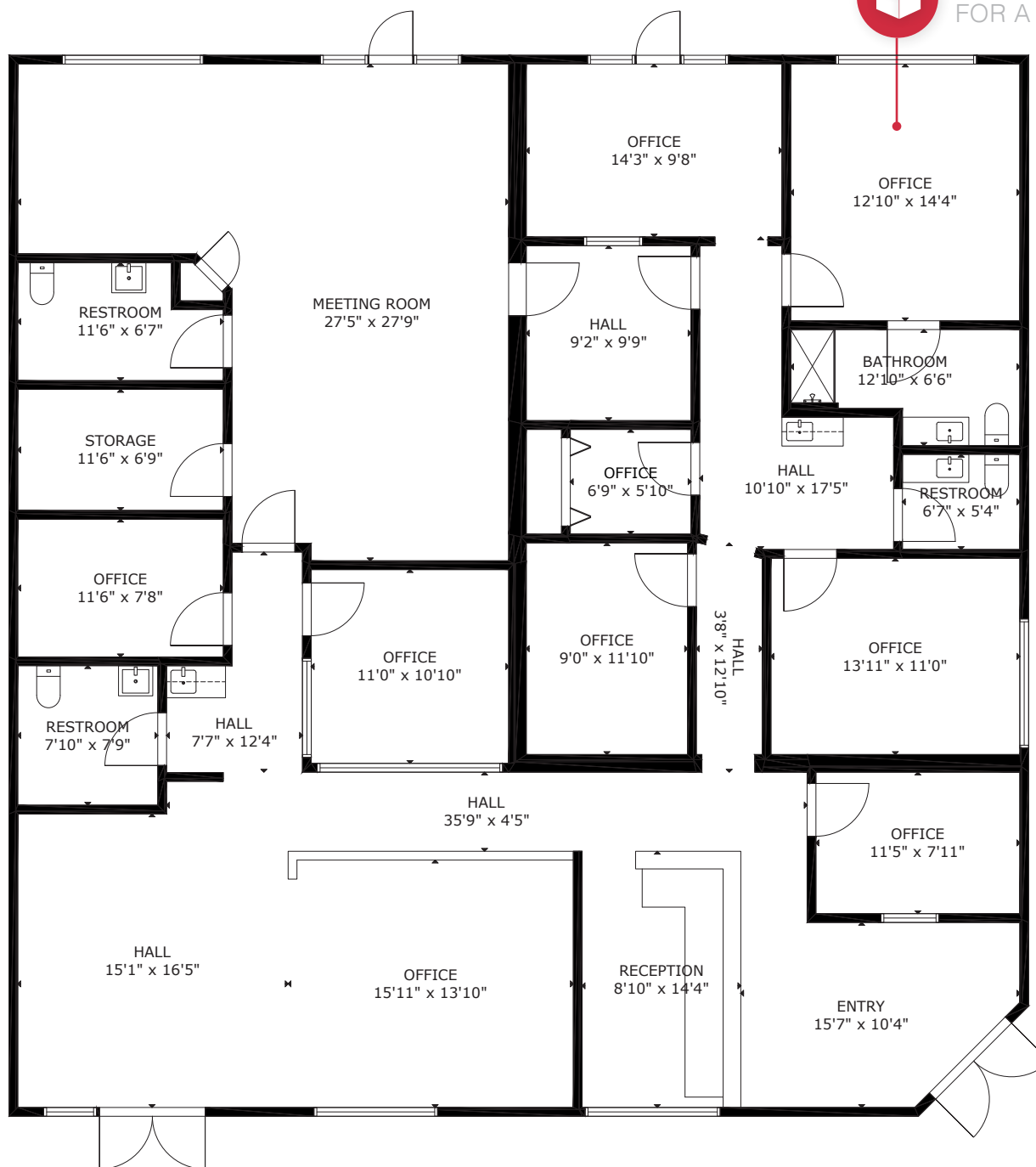

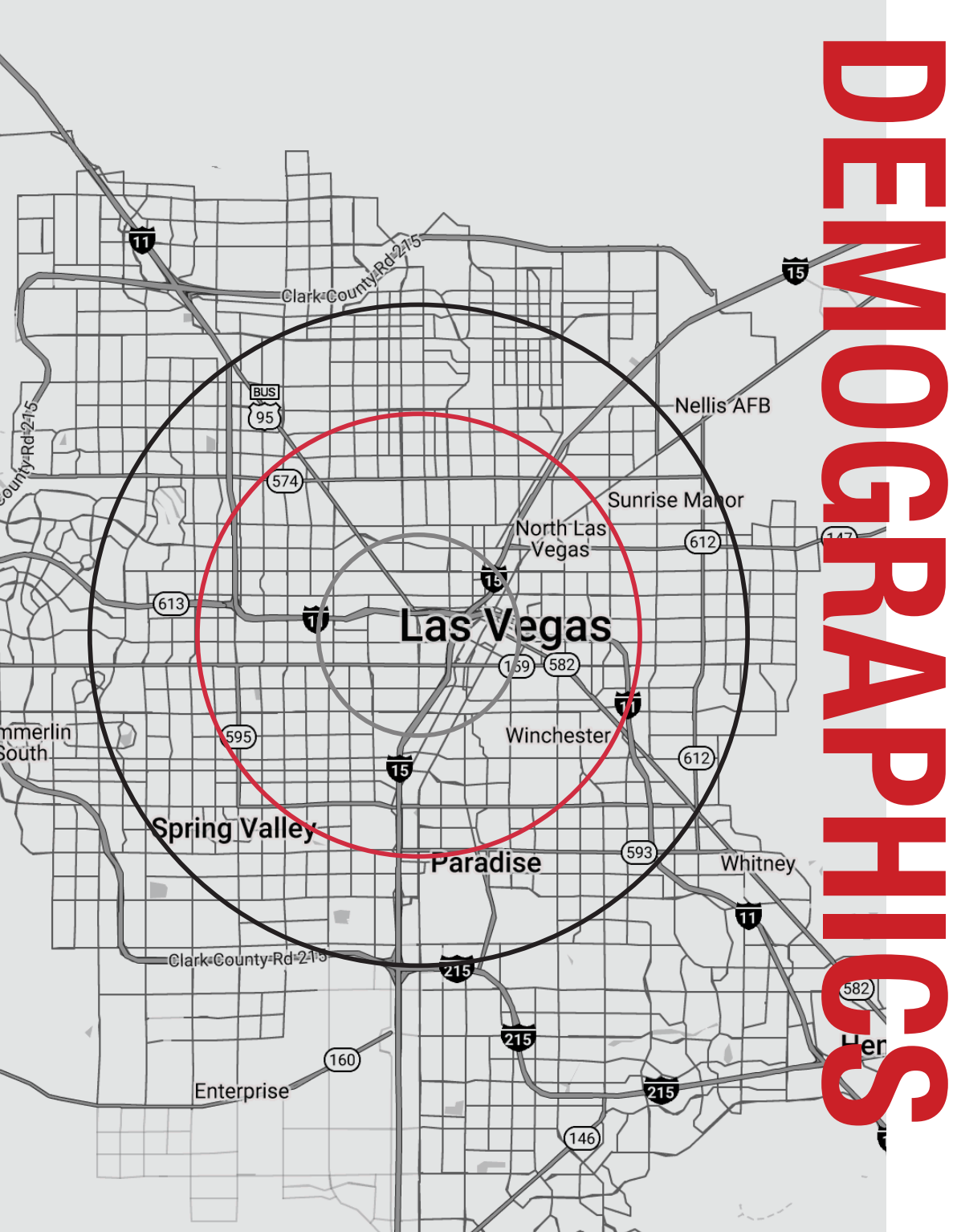


# AREA MAP
