

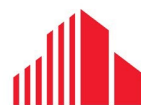

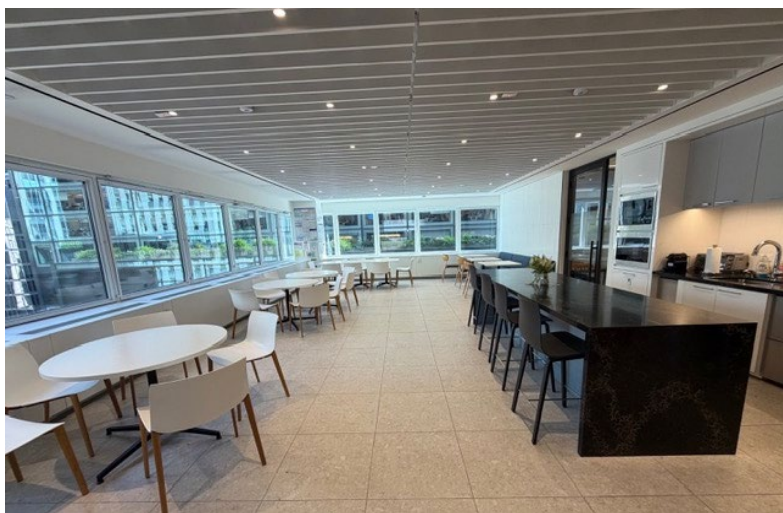

9TH FLOOR

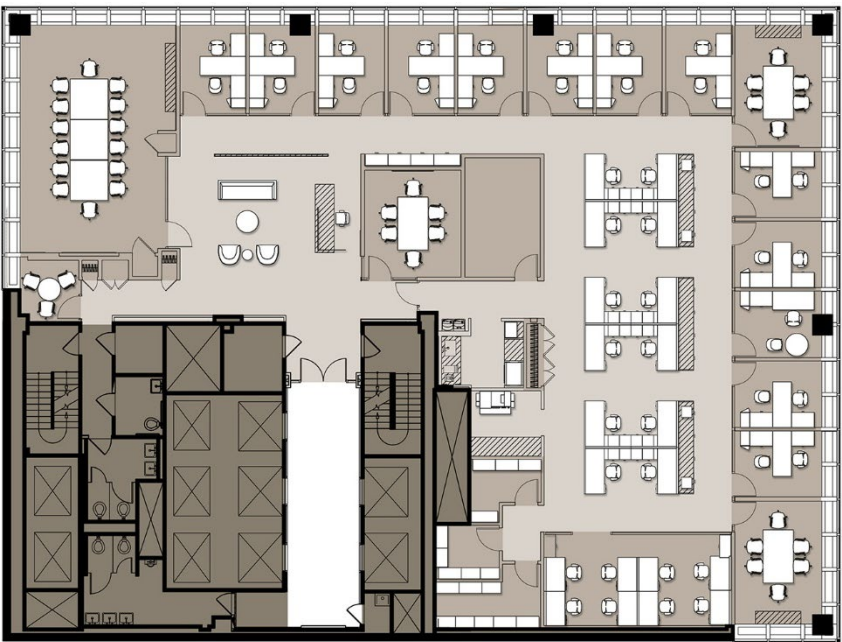
