

SURVEYOR'S CERTIFICATE 5669

I, Jon W. Badow, Wisconsin Professional Land Surveyor, do hereby certify that I have surveyed, divided and mapped this certified survey being Lot 1 of Oneida County Certified Survey Map # 2739 and located in part of the NW1/4 of the SE1/4, and the SW1/4 of the SE1/4, Section 10, T36N, R9E, Town of Pelican, Oneida County, Wisconsin, more particularly described as follows:

Commencing at an iron pipe on the westerly right of way line of C.T.H. "P" and marking the southwest corner of said Lot 1 of C.S.M. # 2739 and the point of beginning, thence along said right of way line along the arc of a curve concaved to the west and having a radius of 1095.92' and a long chord that bears N 11°52'39" W 465.90' a distance of 469.48' to an iron pipe on the westerly right of way line of C.T.H. "P", thence leaving said right of way line S 82°56'01" W a distance of 336.35' to an iron pipe on the easterly shore of Clear Lake, thence along a meander line of said Clear Lake S 77°39'11" E a distance of 72.22' to an iron pipe, thence continuing along said meander line S 20°18'23" W a distance of 63.42' to an iron pipe, thence S 27°15'55" W a distance of 138.70' to an iron pipe, thence S 24°48'35" E a distance of 62.49' to an iron pipe, thence S 51°53'31" E a distance of 82.38' to an iron pipe, thence S 50°02'27" E a distance of 142.53' to an iron pipe and end of meander line, thence leaving said lake shore S 85°57'56" E a distance of 245.00' to the point to of beginning.

Including those lands between the above described meander line and the normal high water mark of Clear Lake.

Subject to easements, restrictions, reservations and right of way of record or in use.




