Instrument No. 4368681/1 is registered against both the above Certificates of Title. Encumbrances noted herein are provided for information purposes only and have not been investigated as to their intent or extent.

As requested, this is to certify that we have made the necessary measurements to determine the position of a two storey brick and metal clad commercial building, numbered 2143/2145/2147 on the north side of Portage Avenue, in the City of Winnipeg, and find that the same, above ground level, is contained entirely within limits of the above described land, excepting Firstly: the southerly canopy encroaches a maximum of 4.5 feet onto Portage Avenue; and Secondly: the northerly metal landing and stairs encroach a maximum of 1.65 feet and 0.65 feet, respectively, onto the Public Lane.

Please note the position of a sign, as appurtenant to the subject property, which encroaches a maximum of 0.6 feet onto Portage Avenue.

There are no encroachments above ground level onto the above described land by buildings from adjoining properties, excepting the two storey metal clad building, as appurtenant to the adjoining property to the west, encroaches a maximum of 1.1 feet onto the subject property.

PLEASE NOTE THAT NO SURVEY MONUMENTS WERE REQUESTED TO BE INSTALLED AT PROPERTY CORNERS.




