#### BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

#### 2 BROKER DISCLOSURE TO CUSTOMERS

- 11 The duty to disclose to you in writing certain material adverse facts about a property, unless disclosure of the information is 12 prohibited by law (See Lines 47-55).
- 13 The duty to protect your confidentiality. Unless the law requires it, the broker will not disclose your confidential information or the 14 confidential information of other parties (See Lines 22-39).
- 15 The duty to safeguard trust funds and other property the broker holds.
- 16 The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and 17 disadvantages of the proposals.

Stat. § 452.01(1e) as a condition or occurrence 52 that a competent licensee generally recognizes will significantly and adversely affect the value of the property, significantly reduce 53 the structural integrity of improvements to real estate, or present a significant health risk to occupants of the property; or information 54 that indicates that a party to a transaction is not able to or does not intend to meet his or her obligations under a contract or 55 agreement made concerning the transaction.
