Boucher, by deed recorded in Volume 93067, Page 293, Deed Records, Dallas County, Texas, and being more particularly described as follows; BEGINNING at the intersection of the West line of Interstate Highway No. 35E, (a variable width R.O.W.), with the North line of The Meadows Parkway, (a 60' R.O.W.), said point being North 00 deg. 42 min. 02 sec. West, a distance of 569.46 feet from a TxDot aluminum monument found in the said West line of Interstate Highway No. 35E, said point also being the beginning of a curve to the right, having a central angle of 18 deg. 00 min. 00 sec., a radius of 1,425.00 feet, and a chord bearing of North 81 deg. 38 min. 18 sec. West, a ½" capped iron rod

THENCE: Northwesterly, with the said North line of The Meadows Parkway, same being with said curve to the right, an arc distance of 447.68 feet to the end of said curve, a point for corner from which a ½" iron rod found bears North 65 deg. 19 min. West, a distance of 0.3 feet; THENCE: North 72 deg. 38 min. 18 sec. West, continuing with the said North line of The Meadows Parkway, a distance of 62.99 feet to the Southeast corner of Lot 23, Block 2, of North Meadows Addition, Revised, an addition to the City of Desoto, Dallas County, Texas, according to the Map thereof recorded in Volume 77100, Page 977, Map Records, Dallas County, Texas, a ½" capped iron rod set for corner; THENCE: North 16 deg. 50 min. 36 sec. East, with an East line of said North Meadows Addition, Revised, a distance of 29.45 feet to an angle point, a point for corner; THENCE: North 73 deg. 09 min. 12 sec. East, continuing with an East line of said North Meadows Addition, Revised, a distance of 79.74 feet to an angle point, a point for corner;

THENCE: North 41 deg. 12 min. 12 sec. East, continuing with an East line of said North Meadows Addition,

Revised, a distance of 98.29 feet to an angle point, a point for corner; THENCE: North 49 deg. 08 min. 48 sec. West, continuing with an East line of said North Meadows Addition, Revised, a distance of 227.56 feet to an angle point, a point for corner; THENCE: North 03 deg. 23 min. 12 sec. East, continuing with an East line of said North Meadows Addition, Revised, a distance of 60.22 feet to an angle point, a point for corner;






