Investment Overview

This offering presents an opportunity to acquire a single tenant medical office property leased to Orlando Health, one of the Southeast's most prominent and financially secure not for profit healthcare systems. The property, located at 801 20th Avenue East in Jasper, Alabama, has operated as a family practice for more than 30 years and was recently acquired by Orlando Health as part of their regional expansion strategy.

The lease has three years remaining on the base term, which provides investors with a higher yield today and significant upside at renewal. Given the long operating history at the site, the brand-new roof replacement in 2025, and the property's strategic location in Jasper's retail and medical hub, renewal probability is considered very strong. Surrounding demand drivers include Walmart, Walker County Health Department, Baptist Health Walker Hospital, Harbor Chase of Jasper, and Lakewood Assisted Living of Jasper, all of which generate consistent patient traffic and reinforce the importance of this facility within the community.

Patients benefit from easy accessibility and abundant surface level parking, creating a more convenient experience than larger hospital campuses with structured parking. With minimal landlord obligations limited to roof and structure, and with the roof fully replaced in 2025, investors enjoy a secure income stream with limited capital exposure. Backed by Orlando Health's \$7.2 billion in annual revenue and AA Fitch credit rating, this property combines institutional credit, essential healthcare demand, and an irreplaceable location, making it a compelling investment with both near-term yield and long-term value creation potential.

Jasper, Alabama

Jasper is the county seat of Walker County and a key city in north-central Alabama. Located approximately 40 miles northwest of Birmingham, Jasper offers a strategic location that serves as a commercial and healthcare hub for the 65,000 residents of Walker County. With a population of over 14,000 residents and a broader service area drawing from the entire county, Jasper continues to benefit from steady demand for professional services, retail, and healthcare.

Jasper's economy is anchored by a strong healthcare presence, led by Walker Baptist Medical Center, a 267-bed acute care hospital that serves as a major employer and regional healthcare provider. The city has seen growth in ancillary medical services, including outpatient clinics, specialist practices, and urgent care centers. As a result, medical office real estate has become a vital and stable asset class in the local market, with increasing demand from private practices and institutional providers alike.


Jasper is easily accessible via U.S. Highway 78 and Interstate 22, providing a direct route to Birmingham and connections to regional transportation corridors.

Jasper offers a strong quality of life with a close-knit community feel. In addition to healthcare services, residents benefit from excellent public safety and city services. Jasper's role as the economic and healthcare center for Walker County further elevates its importance as a service destination.

Driven by the presence of Walker Baptist and an aging regional population, the demand for medical office space in Jasper has remained consistent. New developments and build-to-suit opportunities have emerged around the hospital and along Highway 78, attracting both local practitioners and regional healthcare groups. Medical office users are drawn to the market for its lower operating costs, high patient volume, and strong referral networks tied to the hospital.

Jasper's future growth is closely tied to healthcare and professional services. With a stable employment base, affordable real estate, and a growing need for medical services, the city is well-positioned for continued medical office expansion. Planned infrastructure improvements and pro-business city leadership further support Jasper's outlook as a reliable market for long-term healthcare investment.
