**Recreation:** Garden Grove offers a wide range of parks and recreational amenities, including Garden Grove Park and Atlantis Play Center, known for its unique playgrounds and open green spaces. The city also features the Garden Grove Sports & Recreation Center which provides activities such as basketball, volleyball, and badminton for all ages.
