


FINAL PLAT FRANKHOMA INDUSTRIAL PARK

LEGAL DESCRIPTION FOR COMBINED LAND

A TRACT OF LAND IN THE NORTHWEST OLIARTER (NW/A) OF SECTION TWENTY-FIVE (25) AND THE NORTHEAST OLIARTER

COMMENCING AT THE NORTHEAST CORNER OF SAID NORTHEAST QUARTER (NE/4):

THENCE'S 01"15'00" E ALONG THE EAST LINE OF SAID NORTHEAST QUARTER (NE/4), A DISTANCE OF 30,00 FEET, THENCE'S 88"0"700" WA DISTANCE OF 25.40 FEET TO THE POINT OF BEGINNING, SAID POINT BEING ON THE WEST RIGHT OF WAY LINE OF THE ST. LOURS AND SAN FRANKISCO RAILROAD.

THENCE S 11°26'00" E CONTINUING ALONG THE WEST RIGHT OF WAY LINE OF THE ST. LOUIS AND SAN FRANCISCO RAILROAD, A DISTANCE OF 688.50 FEET;

THENCE N 82°15'00" W A DISTANCE OF 97.53 FEET;

THENCE ON A CURVE TO THE RIGHT WITH AN ARC LENGTH OF 515.22 FEET, A RADIUS OF 3,619.80 FEET, A CHORD BEARING OF \$ 57"51"48" W, AND A CHORD LENGTH OF 514.79 FEET; THENCE \$ 88"07"00" W A DISTANCE OF 208.27 FEET;

THENCE N 01"53"00" W A DISTANCE OF 292.00 FEET TO A POINT ON THE CENTERLINE OF VACATED JOSEPHINE AVE. BEING A PART OF THE RECORDED PLAT OF SAPULPA VIEW;

THENCE S 88'07'00" W ALONG THE SOUTH LINE OF SAID JOSEPHINE AVE., A DISTANCE OF 330.00 FEET TO THE CENTERLINE OF VACATED LAKE ST. BEING A PART OF SAID RECORDED PLAT;

THENCE N 01°53'00" W ALONG THE CENTERLINE OF SAID LAKE ST. TO THE NORTH LINE OF LOTS SEVENTEEN (17) AND THIRTY-TWO (32), BLOCK ONE (1) OF SAID RECORDED PLAT, EXTENDED, A DISTANCE OF 230.00 FEET;

THENCE N 88°07'00" E ALONG THE NORTH LINE OF SAID LOTS SEVENTEEN (17) AND THIRTY-TWO (32), A DISTANCE OF 300.00 FEET TO THE CENTERLINE OF VACATED GANO ST. BEING A PART OF SAID RECORDED PLAT;

THENCE N 01"53'00" W ALONG THE CENTERLINE OF SAID GANO ST., A DISTANCE OF 400.00 FEET:

THENCE N 88"07'00" E A DISTANCE OF 30.00 FEET:

THENCE N 01°53'00" W A DISTANCE OF 30.00 FEET TO A POINT ON THE NORTH LINE OF SAID NORTHEAST QUARTER (NE/4)

THENCE N 88°07'00" E ALONG THE NORTH LINE OF SAID NORTHEAST QUARTER (NE/4), A DISTANCE OF 629.82 FEET TO A POINT ON THE WEST RIGHT OF WAY LINE OF THE ST. LOUIS AND SAN FRANCISCO RAILROAD;

THENCE S 11°26'00" E ALONG THE WEST RIGHT OF WAY LINE OF THE ST. LOUIS AND SAN FRANCISCO RAILROAD, A DISTANCE OF 30.42 FEET TO THE POINT OF BEGINNING.
