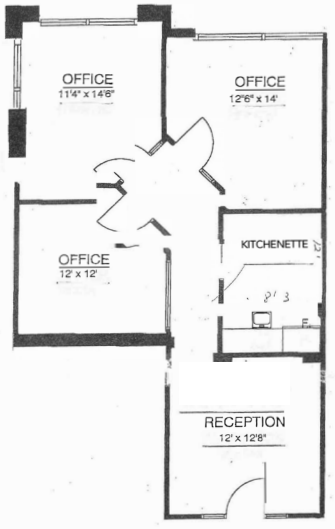

KITCHENETTE INCLUDES SINK, MICROWAVE, MINI-FRIDGE OR REFRIGERATOR

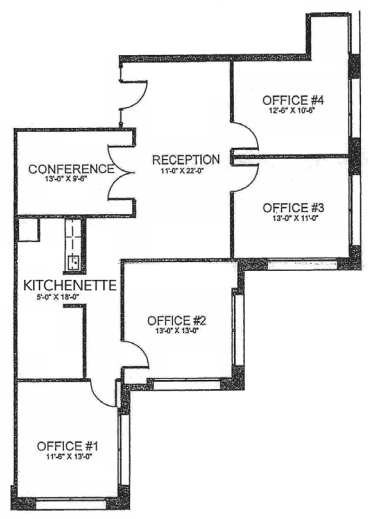

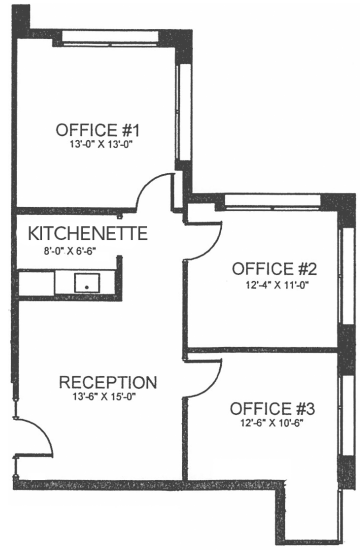

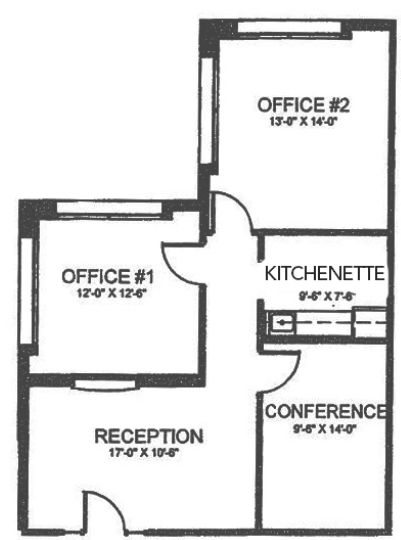
