## Building description includes:



- Steel superstructure set in concrete foundations. Interior, mostly sprayed w/insulation. Center monitor windows throughout which have been recalked and glass replaced as needed.
- 12' to 17' clear span ceiling height.
- Mostly 40' x 20' column spacing.
- Floors are reinforced concrete.
- Lighting is LED.
- Heating is by overhead tubular style in some areas & gas fired overhead radiant units over specific areas.
- 5 interior tractor trailer docks
- 4 interior sunken docks for flatbed & Conestoga type trailers w/tarp.
- 9 overhead bridge cranes ranging in size from 3 ton to 10 ton. Combination of pendant & remote controlled operated. Maintained by Industrial Crane & Hoist of Akron.

## Utilities and Other Amenities.

Electrical: 480 Volt substation rebuilt by owner in 2014, 500 KVA w/1200 amp. Then a 240 Volt substation with 1000 KVA.

Utilities: Sewer, water & gas all public.

Office: Approx. 4,500 SF w/individual office space, open work areas, conference room, rest rooms and lunch/coffee area. Mostly 9"x 14" acoustical ceiling tile.

Office HVAC: Two gas operated boilers providing combination of some static and mostly forced air. There are two outside condenser units for a/c.

Sprinkler System: Dry system that provides fire protection for the majority of the building.

Environmental: Arcadis, VAP (air program) providing compliance with a mechanical rotation system to reduce potential trichloroethylene (TCE) contamination. The vendor providing the system maintenance and compliance is Arcadis of Akron. The expense is covered by a third-party company, National Gypsum.

Transite: There is a requirement to paint the exterior of the building every 10 years for environmental compliance of Transite. The last painting was reported in 2023.
