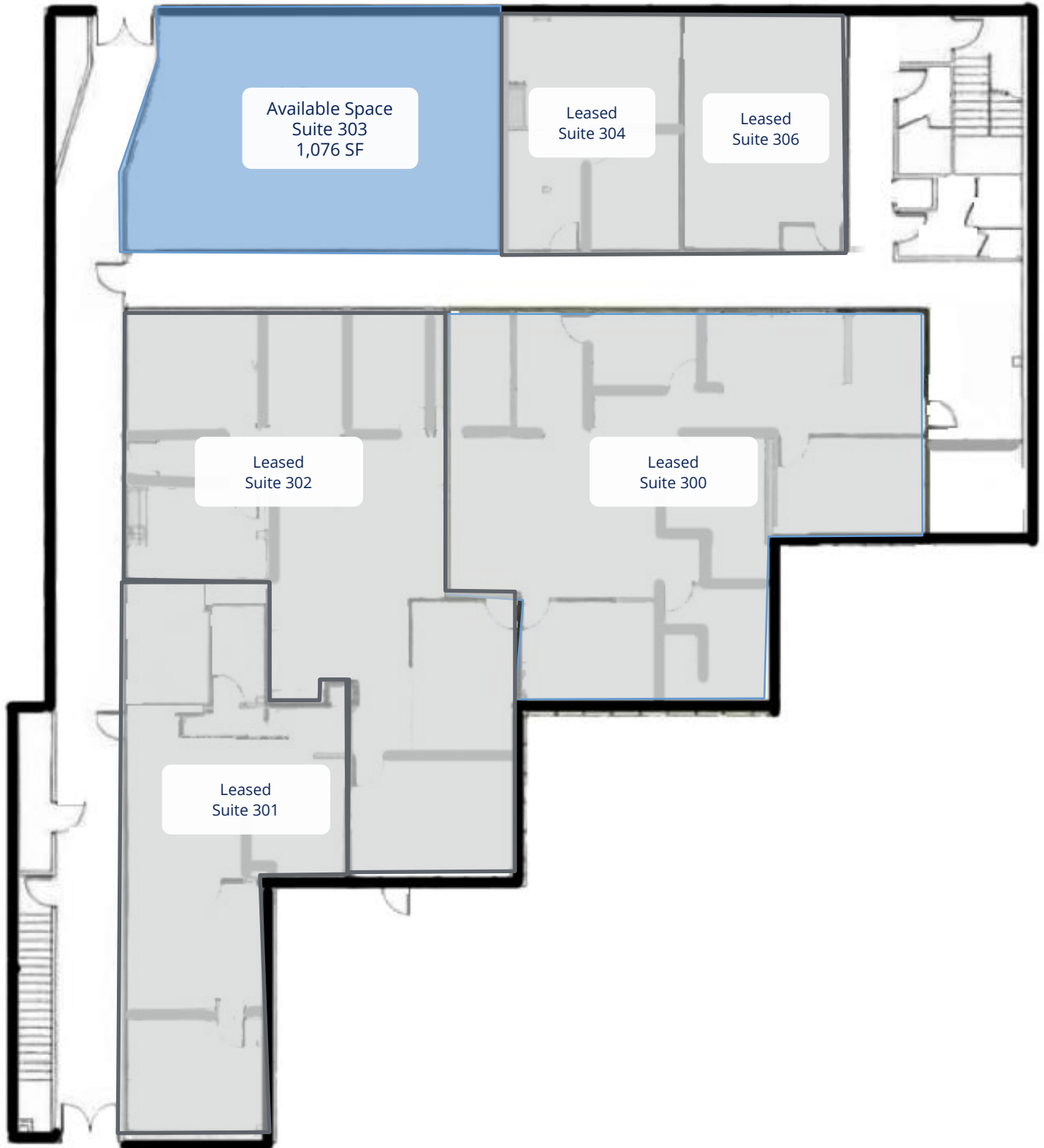

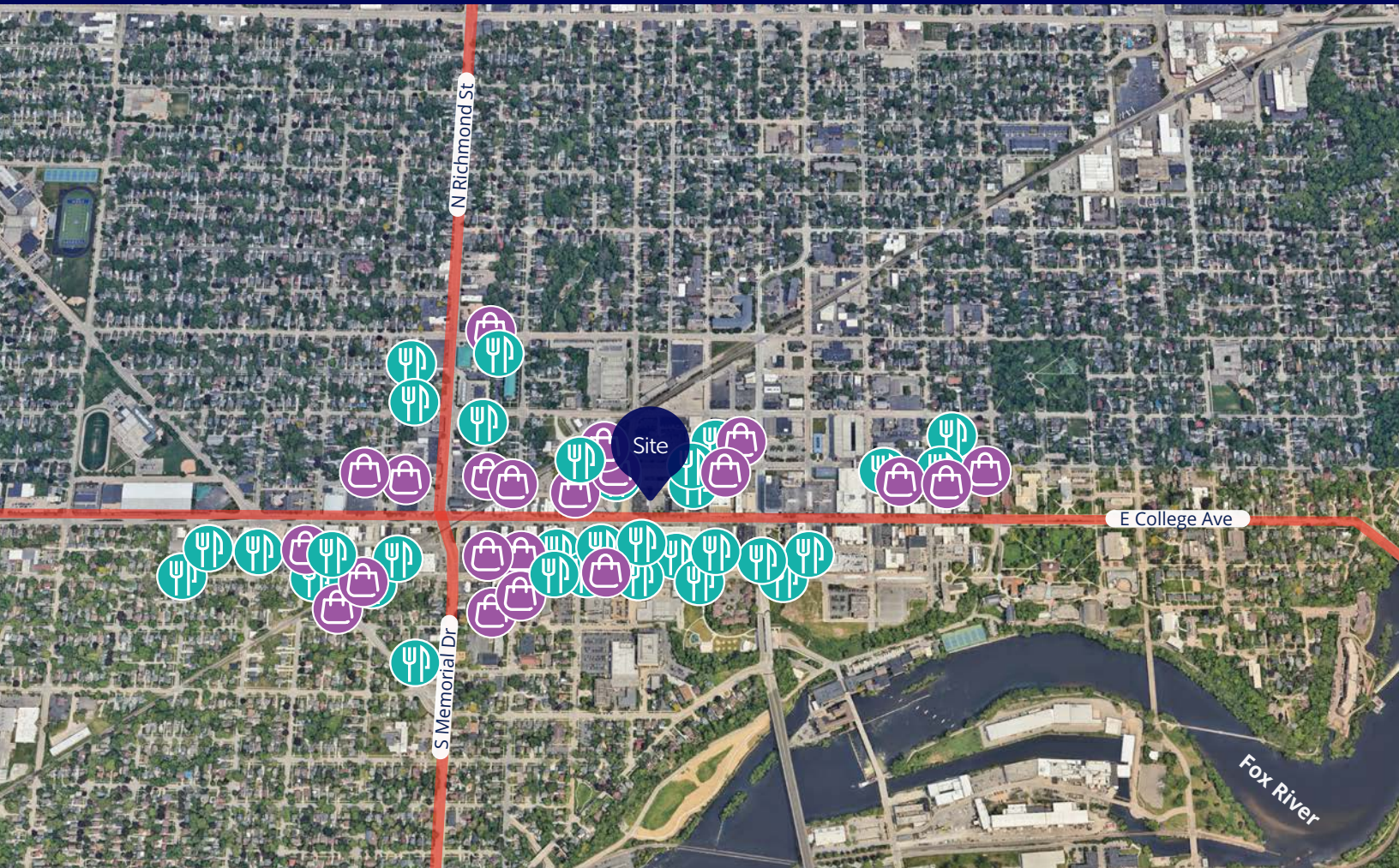

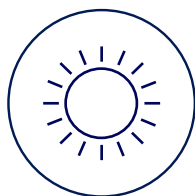

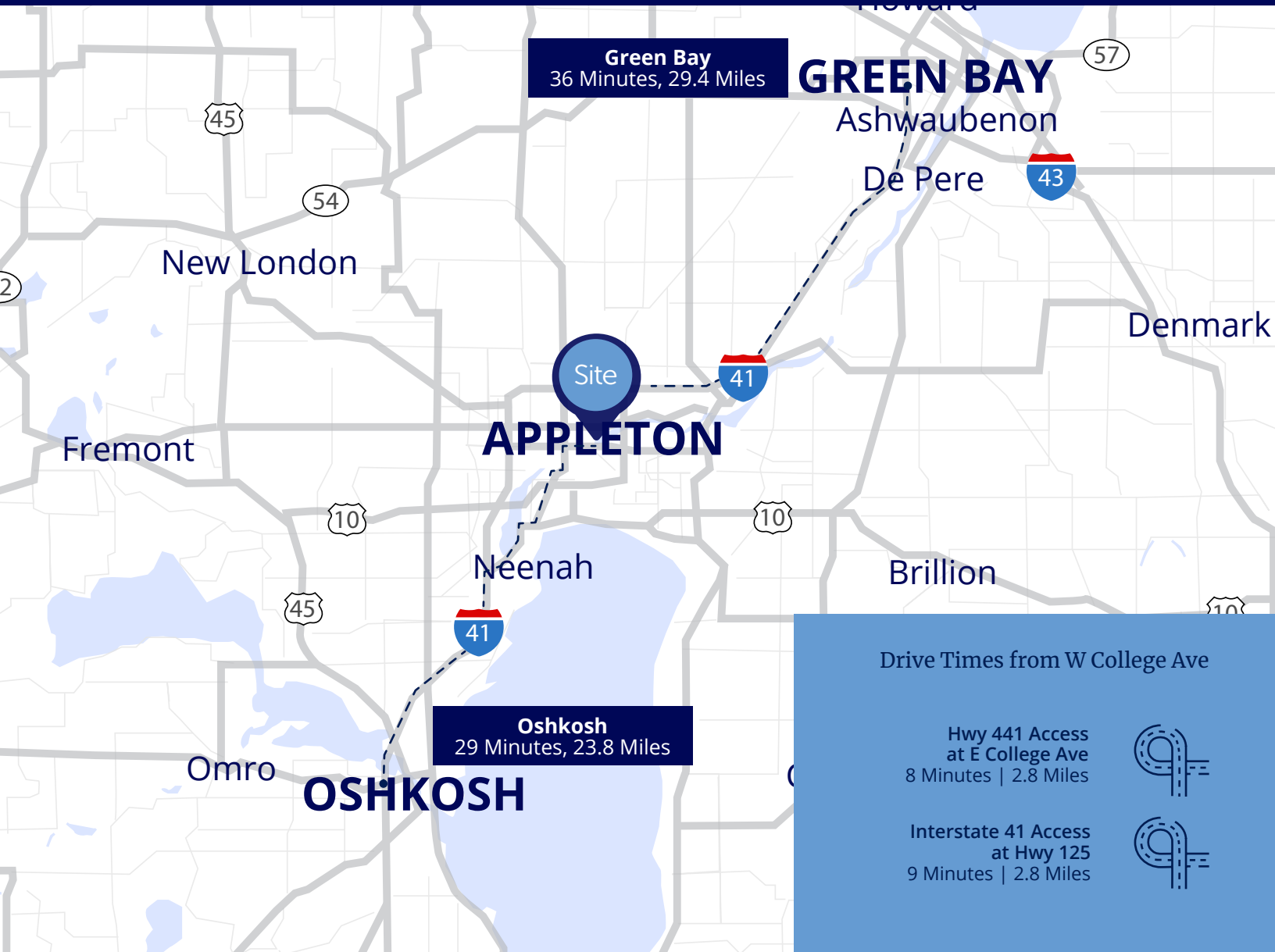

State Of Wisconsin | Disclosure to Non-Residential Customers

Prior to negotiating on your behalf the Brokerage firm, or an agent associated with the firm, must provide you the following disclosure statement:

Broker Disclosure to Customers

The Firm is either an agent of another party in the transaction or a subagent of another firm that is the agent of another party in the transaction.
