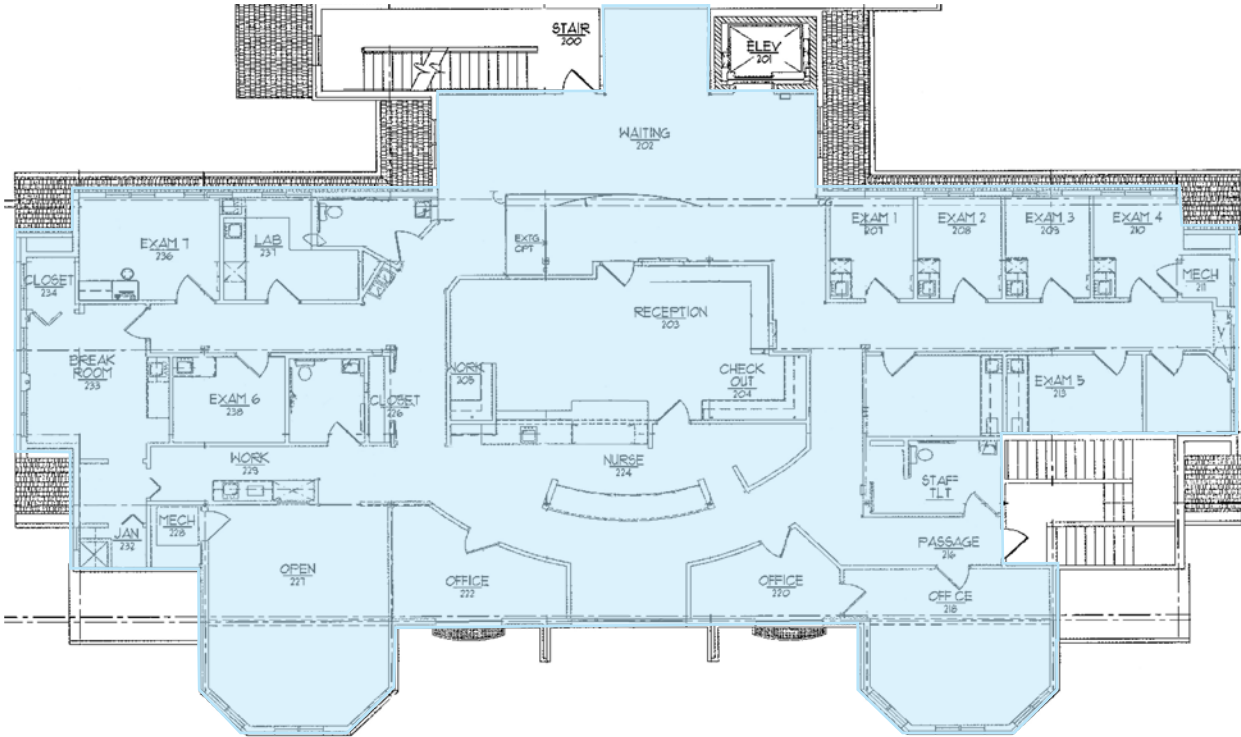

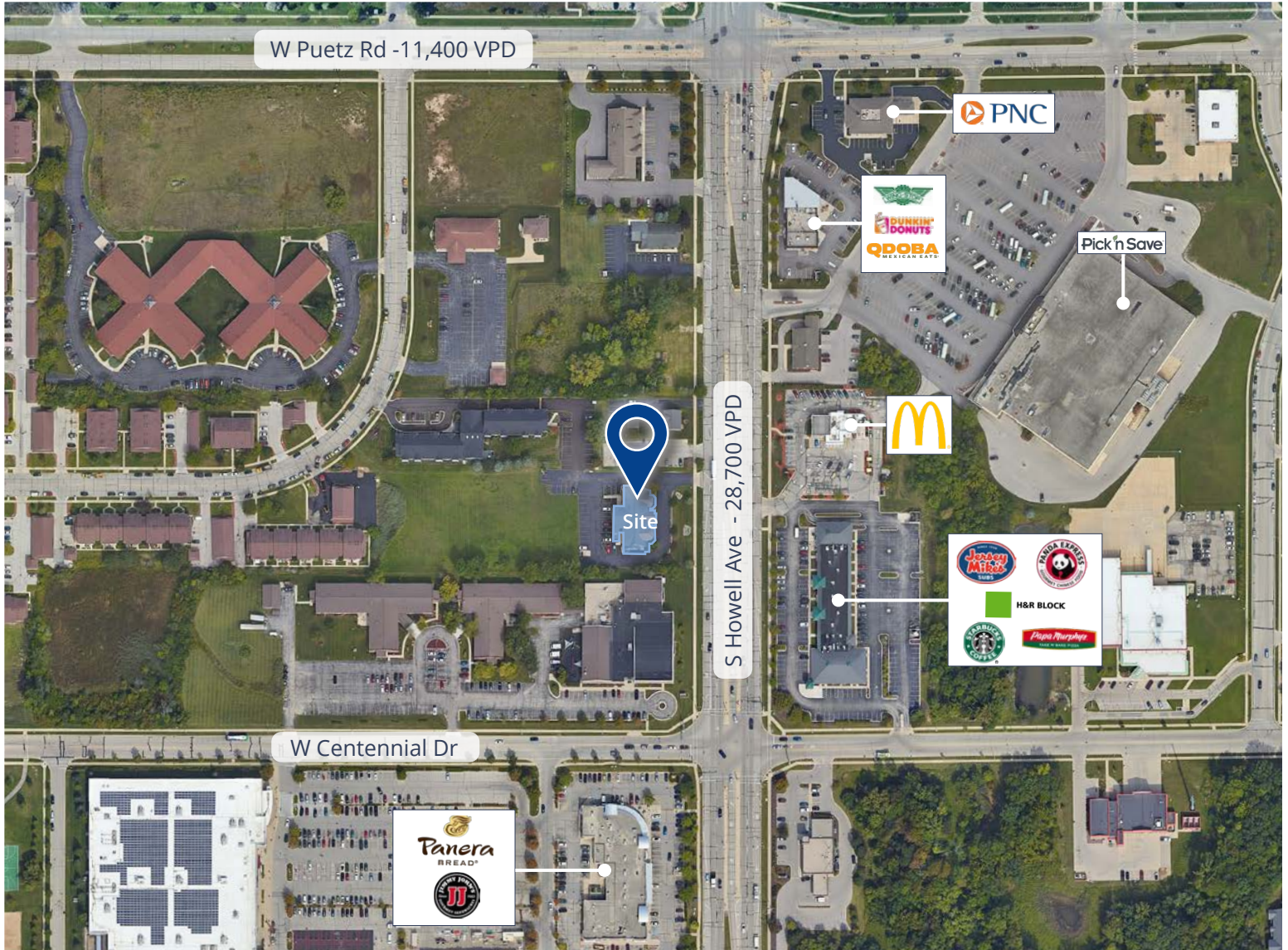

Location & Demographics

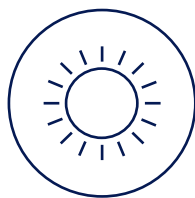


Demographics - 1, 3, 5 Miles

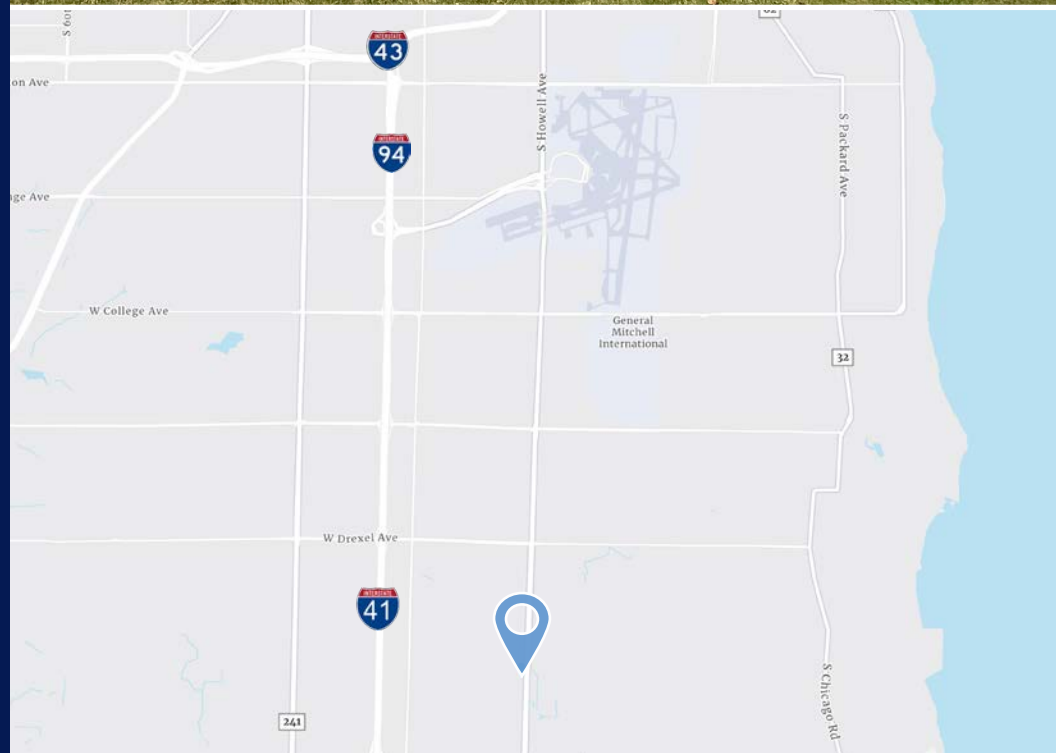

State Of Wisconsin | Disclosure to Non-Residential Customers

Prior to negotiating on your behalf the Brokerage firm, or an agent associated with the firm, must provide you the following disclosure statement:

Broker Disclosure to Customers

You are a customer of the brokerage firm (hereinafter Firm). The Firm is either an agent of another party in the transaction or a subagent of another firm that is the agent of another party in the transaction. Definition of Material Adverse Facts

A "Material Adverse Fact" is defined in Wis.
