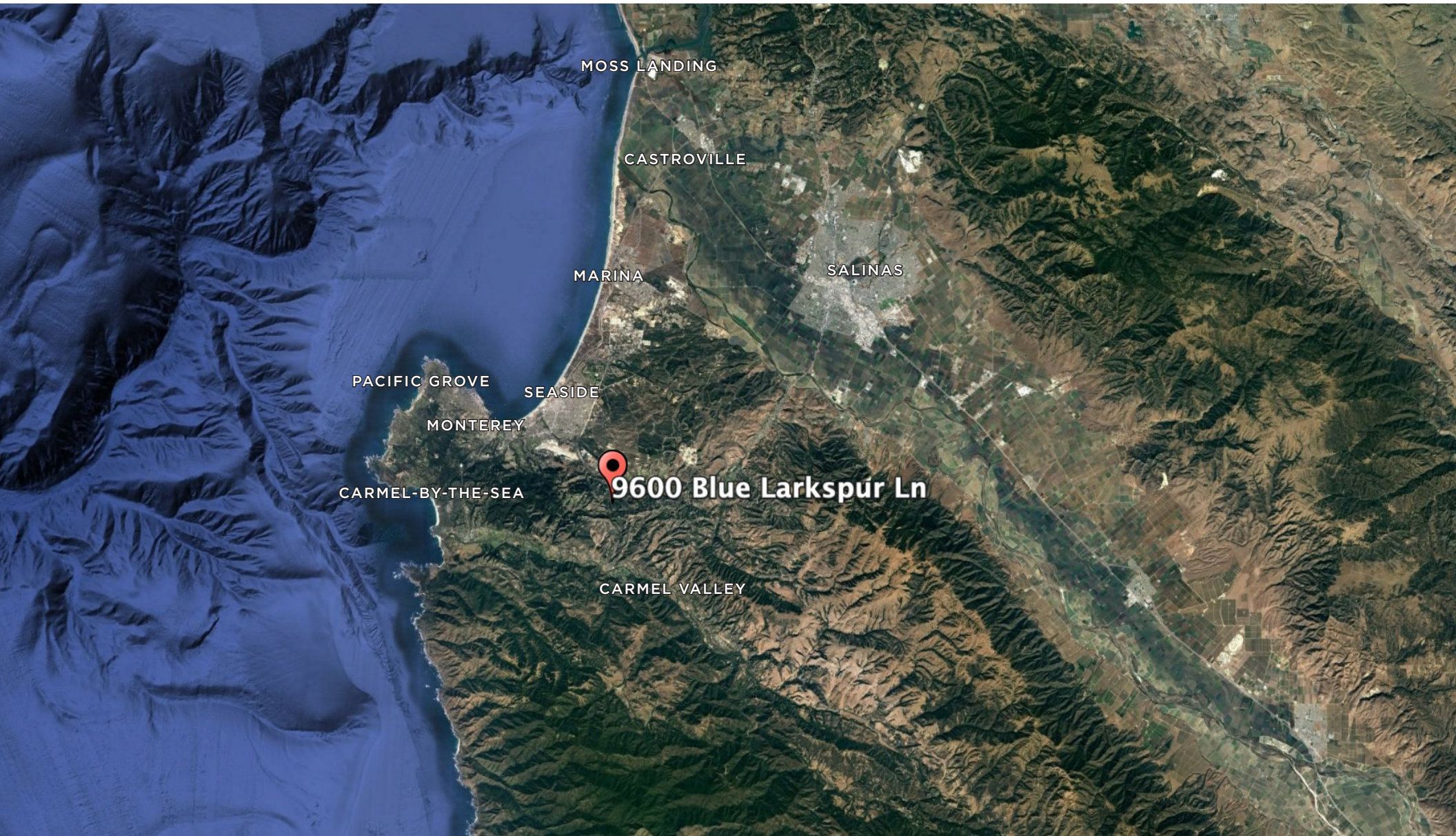




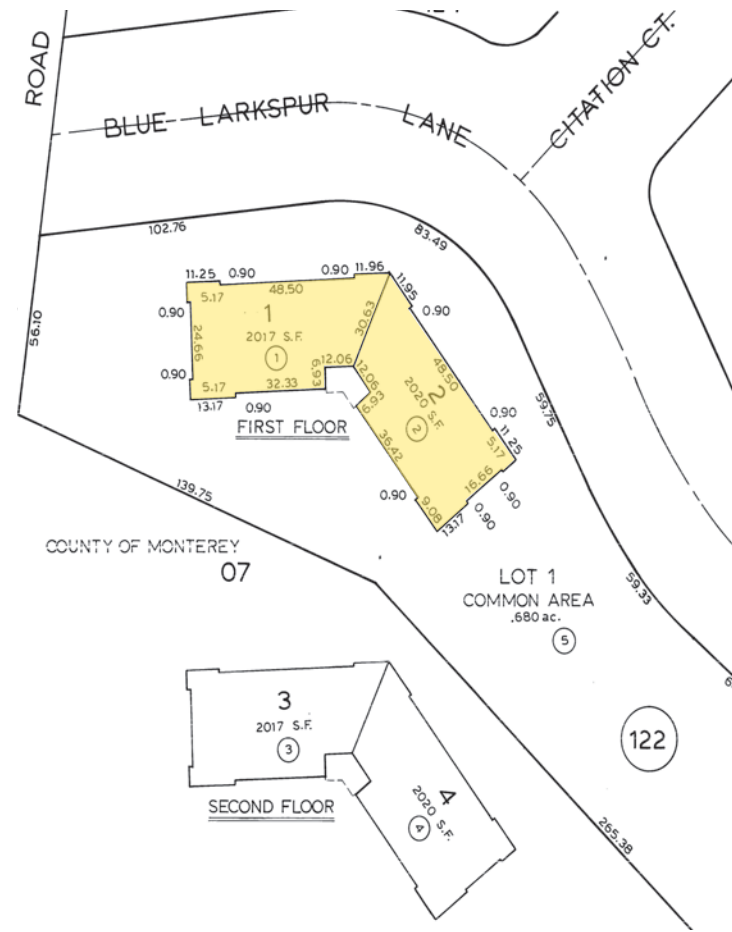
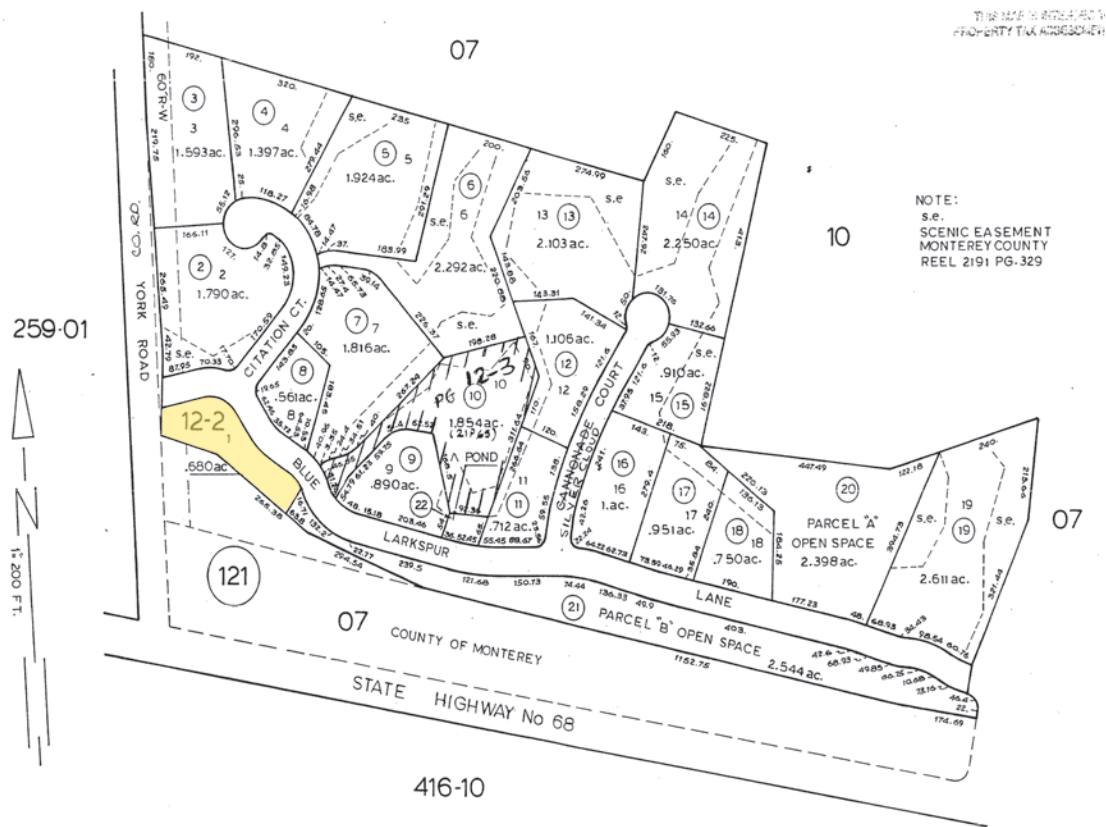
AERIAL MAP
