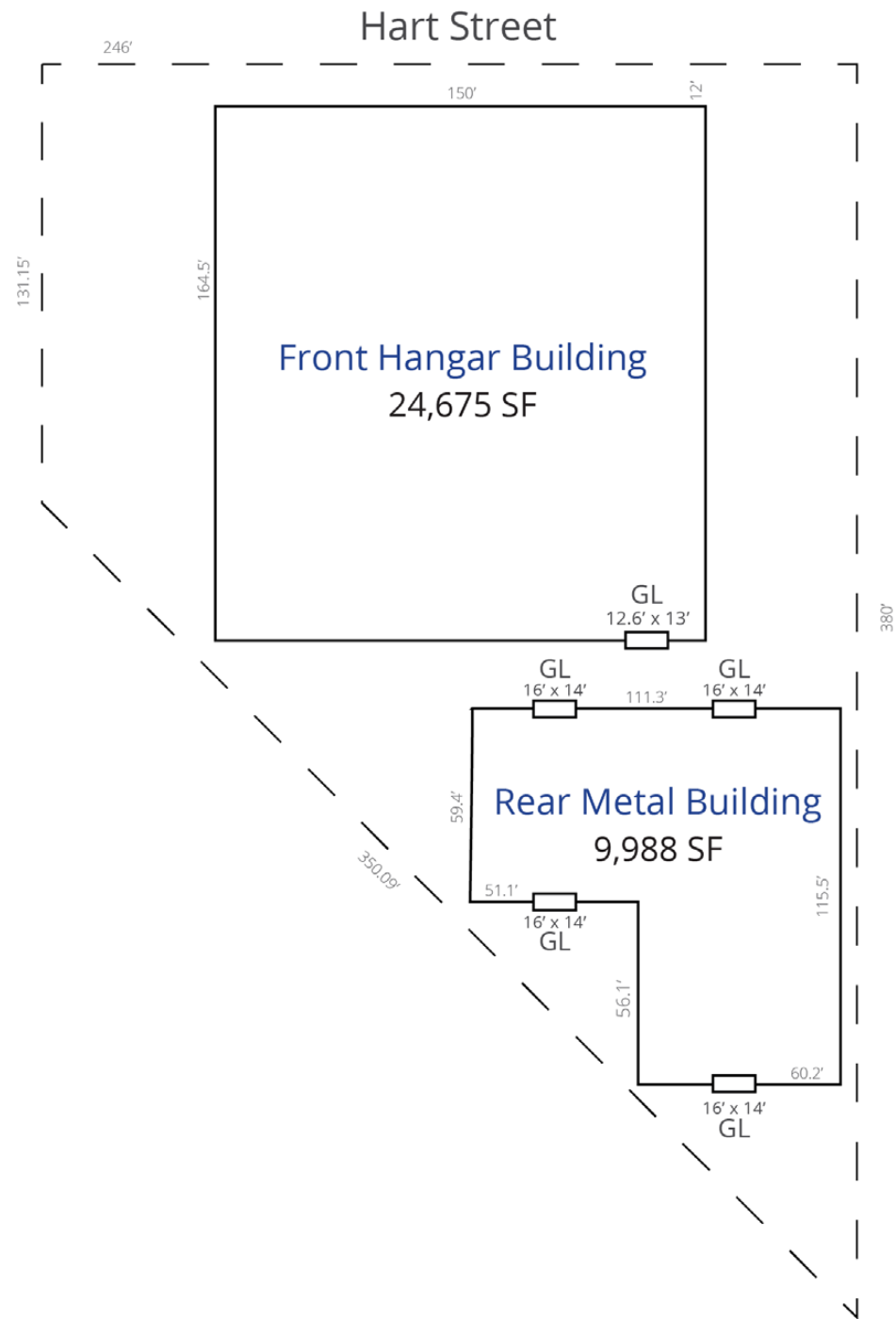

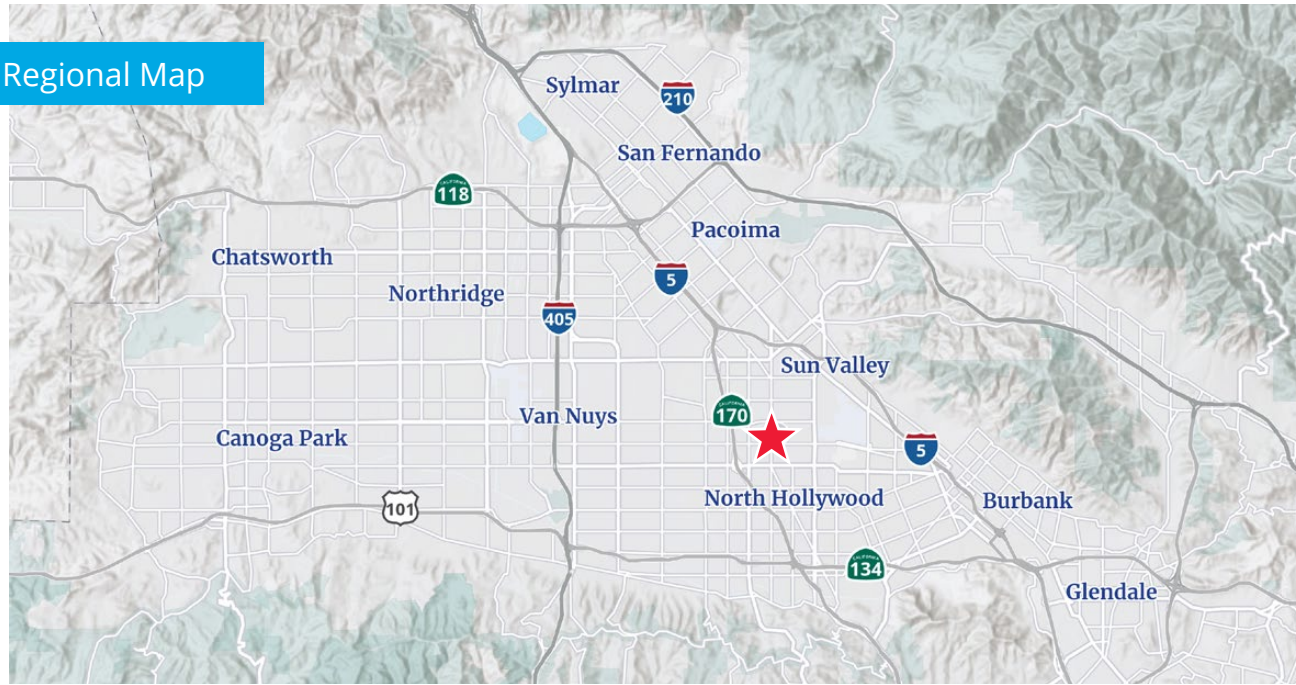


# Site Plan

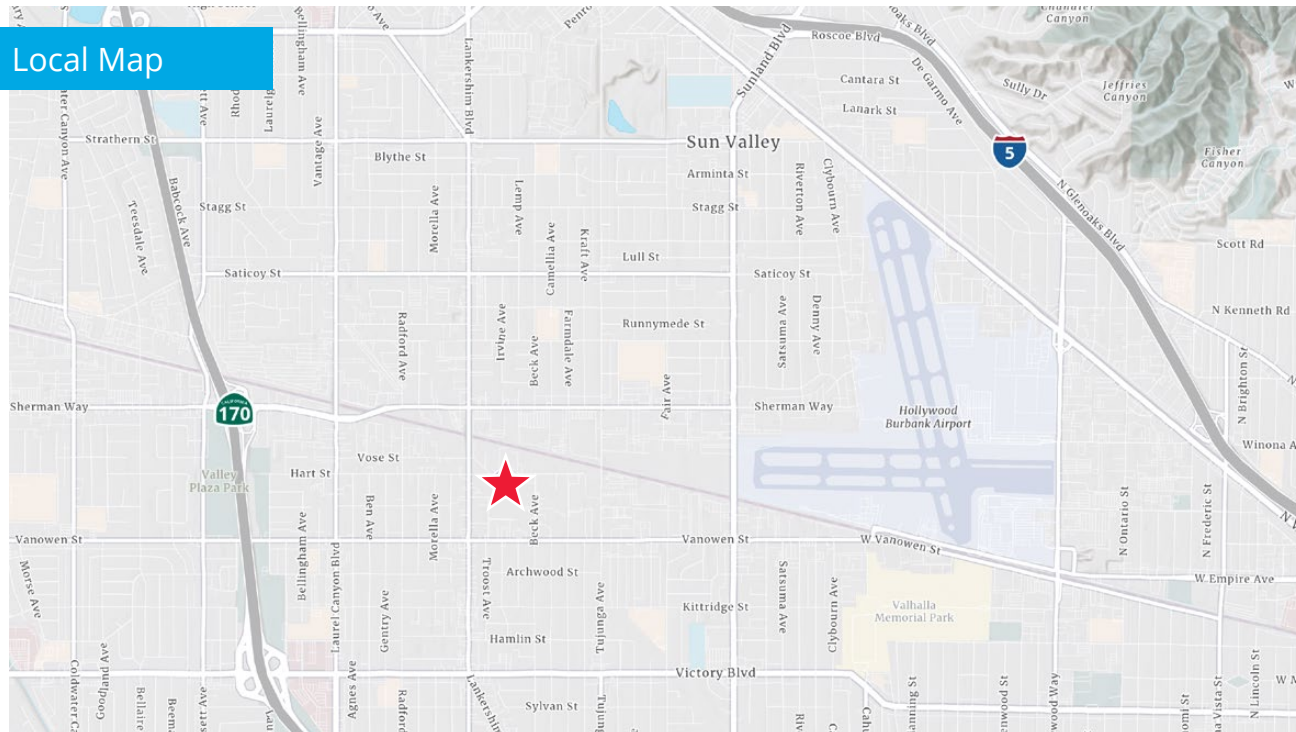


# Location Maps
