The property features approximately 400 feet of frontage on NW 6th Street and 300 feet on NW 23rd Avenue, with U6 Urban Mixed Use zoning that supports a wide range of development options including retail, office, medical, or multi-family.

This strategic corner location is surrounded by established commercial users and dense residential neighborhoods, with traffic counts exceeding 31,000 VPD on 6th Street and 18,600 VPD on 23rd Avenue. All utilities are available.

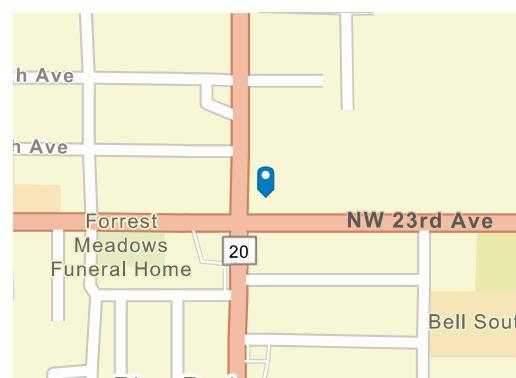
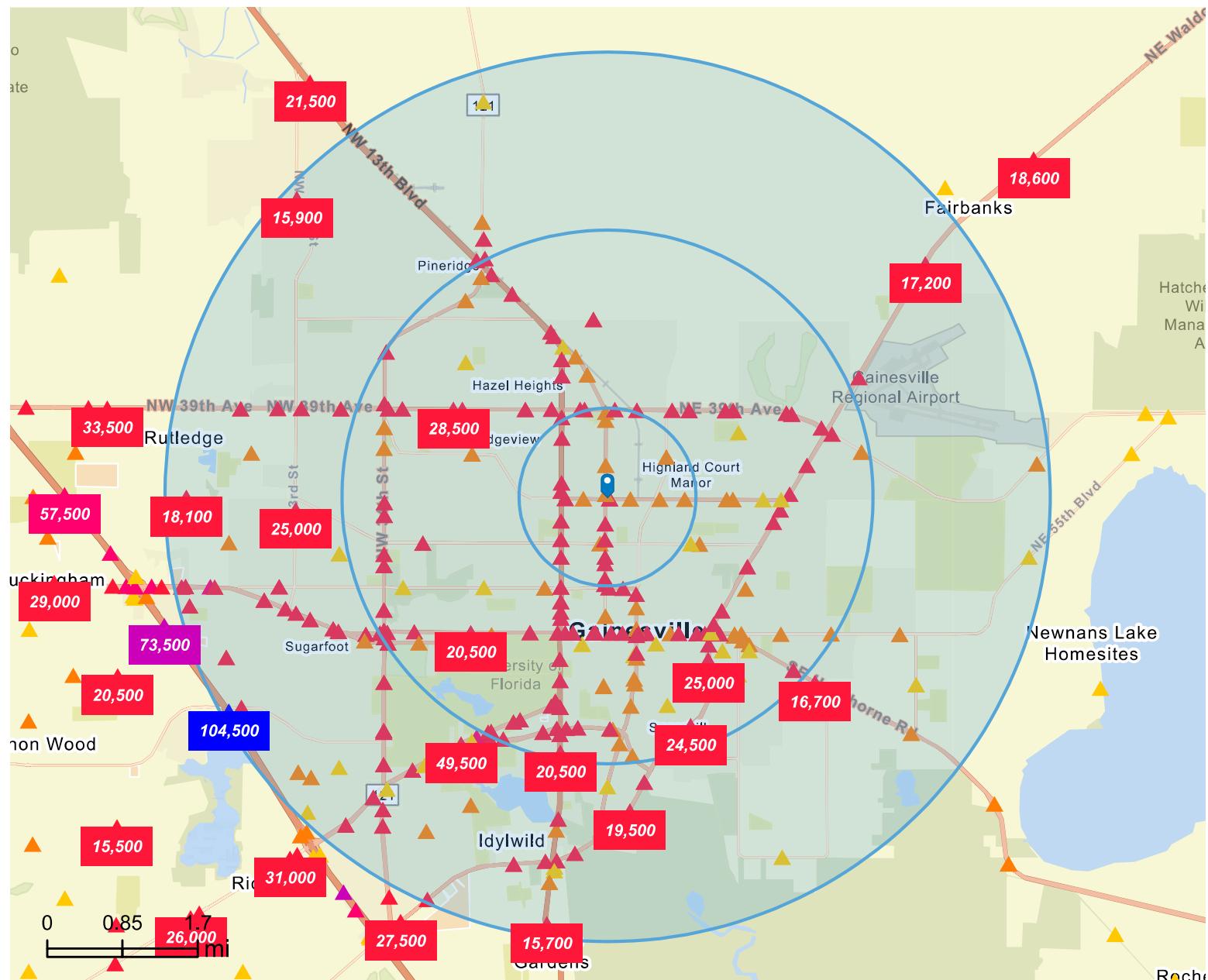
# Traffic Count Map
