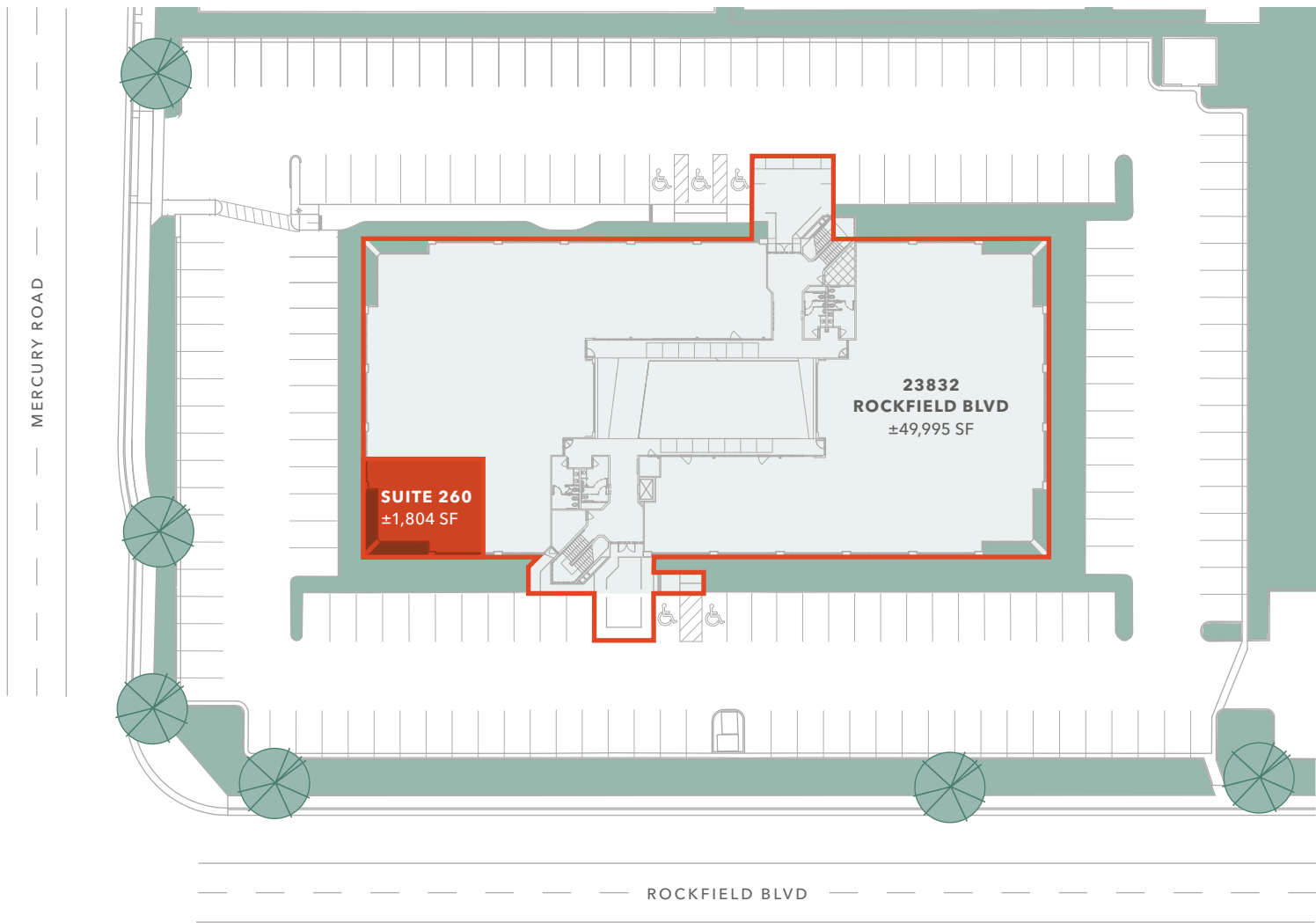

SITE PLAN

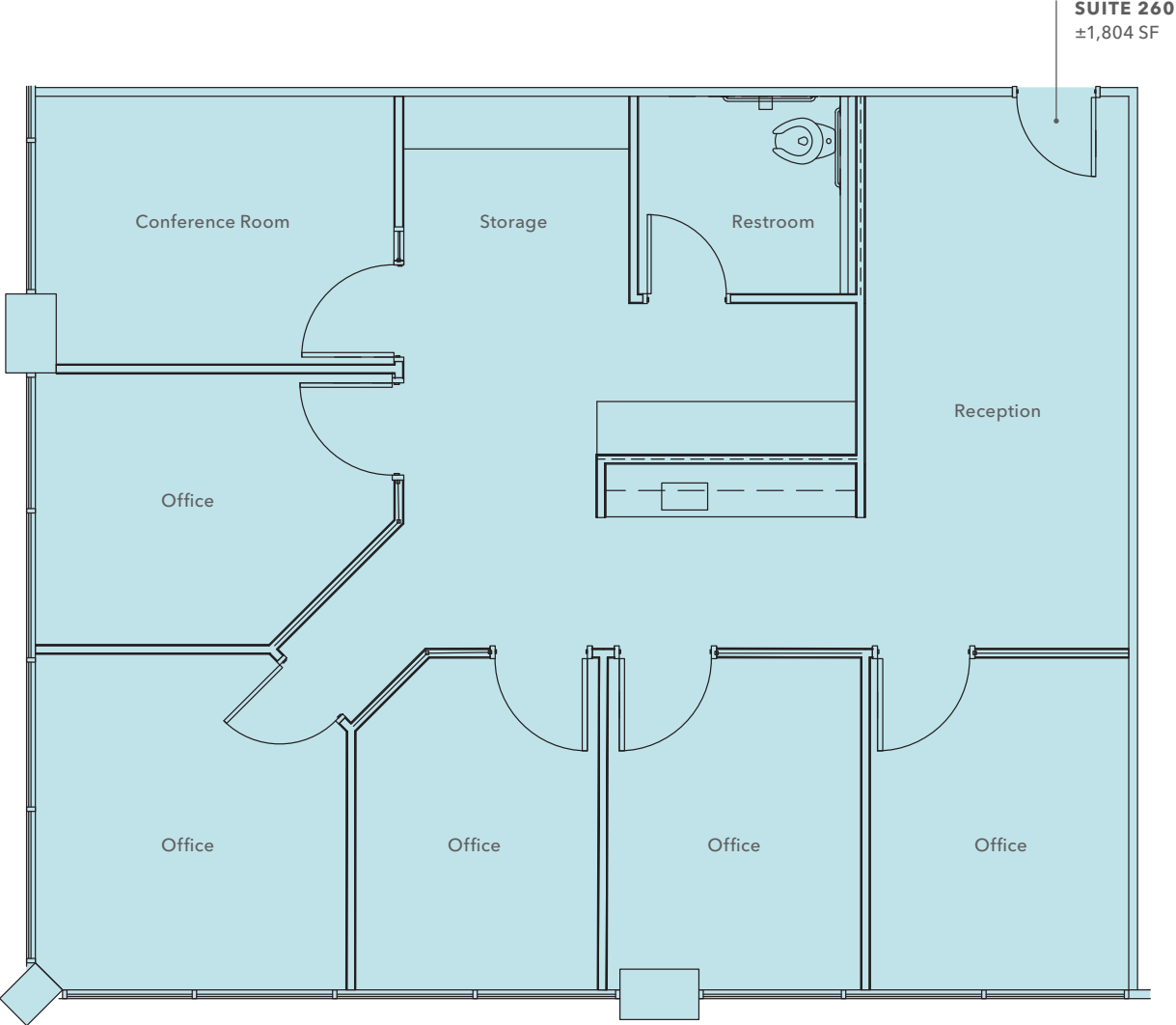
