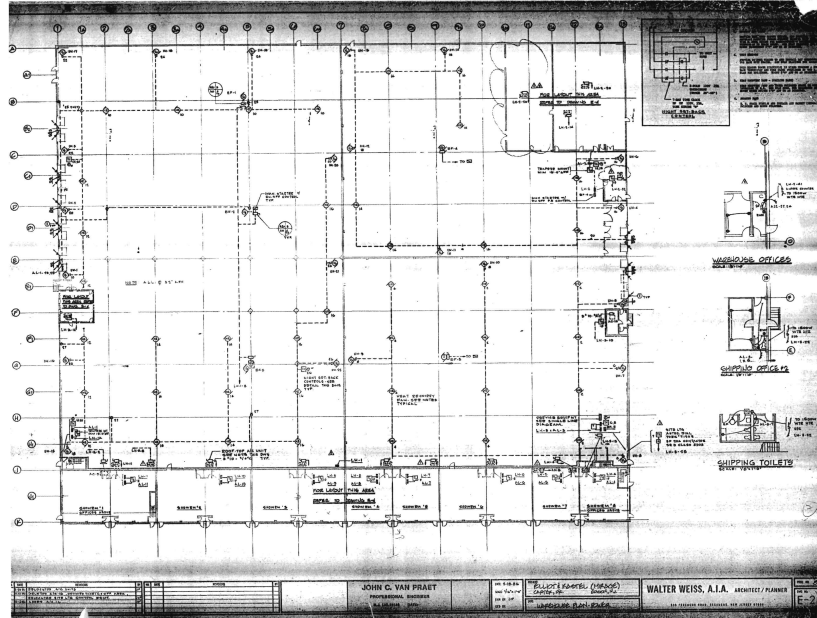
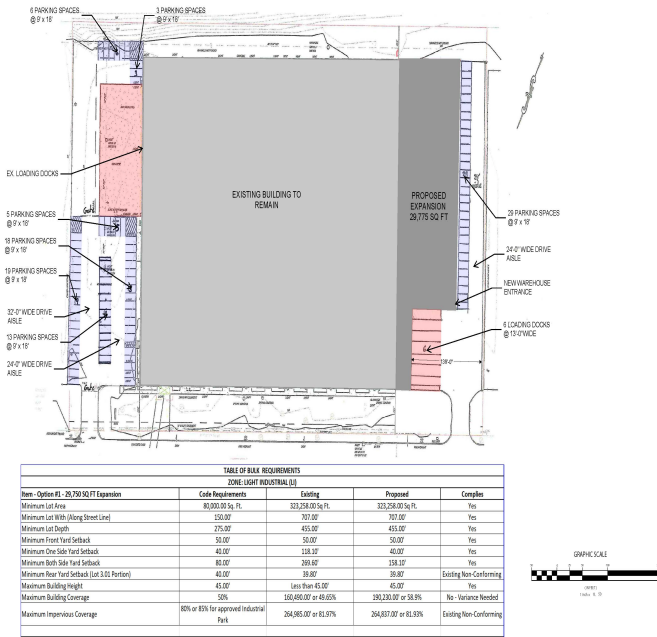

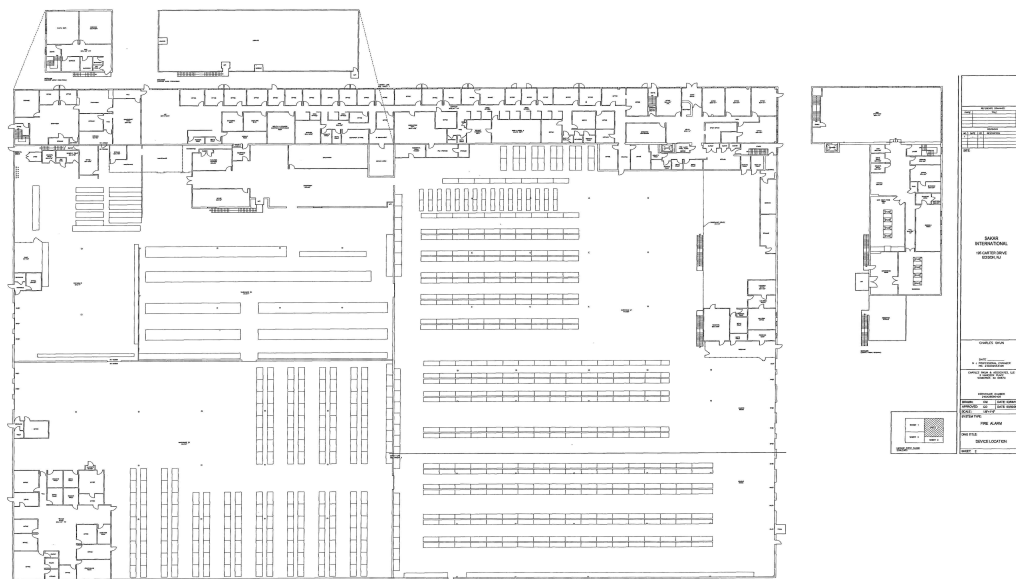

Site Plan



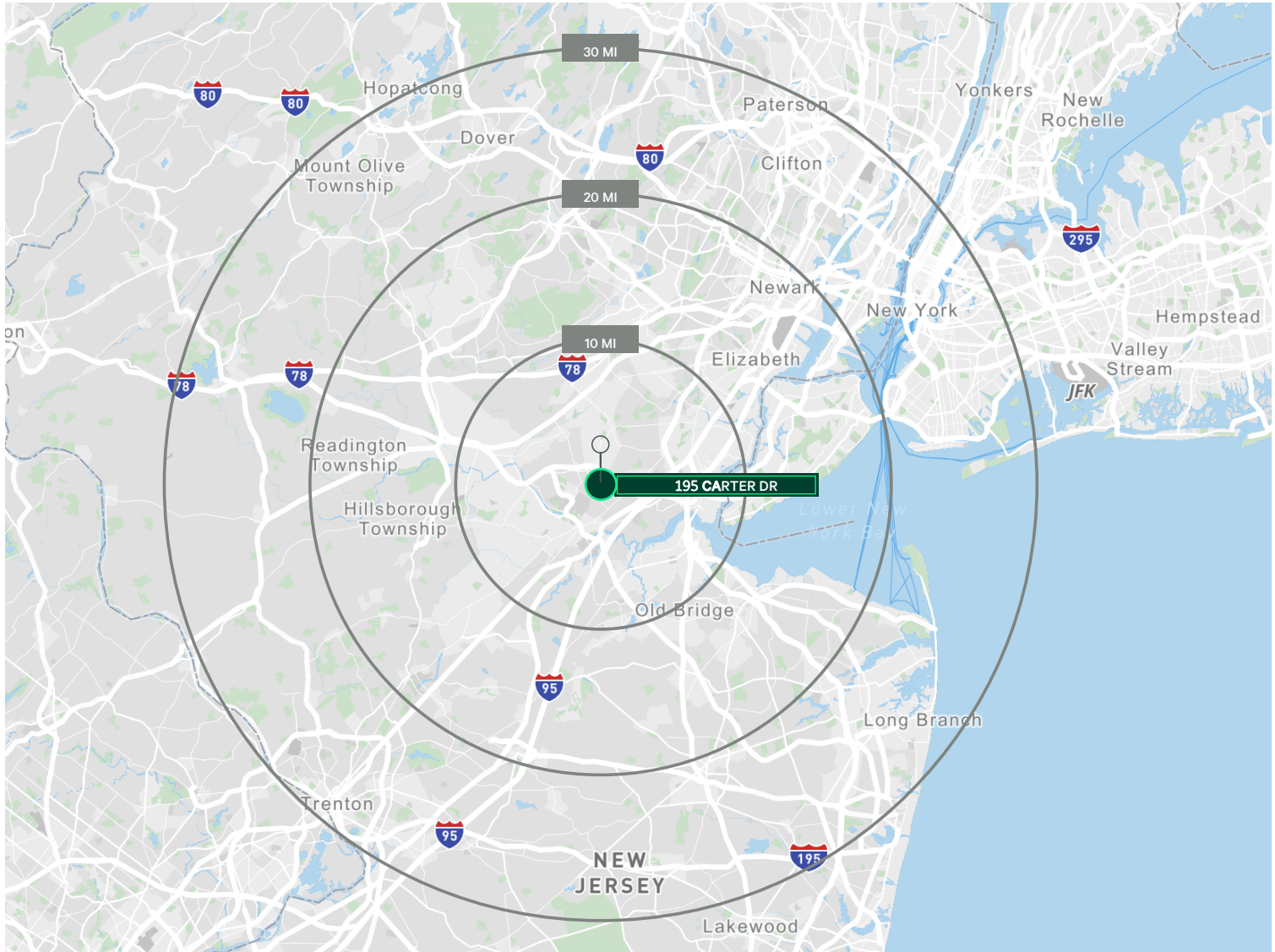
Racking Plan
