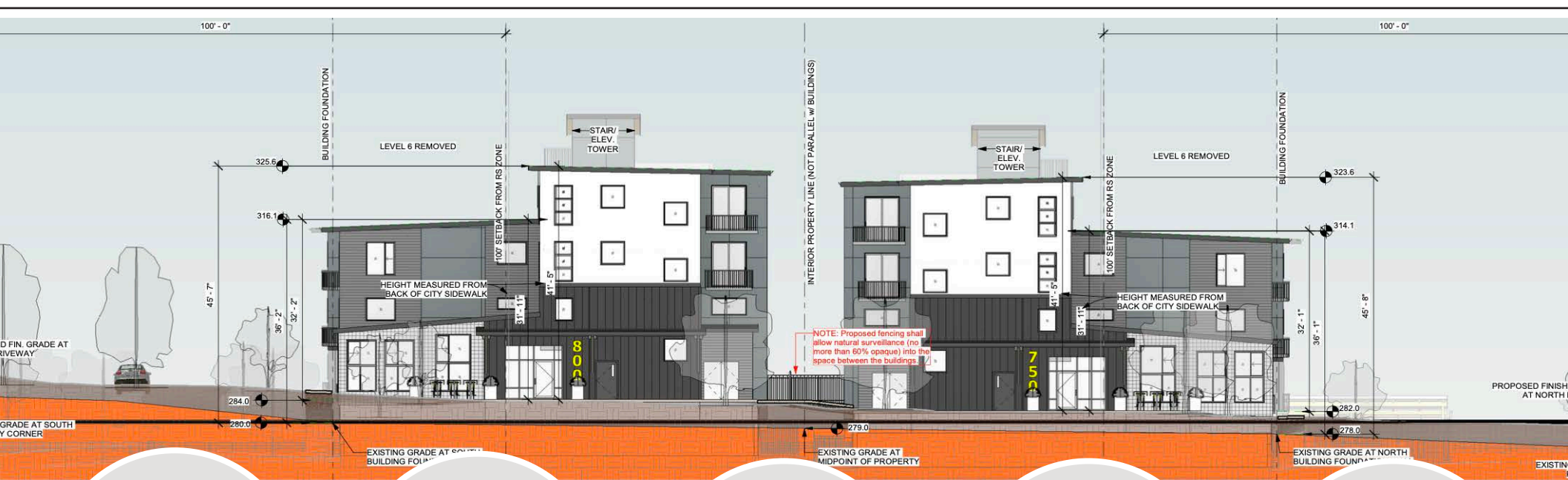

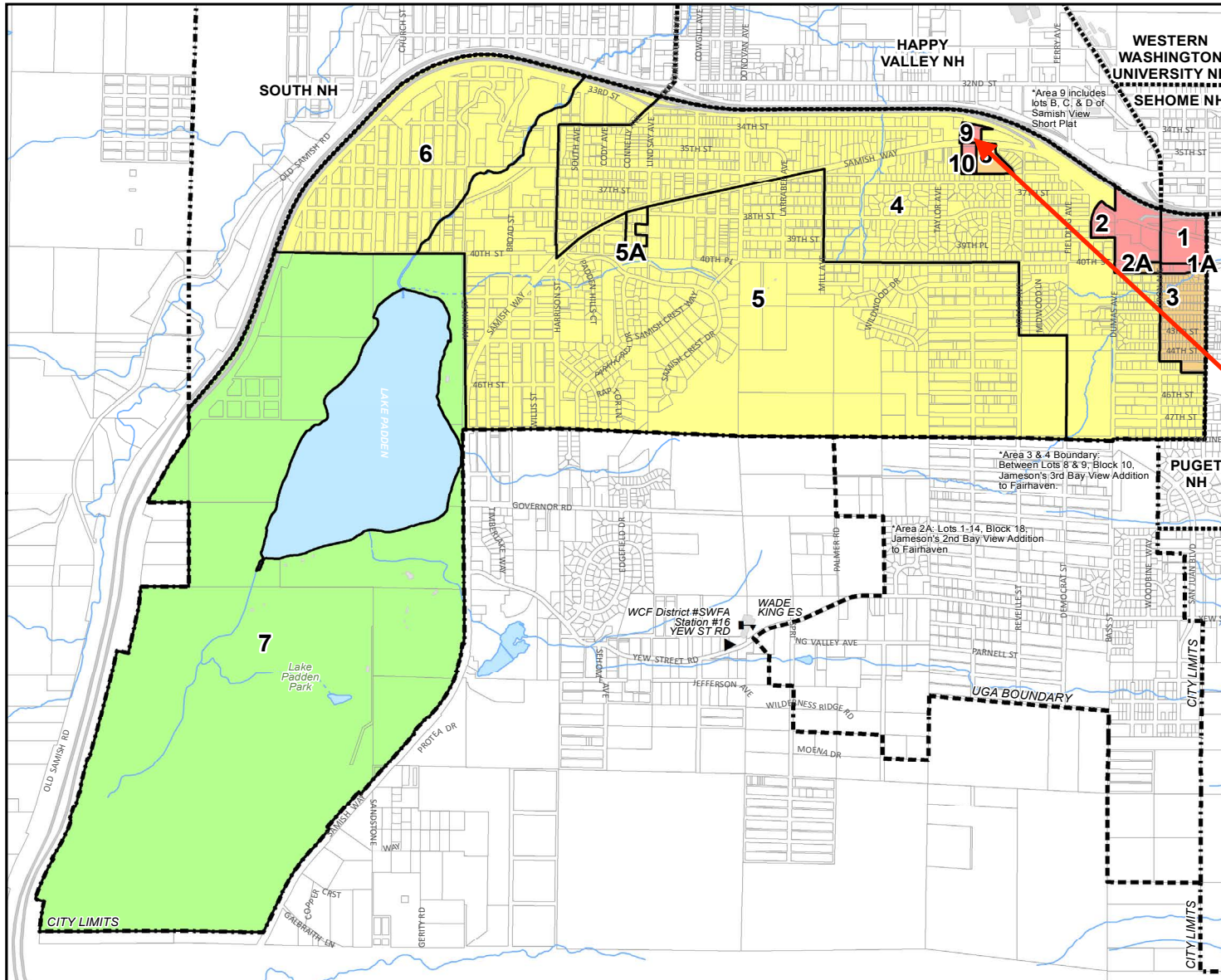

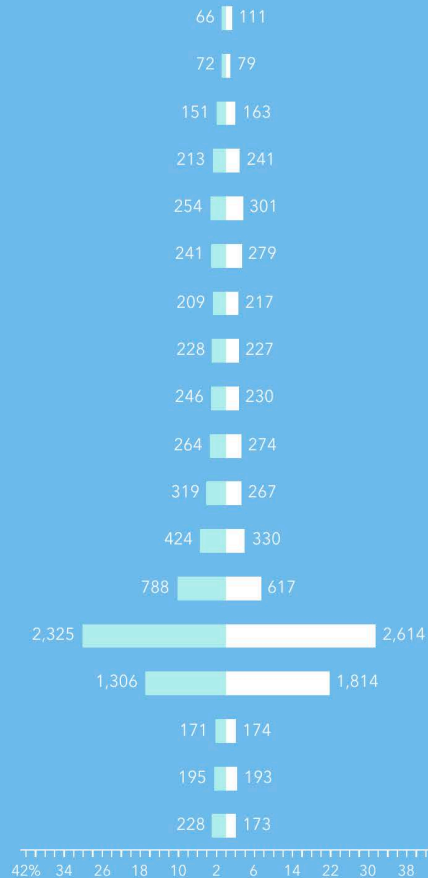

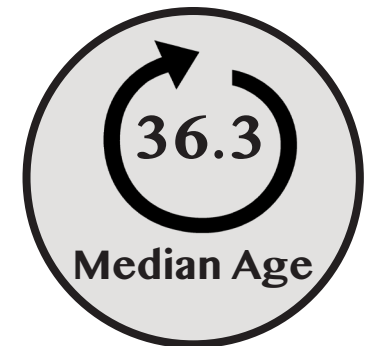
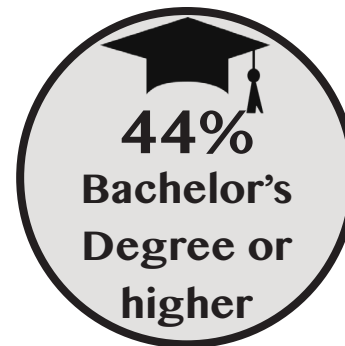
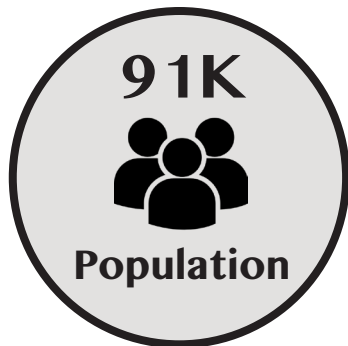
Demographics
