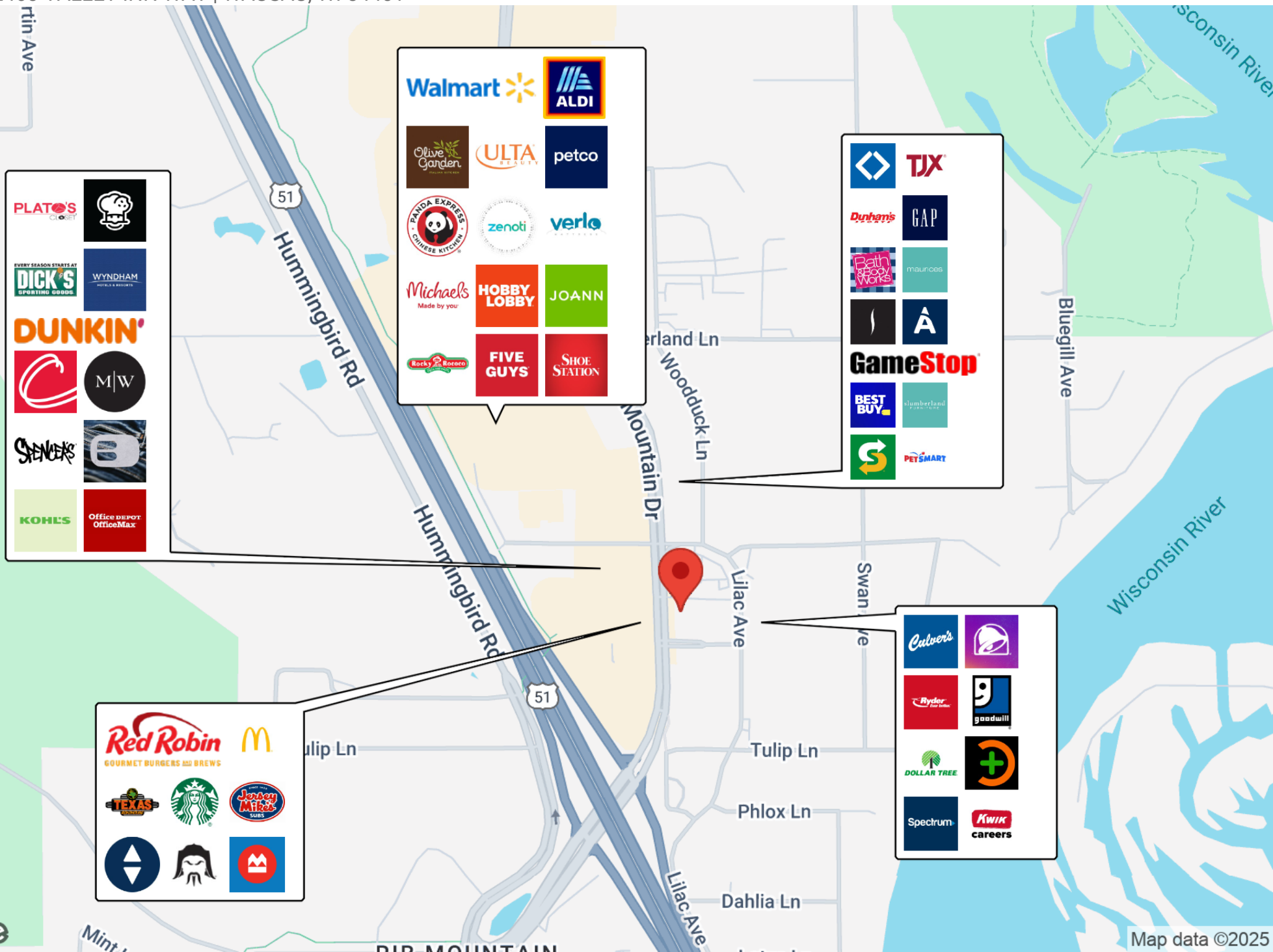

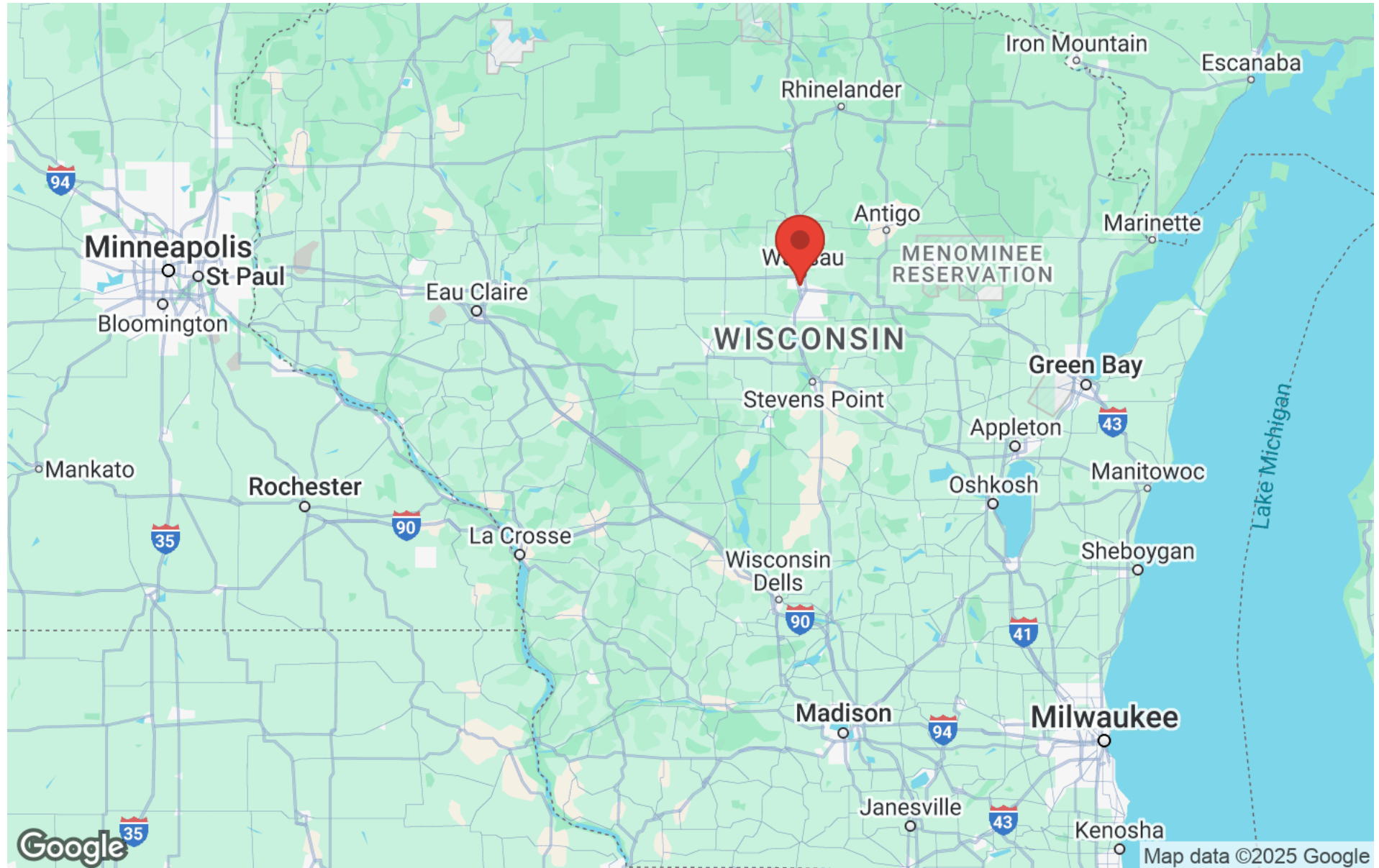
BUSINESS MAP

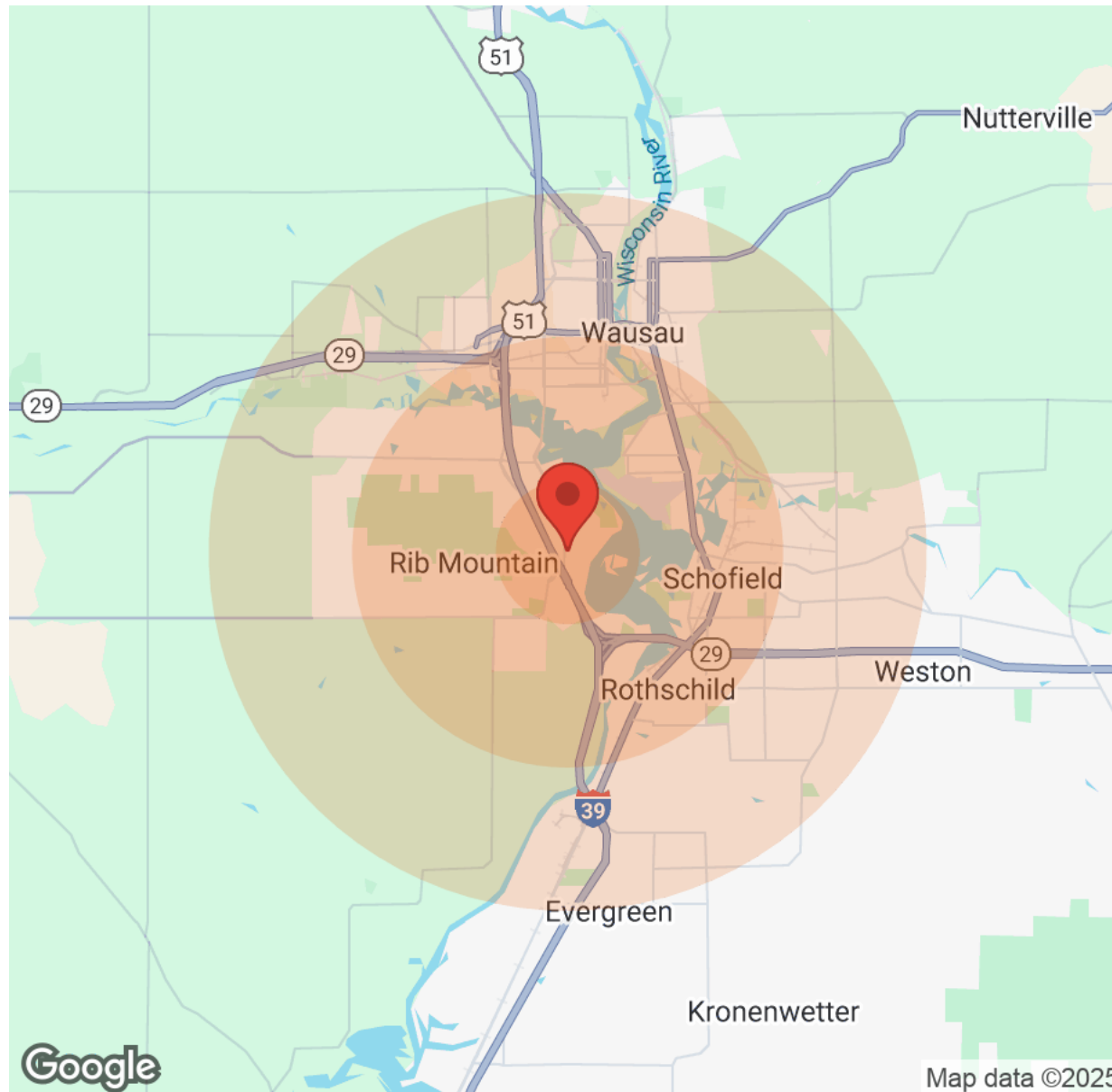
