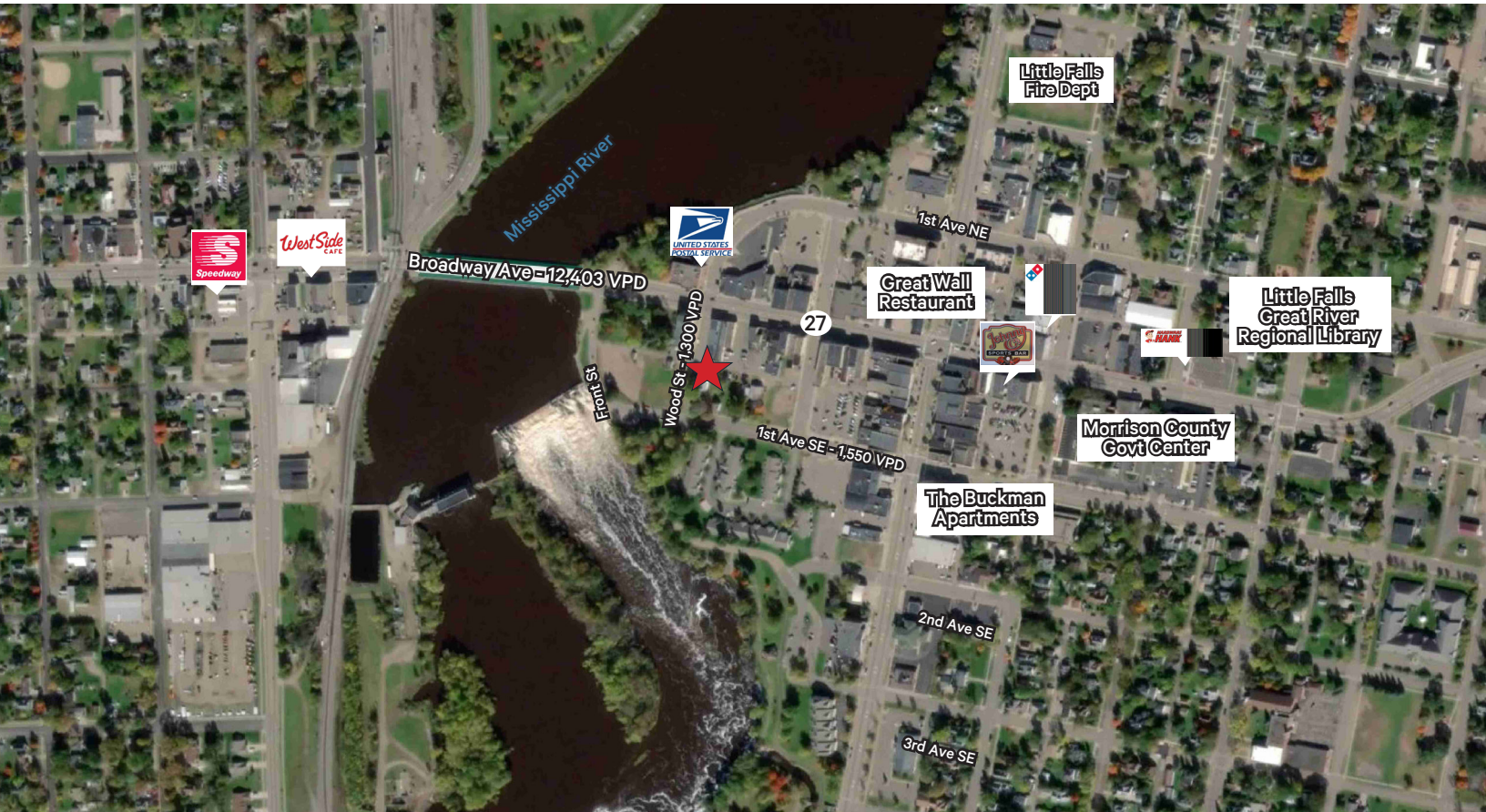

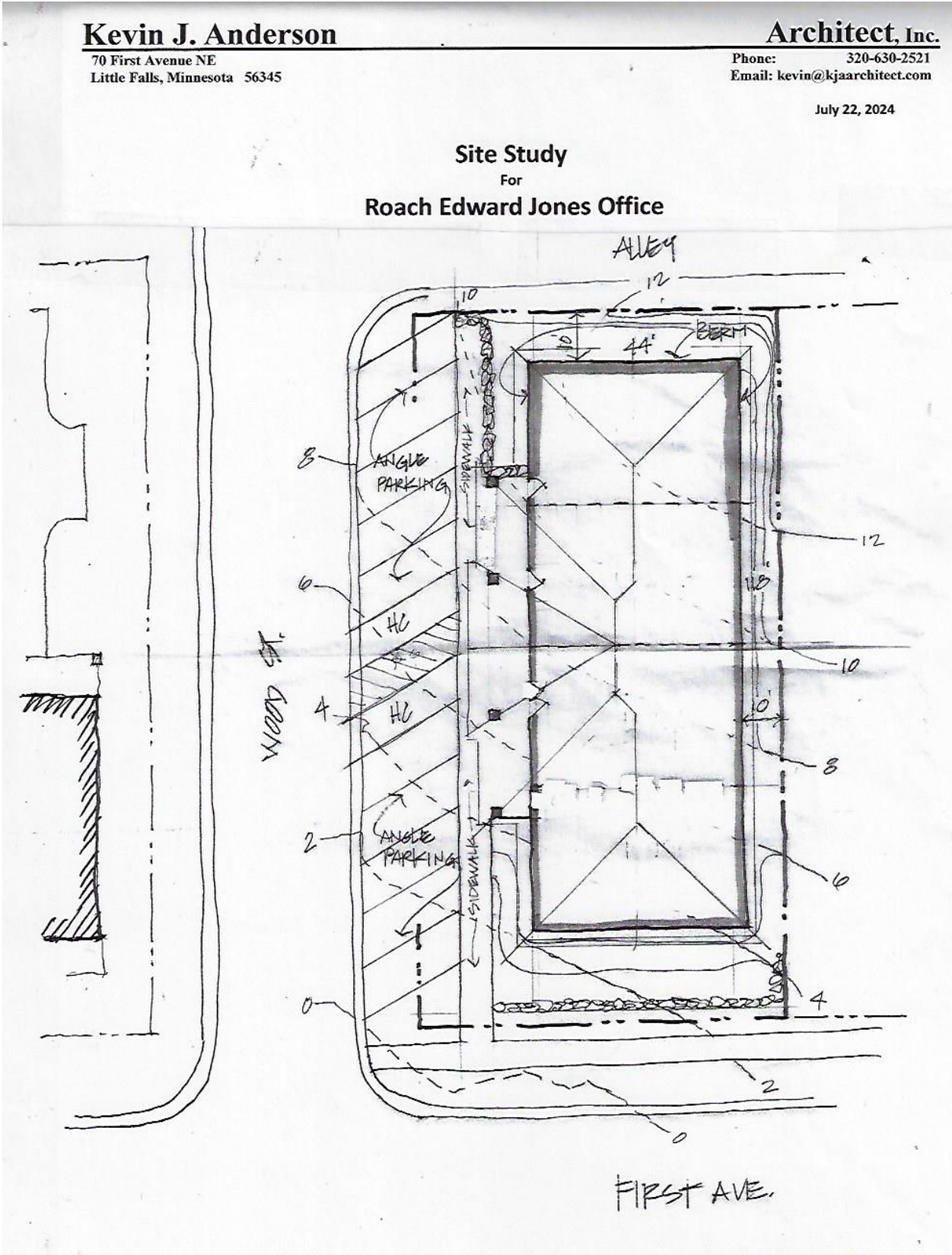
Floor Plans



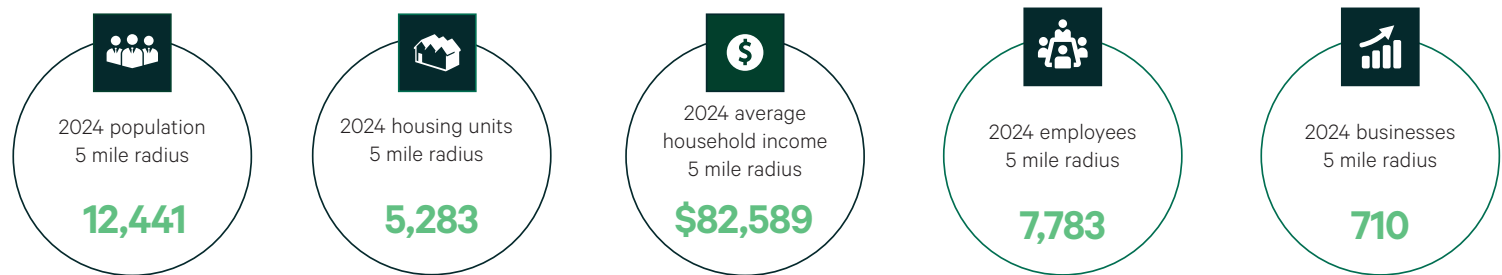
