Historically & currently home to Artisan's Inc., a well-established screen printing and embroidery clothing manufacturer with a strong local workforce of approximately 75 employees. The facility includes 26,000 SF of office space & 136,900 SF of manufacturing and warehouse space. Building features include 10–14' eave heights, 22–24' center heights, a fire suppression system throughout, 1 overhead door, & 8 dock doors, providing exceptional flexibility for production & distribution operations. Utilities include municipal water & sewer & a 2,000-amp 3-phase electric service, supporting a wide range of industrial or manufacturing uses.



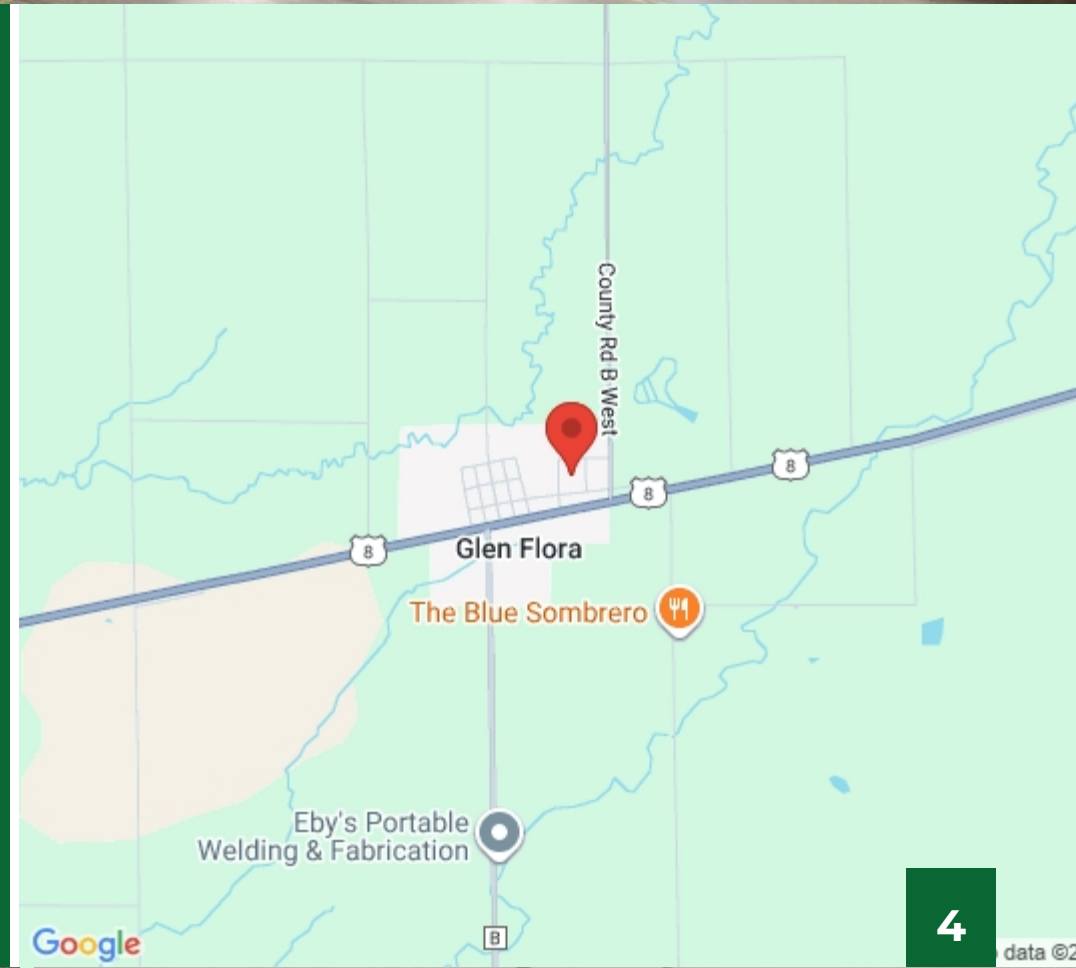

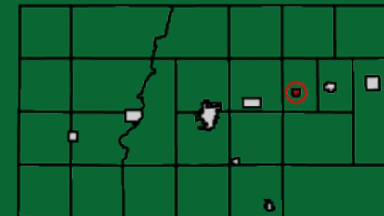

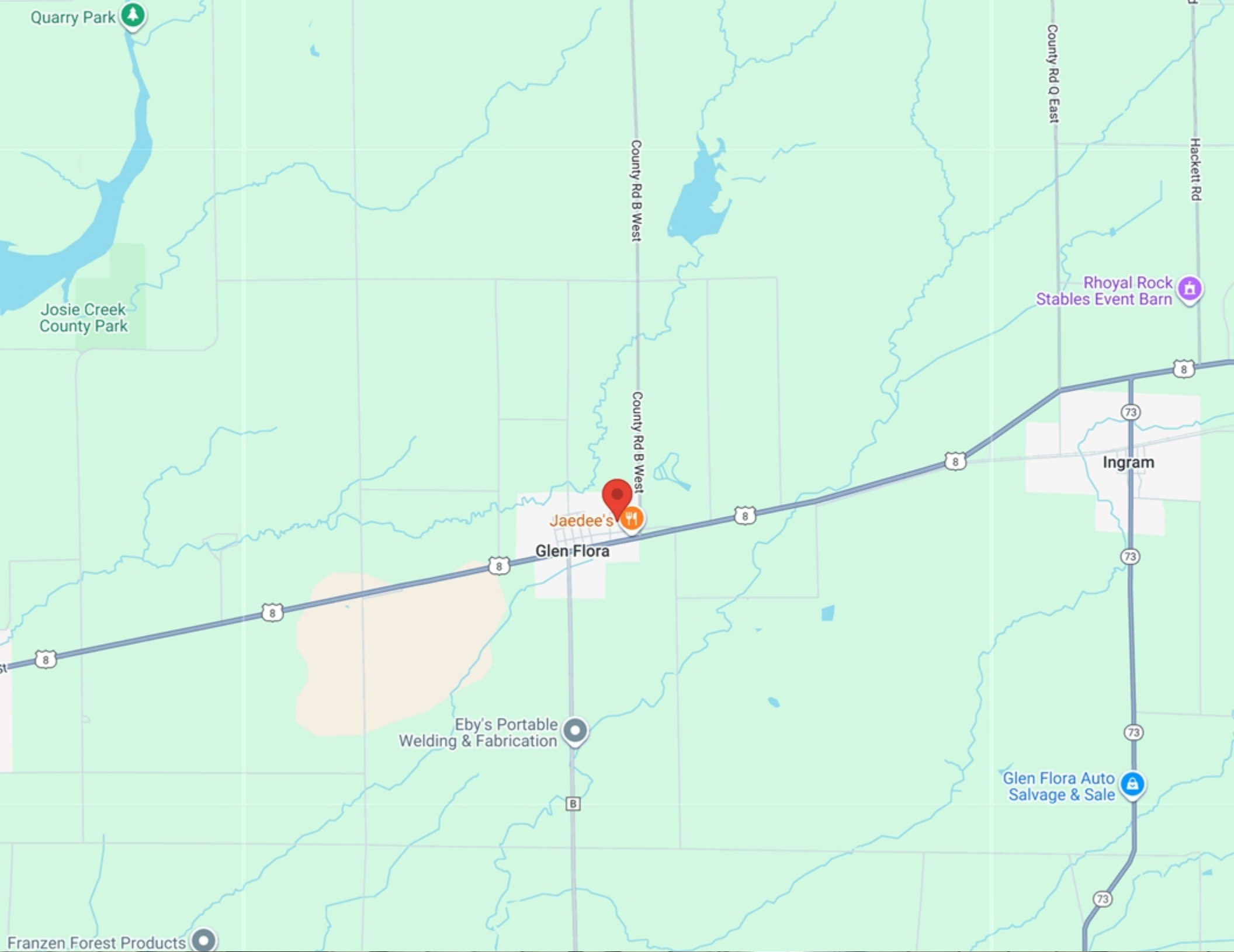
