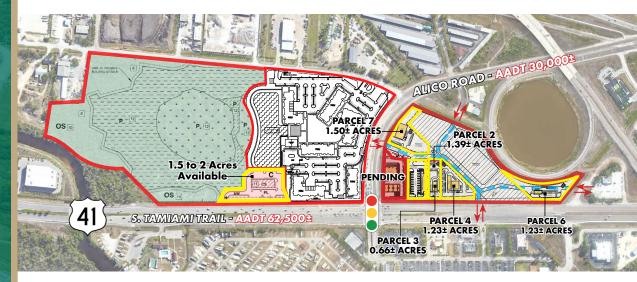

This is a prime opportunity for retail and commercial development in one of Fort Myers' most sought-after areas.

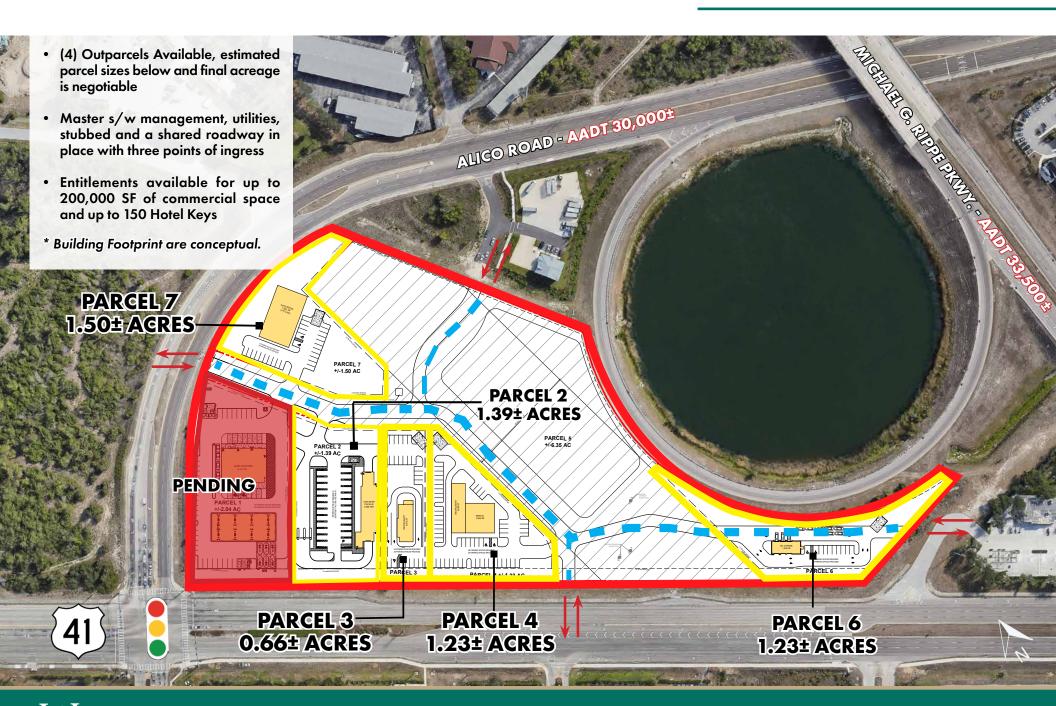


SITE PLAN





SOUTH PARCEL SITE PLAN



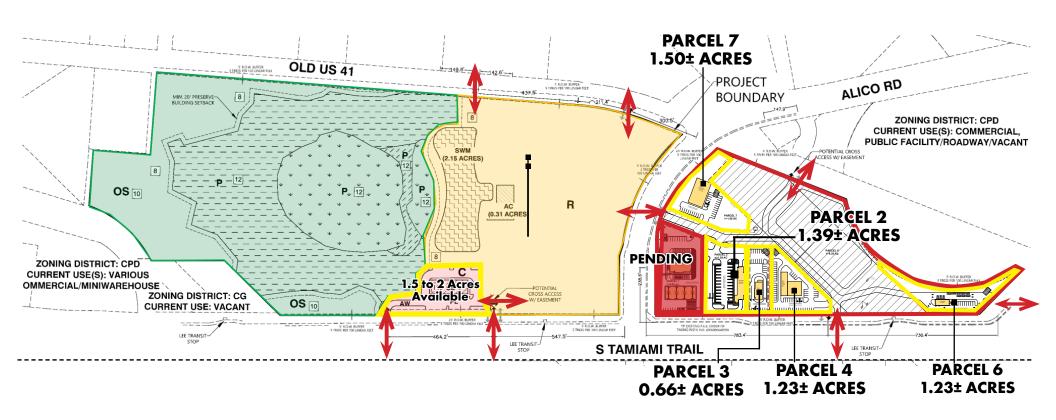


NORTH PARCEL SITE PLAN

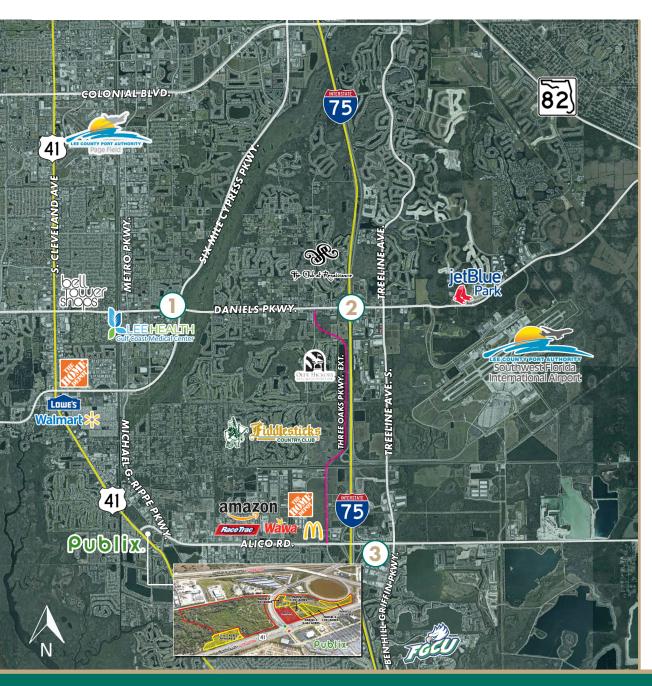

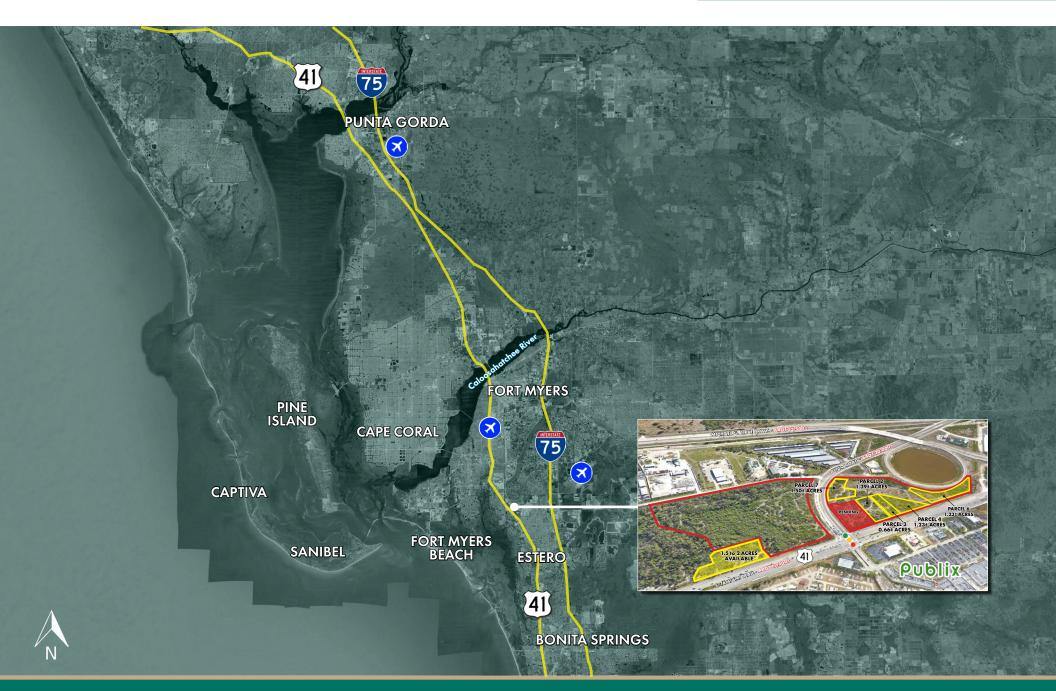


DRIVE TIME MAP
