
PROPERTY DESCRIPION

The property was built in 2000 as a flex/warehouse property. The property was extensively renovated in 2019-2020 with the addition of a second floor, offices, splash pools, locker rooms and various situational fitness rooms such as altitude training, specialized personal training, yoga studios, spa treatments, IV treatments, and similar uses. The property includes separate retail/office space in the front of the building (frontage to N Park Dr) which can be leased or used by Owner.

The property includes a lobby entrance with a front desk and retail area, stadium seating area, large workout area with various fitness equipment and open space for personal training. The newly added 2nd floor includes offices, yoga studio, IV treatment rooms, additional smaller scale exercise areas, spa services and areas for cubicles.

The superior quality renovations were completed to the entire property with impact glass and doors, fire systems, plumbing and electrical and structural work, including the 2nd floor addition. The renovation added approximately 6,000 sq ft to the property with the addition of the second floor.

The property includes a drive in dock in the back of the building (20' clearance) and plenty of parking in the 2.25-acre lot, including in the front, back and on the side of the property.






PROPERTY DESCRIPION



The front portion of the property was formerly Therapies for Kids, which worked with children and their parents specializing in services for autism, speech therapy, psychiatric and physical therapy.





PROPERTY SITE PLAN






The square footage of the property after the 2020 renovations was 26,998 sq ft, split up amongst two floors.

The lot size is 98,008 sq ft, or 2.25-acres.






HOUSE OF ATHLETES FLOOR PLAN - FIRST FLOOR
