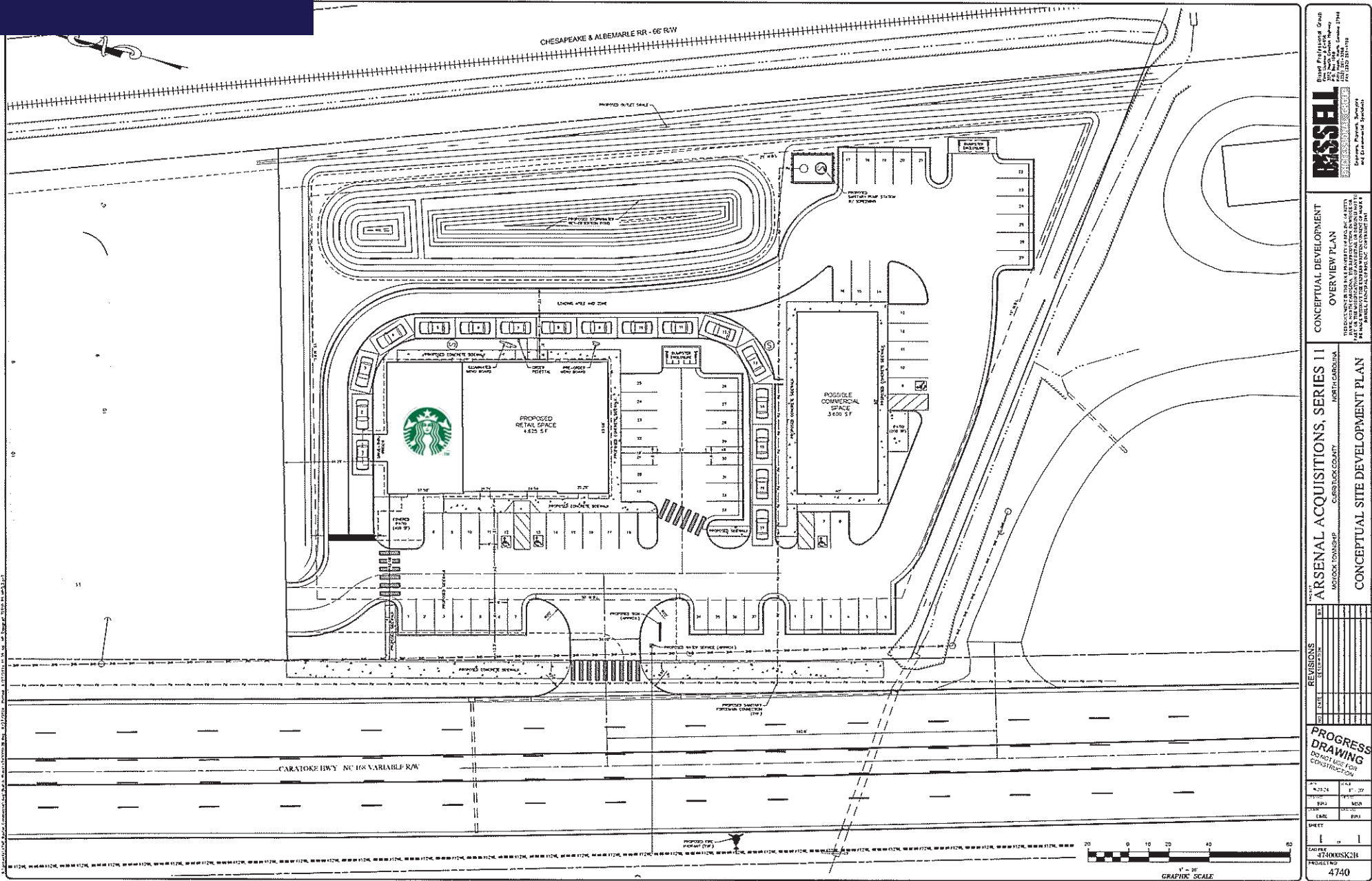

Moyock Comp Map

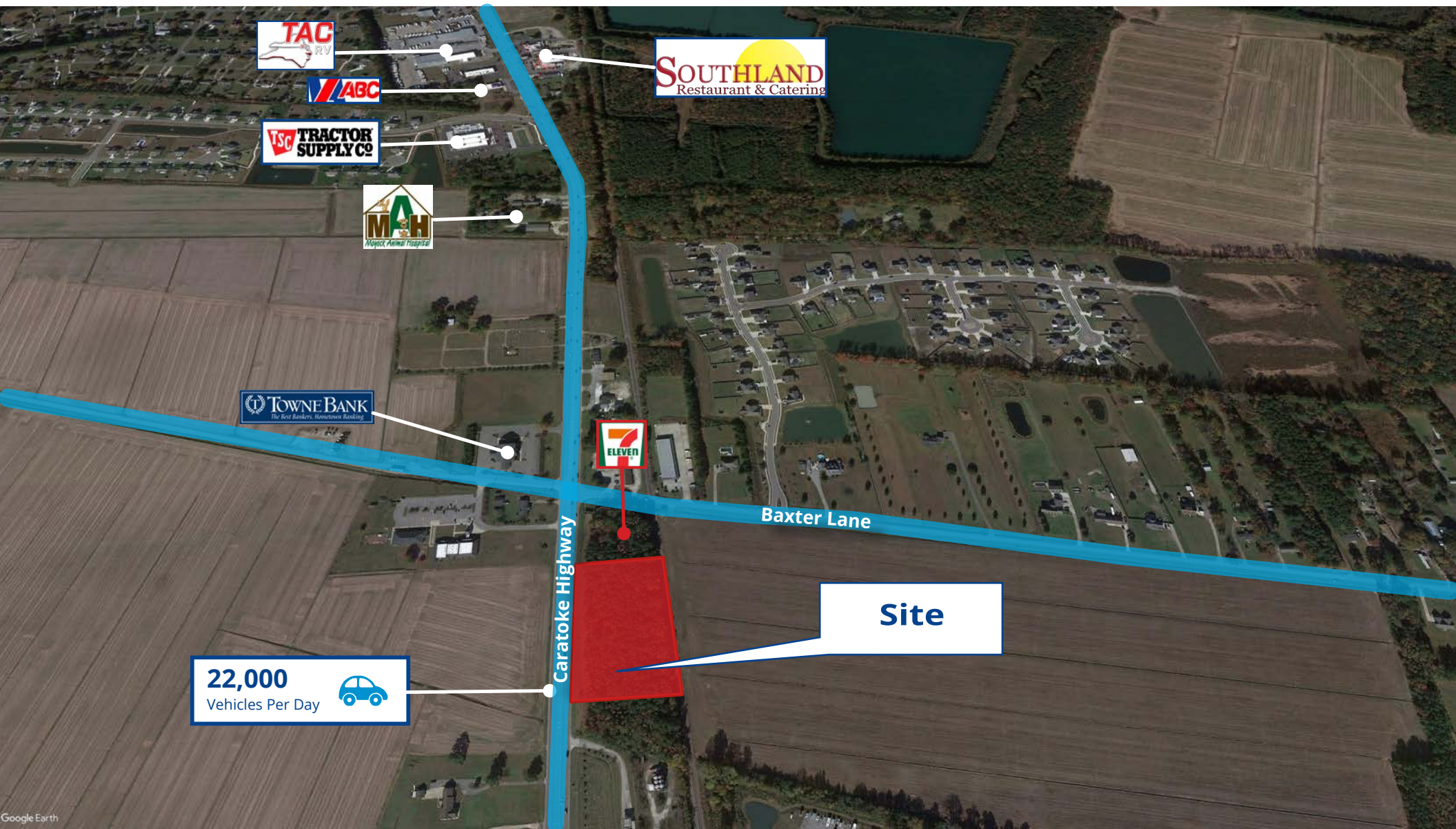

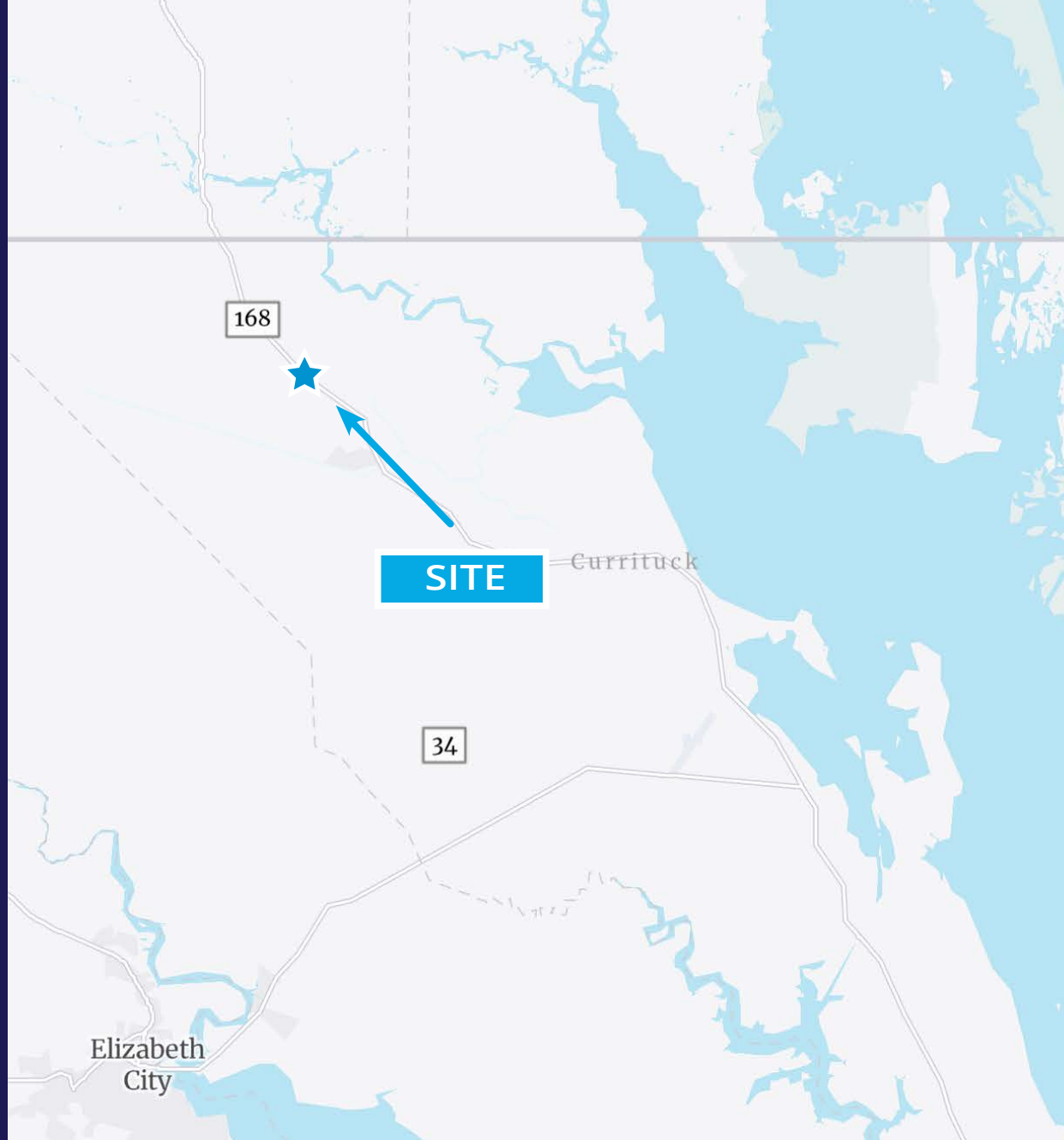
