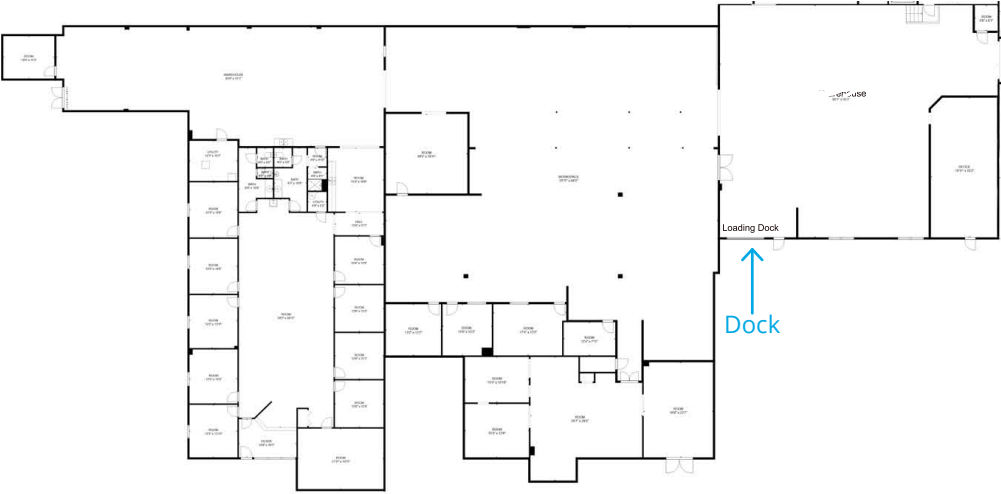
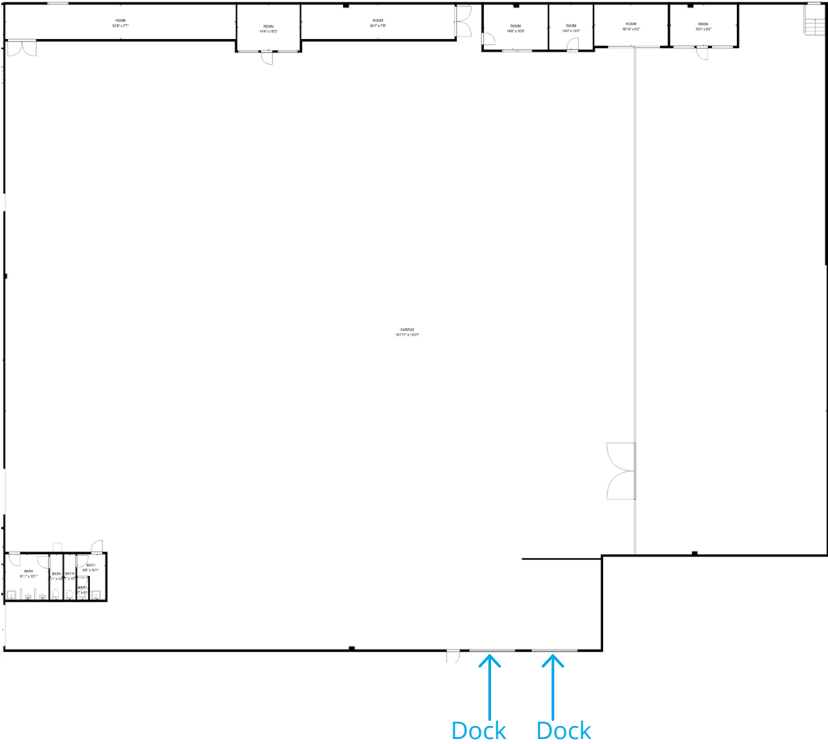
**Second Floor Office**

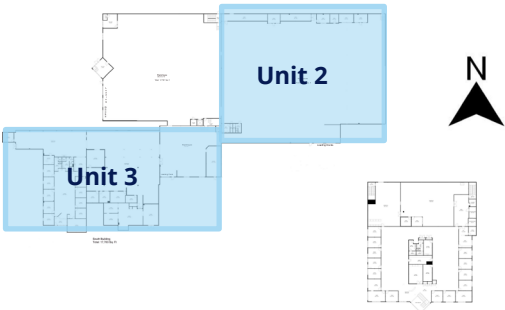

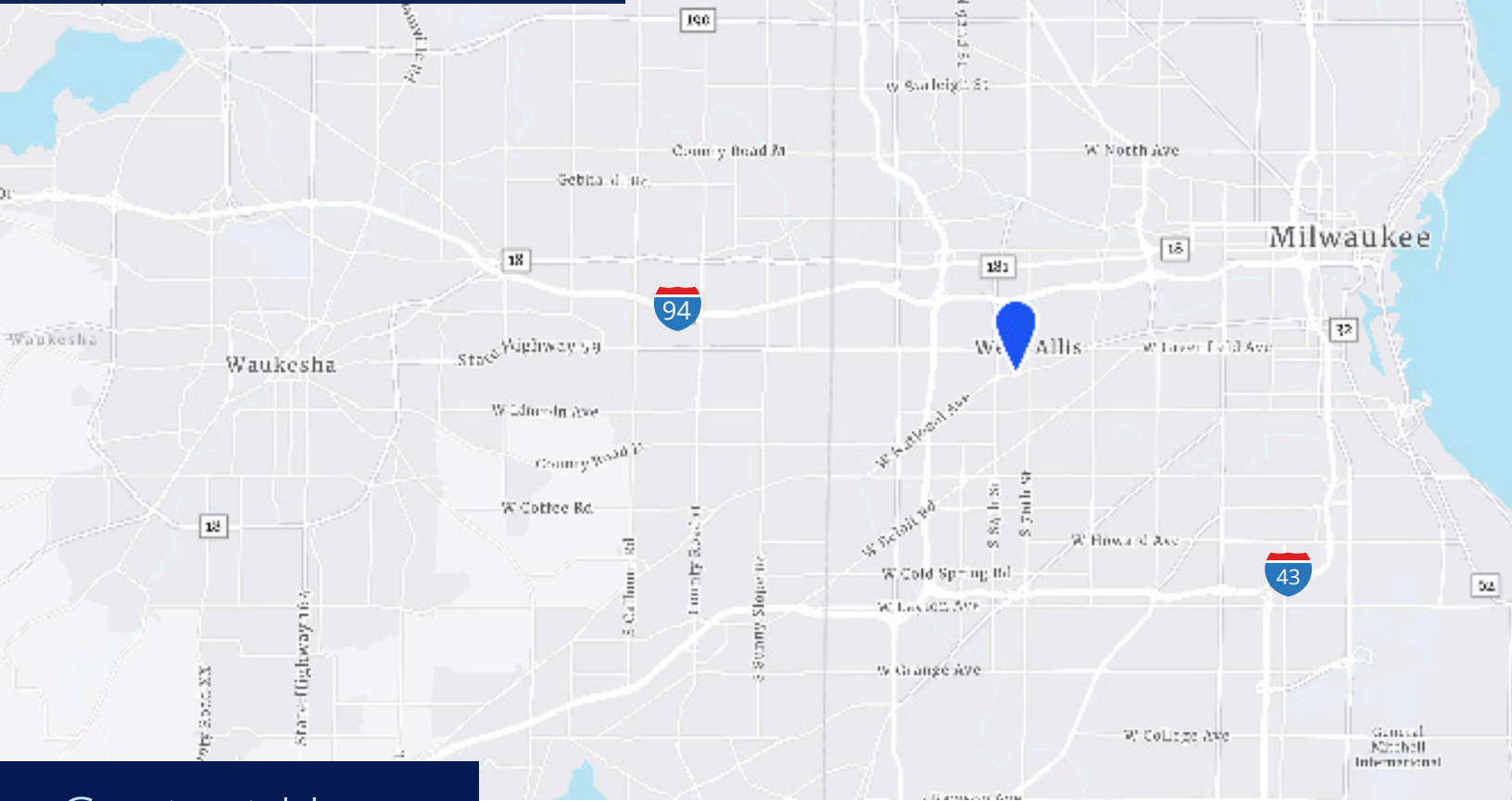
## Drive Times from Hicks Street

**Non-Residential Customers**
