

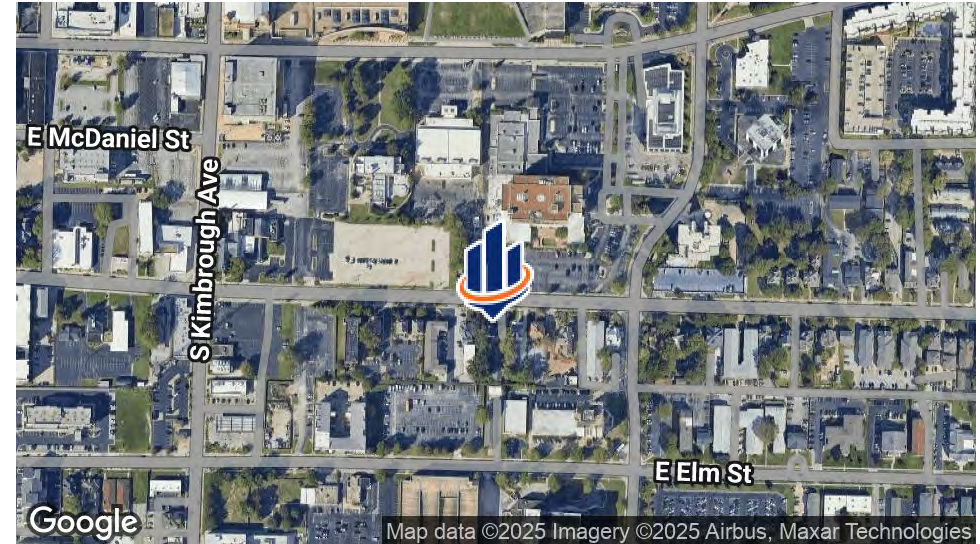

- Multiple restaurants, shops and other amenities within walking distance.

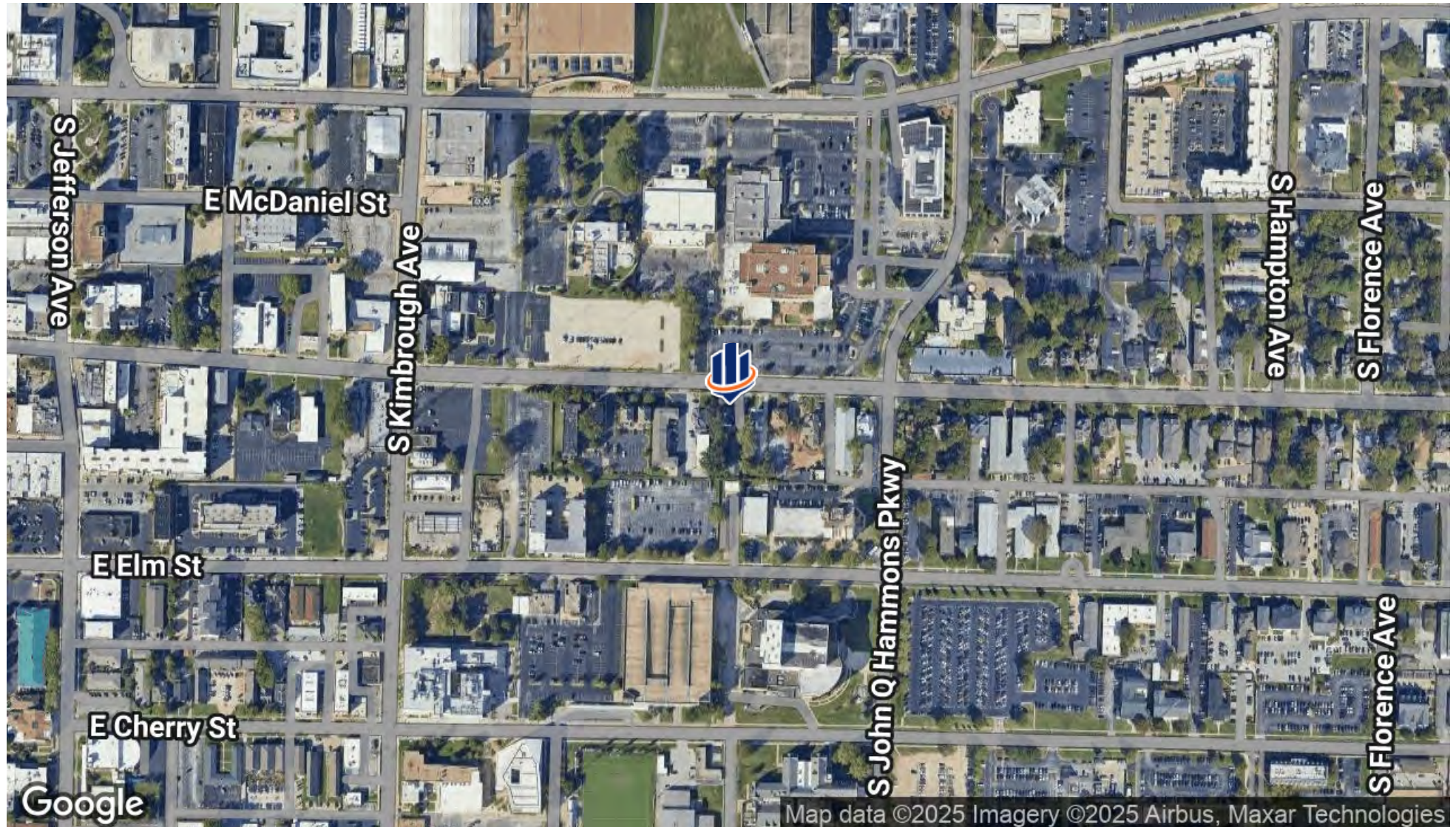

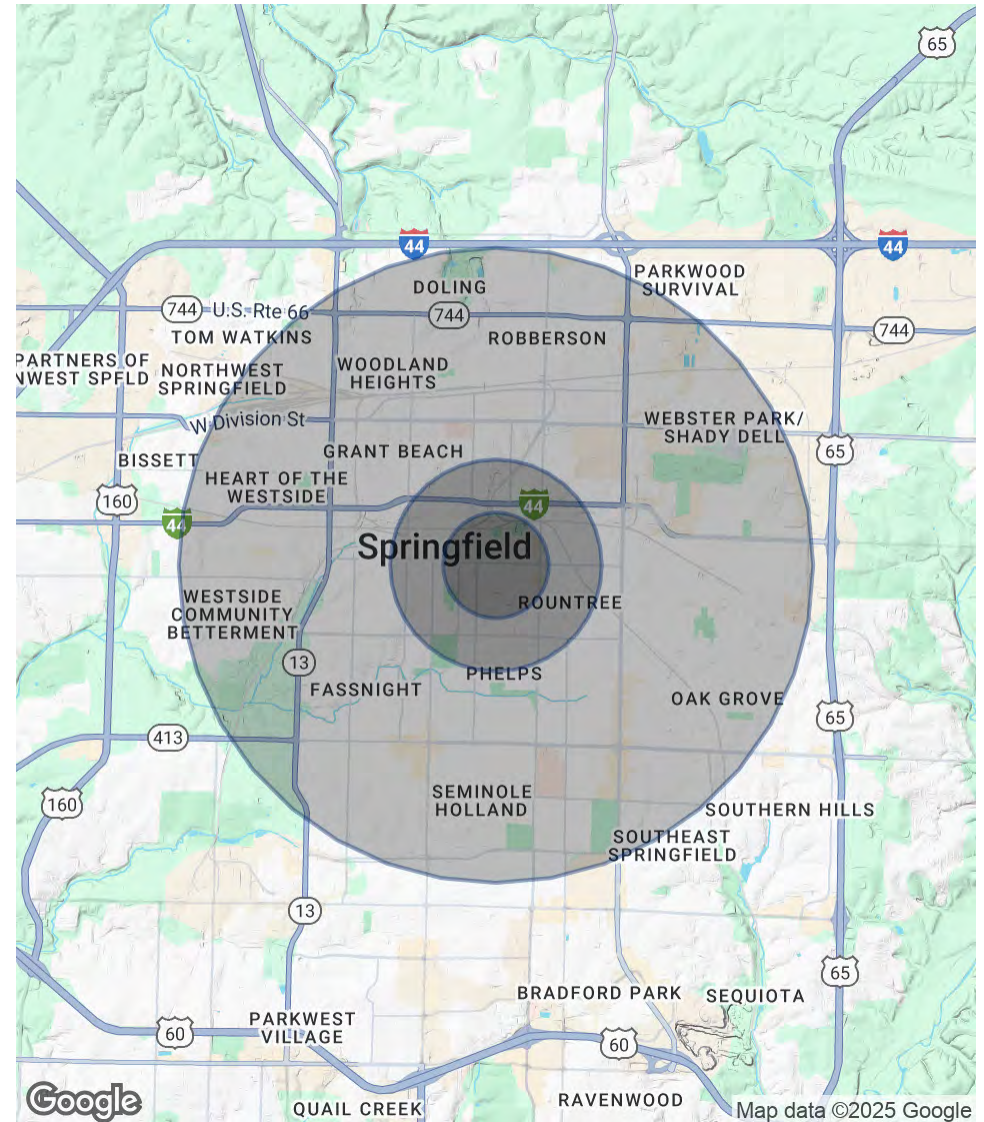
