HAERNER, PETER HAERNER and BONIE HAERNER and Faith Hoerner, husband and wife of Flathead County, Montana, do hereby certify that we have caused to be surveyed and subdivided into lots, blocks, streets and alleys as shown by the certificate of survey hereto annexed the following described tract of land to wit: Beginning at a point on the westerly boundary of 4th Ave West of the City of Columbia Falls, Montana, said point being 86.4 feet West and 290 feet South of the N.W. 1/4 of Section 17 Township 30 North Range 20 West, thence West 156.1 feet, thence North 4.10 to the southerly boundary of State Highway No. 10, thence West 316.7 feet along said southerly boundary of Hwy No. 10 thence South 423.0 feet, thence West 125.1 feet to the westerly boundary of 4th Ave West, thence North 595 feet to the true point of beginning, said subdivision to be known and designated as Hoerner Addition and the land included in all streets and alleys shown on the annexed Plat are hereby granted and donated to the use of the Public forever.

I, W. D. Seibert, County Surveyor for Flathead County, Montana do hereby certify that I have examined the annexed Plat and approve of the same.

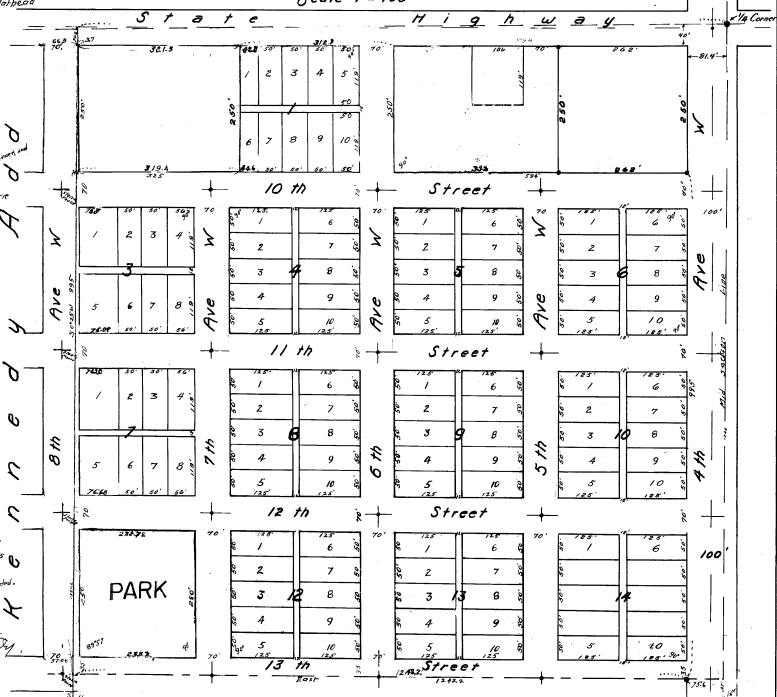
Certificate of Survey
