# NEIGHBORHOOD OVERVIEW



## FAIRMONT – CLAREMONT VILLAGE

Fairmont-Claremont Village is a residential neighborhood located in the heart of the South Bronx, offering a mix of longstanding community roots and ongoing revitalization.
