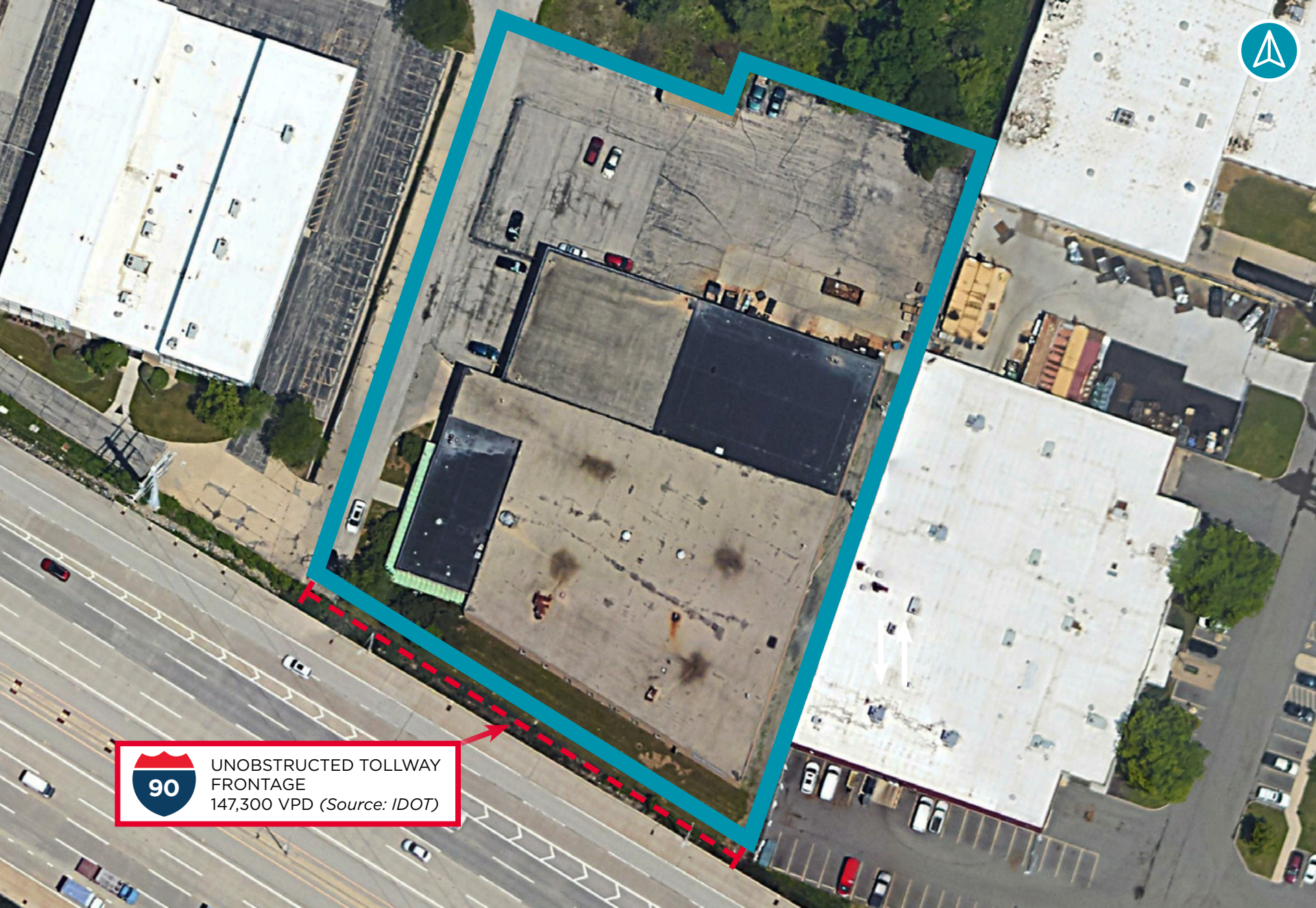

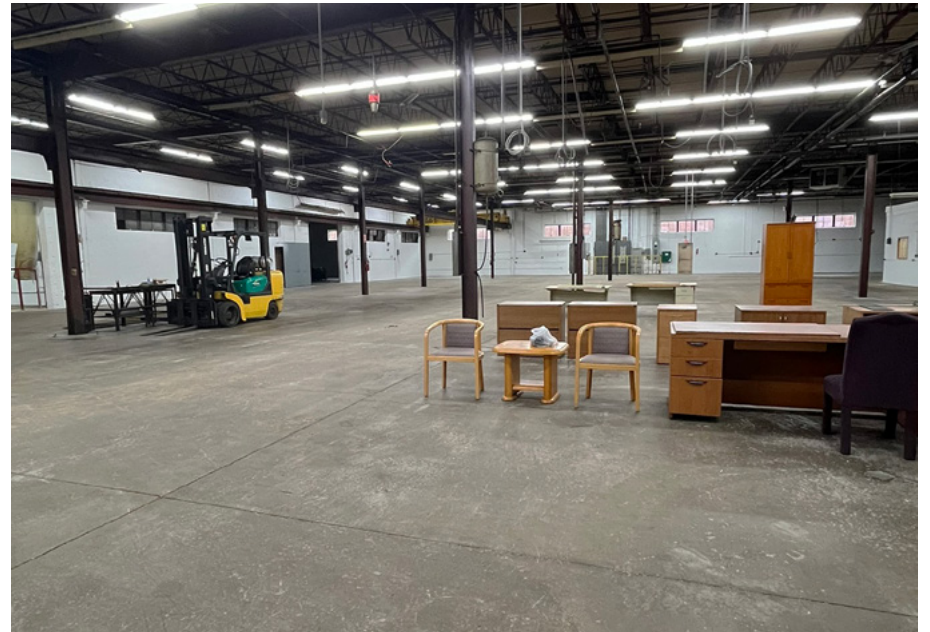




SITE PLAN

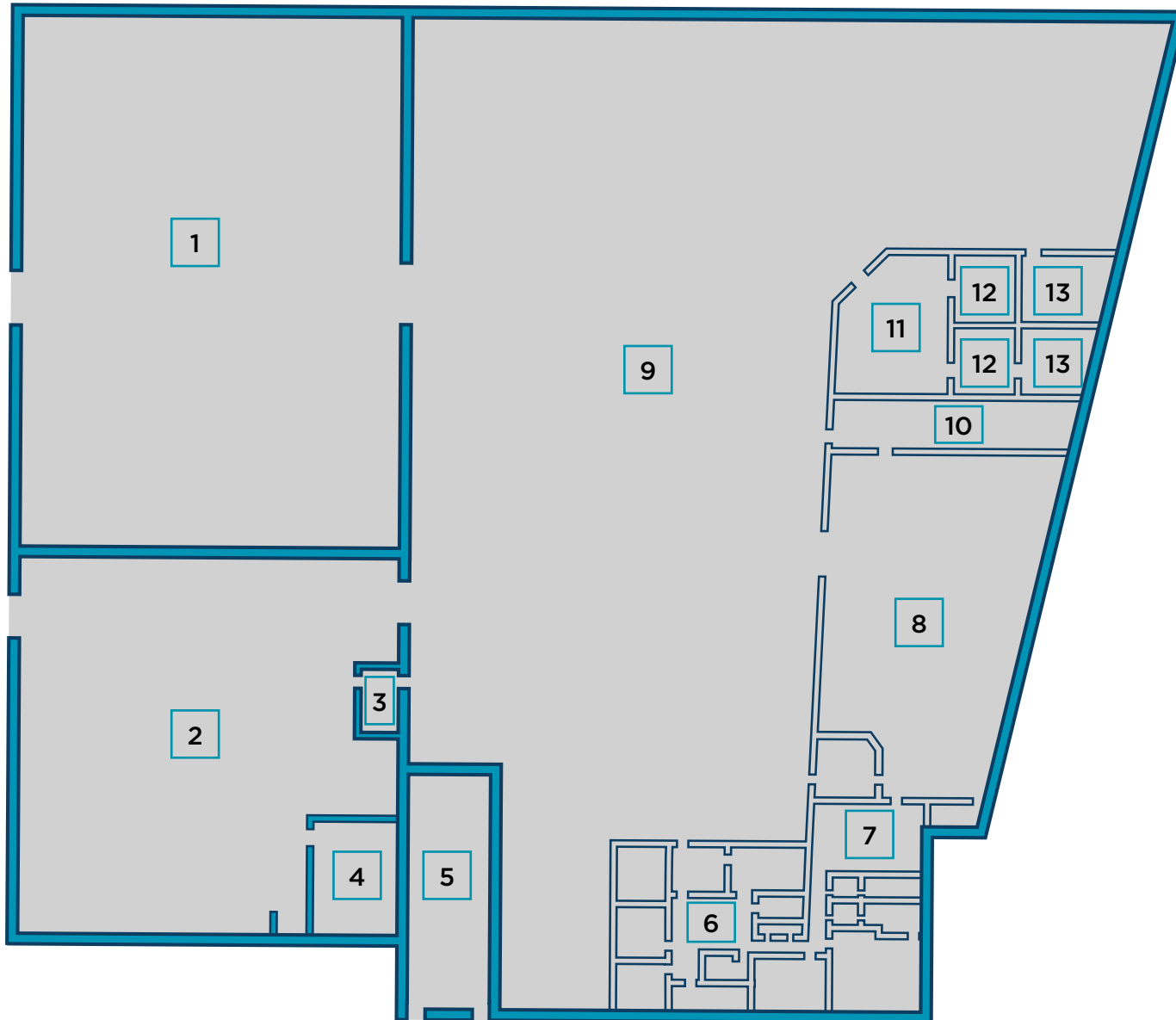


 UNOBSTRUCTED TOLLWAY
