NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 31 day of January 1994, by and between

The designation Grantor and Grantee as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine, feminine or neuter as required by context.

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that certain lot or parcel of land situated in the City of Waynesville Township, Haywood County, North Carolina and more particularly described as follows:

The 0.600 acre tract shown on the survey entitled "John S. Smith & Saunook Industries" recorded in Plat Cabinet C, Slot 1619, Haywood County Registry.

TOGETHER WITH and SUBJECT TO the joint use of the 30' right of way (for access and utility purposes) shown on the plat running to S.R. 1243 (Old US Highway 19-23).

SUBJECT TO the restrictions recorded in Deed Book 395, page 522. TOGETHER WITH an easement for septic field drain lines running across the northern portion of the subject property onto the adjacent property of Saunook Industries (Deed Book 440, page 522) for the repair, maintenance and replacement of a septic tank and septic field drain lines. This easement was reserved in the deed from the Grantors to Saunook Industries referred to above.

BEING a portion of the property conveyed to Joe C. Haynes by Farm Credit Bank of Columbia by deed dated December 19, 1988, recorded in Deed Book 395, page 768.

The property hereinabove described was acquired by Grantor by instrument recorded in


