The Army Corp of Engineers has approved a 30 slip expansion, and additional upside is envisioned in the renewal of the mooring field and services, greater utilization of the event space, and in offering additional maritime services.

Bath, ME is known as “The City of Ships” for its prominent role in North American shipbuilding. Bath Iron Works (now a subsidiary of General Dynamics) has been a leading shipbuilder for over 140 years, and is the largest manufacturing employer in the State of Maine. Bath’s location on the Kennebec River offers maritime access to interior rivers and coastal waters, as well as being a deep water port only 10 miles from the Gulf of Maine and the Atlantic Ocean. Investment capital is moving North along the Maine coastline as the Mid Coast communities continue to benefit from population growth and investment opportunities with attractive entry fundamentals.


