13 14 15 16	Conventional Septic System Pumping: If the Facility is a conventional septic system or alternative system that uses a septic tank, prior to Close of Escrow it shall be pumped at Seller's expense to remove, to the maximum extent possible, solid, floating, and liquid waste accumulations, unless: (i) a Discharge Authorization for the Facility was issued and the Facility was put into service within twelve (12) months before the transfer of ownership inspection; (ii) pumping or servicing is not necessary based on the manufacturer's written operation and maintenance instructions; or (iii) no accumulation of floating or settled waste was present in the septic tank or wastewater container.
