## REVIEW YOUR TAX NOTICE BEFORE YOU PAY

1. PARTIAL OR INCORRECT PAYMENTS WILL BE RETURNED AND MAY RESULT IN PENALTIES BEING DUE
2. Appeals do not prevent penalties accruing for unpaid accounts. **DO NOT WAIT FOR APPEAL RESULTS PRIOR TO PAYING YOUR TAX BILL.**
3. PAYMENTS MUST BE RECEIVED AT OR BEFORE CLOSE OF BUSINESS ON THE DAY BEFORE PENALTIES ARE IMPLEMENTED TO AVOID PENALTIES. PAYMENTS RECEIVED AFTER NORMAL BUSINESS HOURS WILL INCUR A STATUTORY PENALTY.
4. THE UNITED STATES POSTMARK IS THE ONLY DETERMINING DATE FOR MAILED PAYMENTS
5. USE OF ONE CHECK TO PAY MULTIPLE ACCOUNTS **WILL INCREASE** PAYMENT PROCESSING TIME
6. CONFIRMATION OF PROOF OF MAILING OR RECEIPT OF PAYMENT IS PROVIDED BY THE U.S. POSTAL SERVICE

11. DISHONORED OR FAILED E-CHECKS, BANK CHECKS OR OTHER ELECTRONIC PAYMENTS WILL INCUR A RETURNED PAYMENT PROCESSING FEE.
12. PAY EARLY AS INTERNET AND DROP BOX PAYMENT METHODS WILL HALT AT CLOSE OF BUSINESS PRIOR TO PENALTY IMPOSITION DATES FOR ACCOUNT RECONCILIATION

<p><b>LEGAL RESIDENCE AND AGRICULTURAL USE</b>                  In accordance with S.C. Code of Law 12-43-220, as amended, property owners are required to file an initial application for special assessment ratios for legal residence and agricultural property used for such purposes. To qualify for owner occupied residence or agricultural use rates, the owner must file a special assessment application with the Assessor's Office on or before the first penalty date on this notice.  <b>Legal Residence and Agricultural Use Questions ..... 864-467-7300</b></p>	<p><b>HOMESTEAD EXEMPTION</b>                  You may qualify for a homestead exemption if you were at least 65 years of age, certified as legally blind by a licensed ophthalmologist or permanently and totally disabled as of December 31 of the preceding calendar year. <p><b>REAL ESTATE VALUE APPEALS</b>                  In years when there is an assessment notice of change, written objections must be filed within ninety days from the date of notice. In years when there is no notice of change, written objections must be filed before the first penalty date. An appeal filed on or after the first penalty date applies for the following property tax year.
