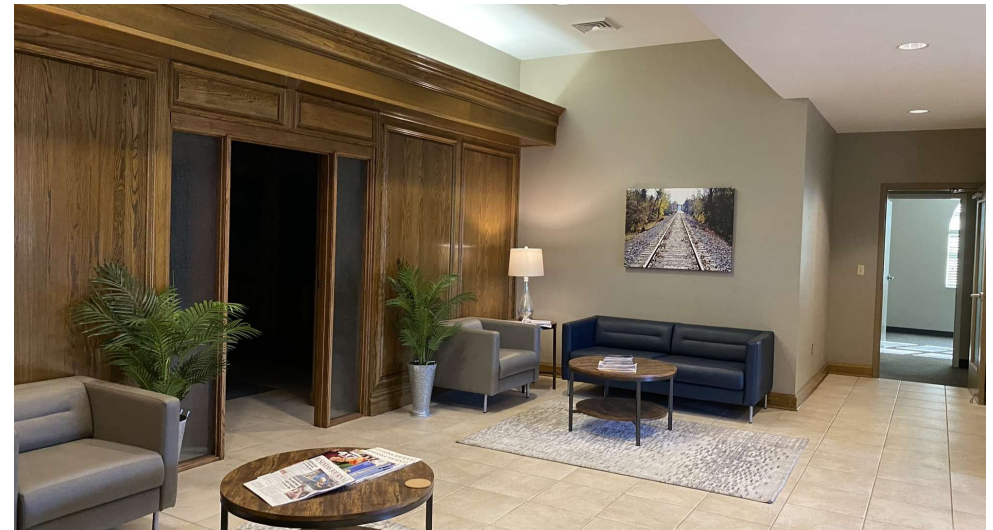

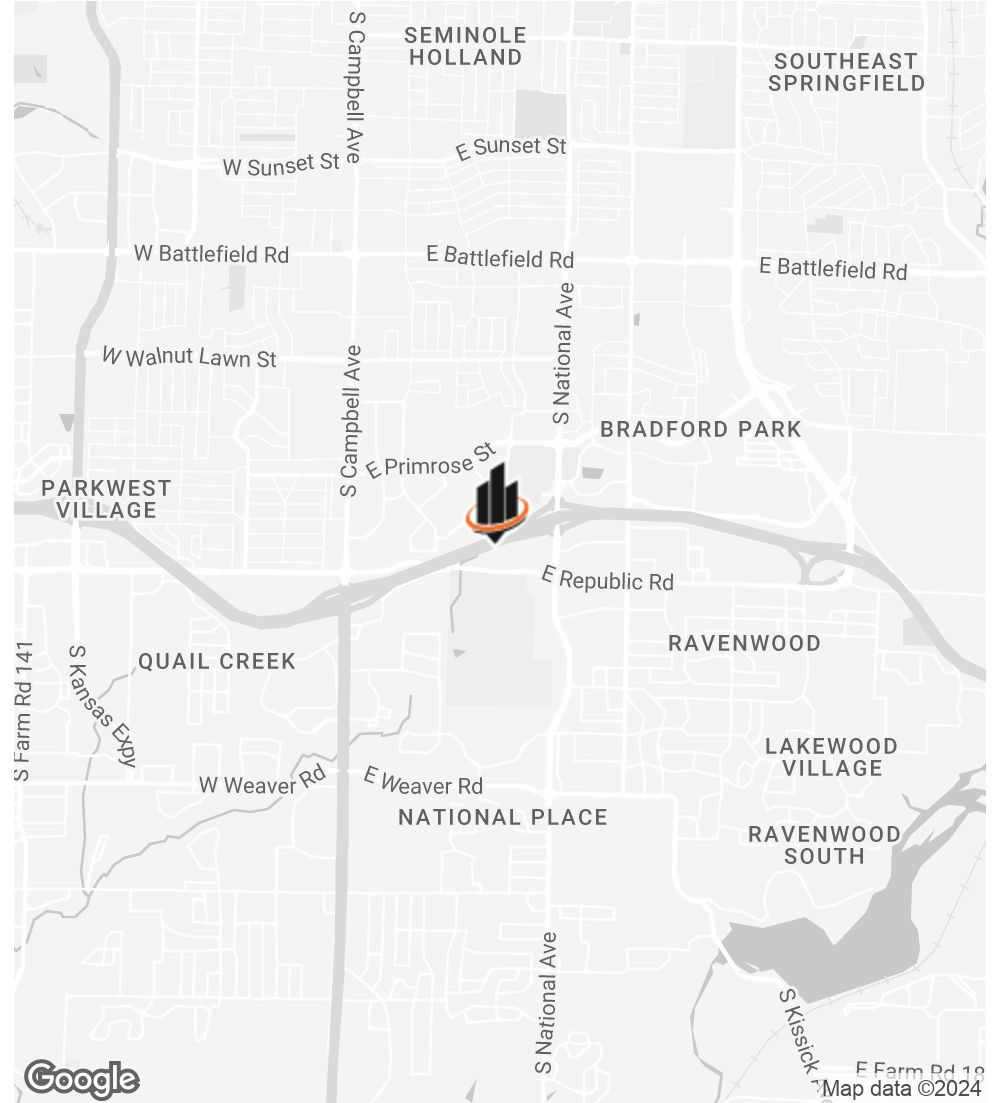

LOCATION MAP

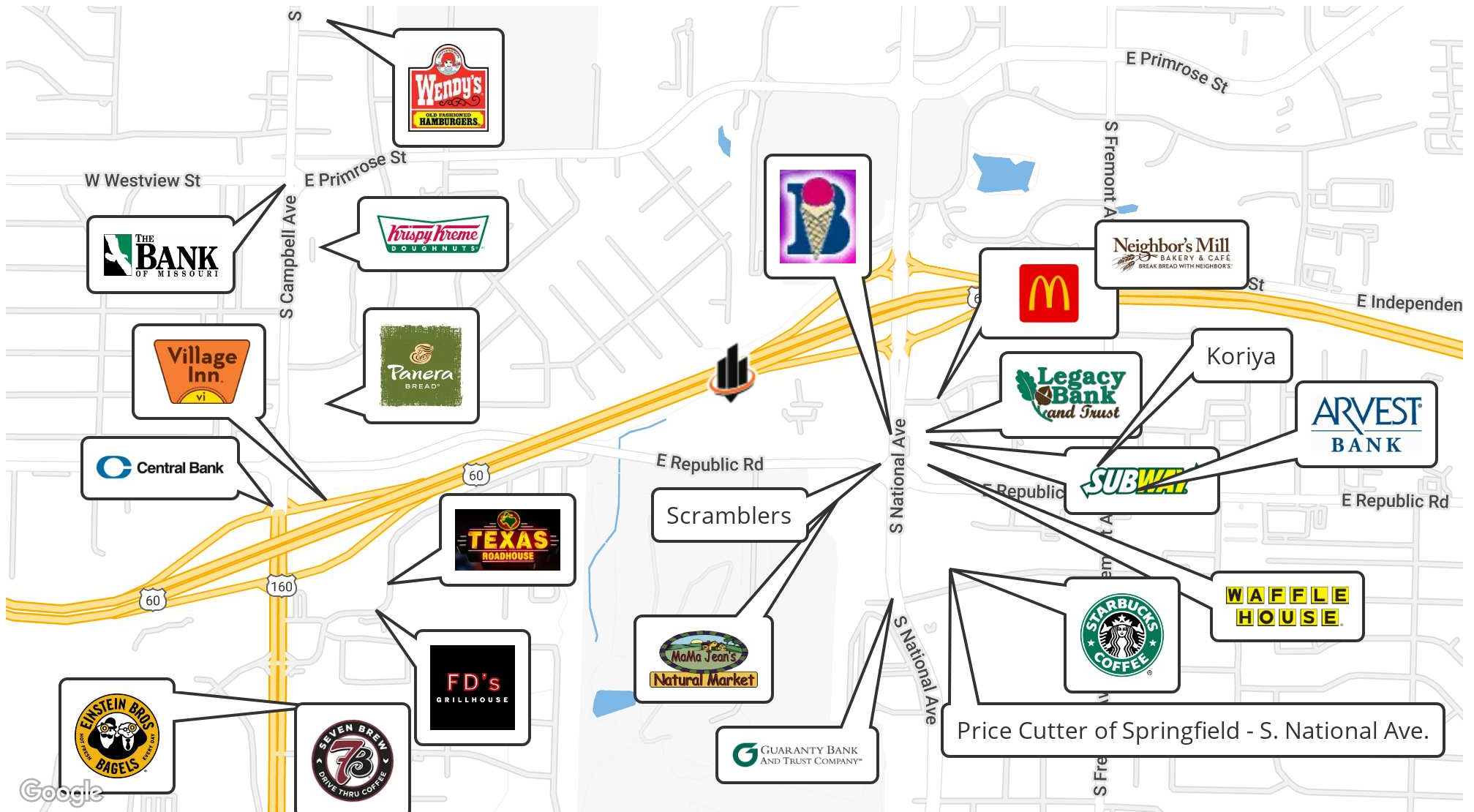

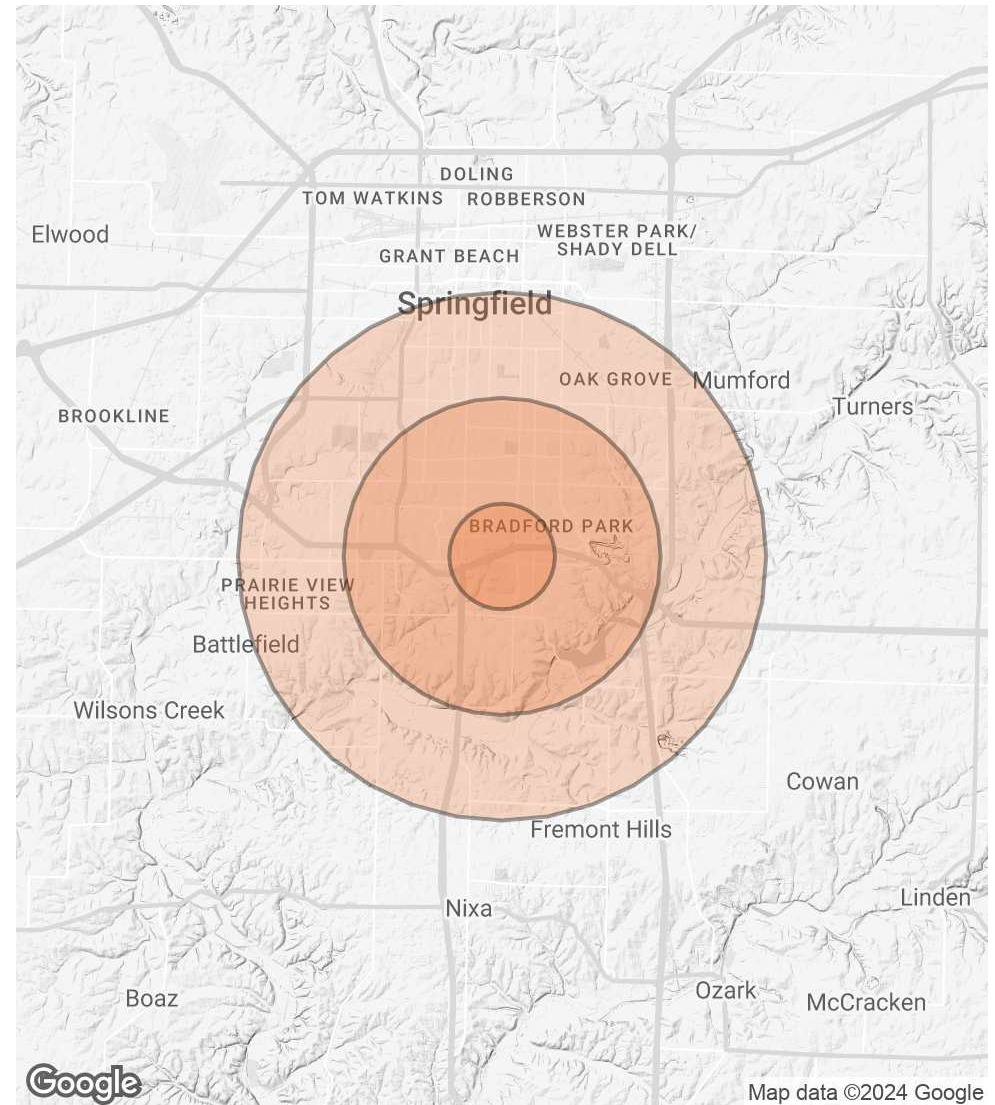
