# WESTERN SOMA

Western SoMA is a neighborhood defined by its up and coming developments and close proximity to some of the most desirable sub-markets in San Francisco: Mission District, the Hub District, Central SoMa, Potrero Hill, and Mid-Market. Conveniently situated near the intersection of the largest volume vehicle thoroughfares in the city—Interstate 80 and Highway 101—residents enjoy quick access to all parts of the city.

In 2019 the City designated the western portion of SoMa as a Community Benefit District. This legislation encouraged new developments, public amenities, and affordable housing while promoting general safety and cleanliness.

The neighborhood boasts of a growing density of off-the-beaten path restaurants that draw a crowd, including nine Michelin star restaurants (1601 Bar & Kitchen, Bellota, Birdsong, Californios, Izakaya Rintaro, Niku Steakhouse, Okane, Omakase, Shizen). Western SoMa offers the widest diversity of premium grocery options in the city (Costco, Trader Joe's, Whole Foods, Rainbow Grocery, Foods Co., Safeway, & independents). Western SoMa is evolving into one of the most desirable residential enclaves in the City.

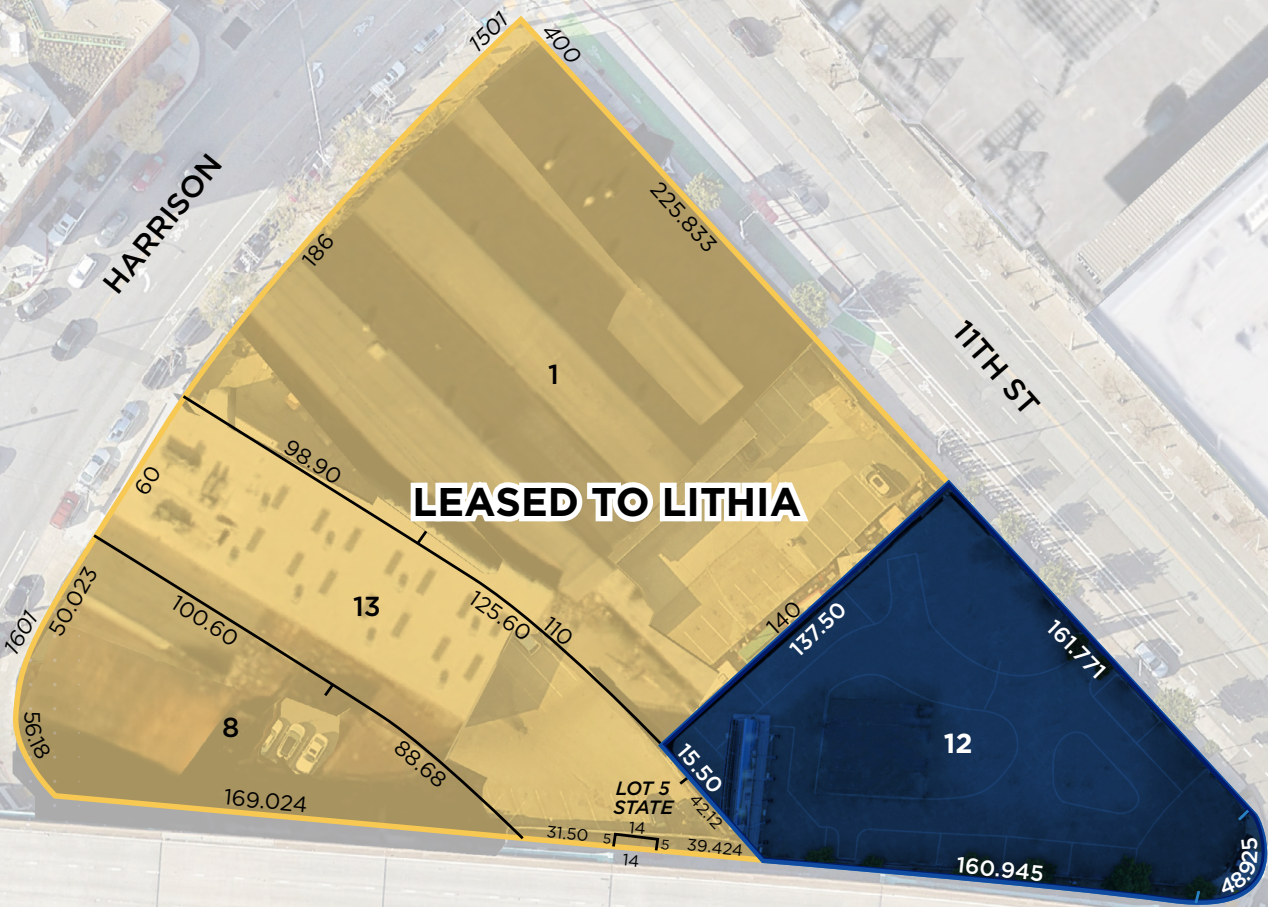
