In 2015, over \$1.5 million was invested into the 15th and 16th floors of the Petroleum Club Building to completely renovate the old Petroleum Club space, damaged by a fire in 1994. With over 17,500 square feet, Consumer Affairs beautifully utilized the space by leaving touches of history alongside the new modern design. By leaving the ceiling exposed, the office takes on a modern feel. The renovation features an open office plan in the center with modern work stations and an abundance of natural light from the 360-degree window line. They then took their space to the next level by adding a full bar and


