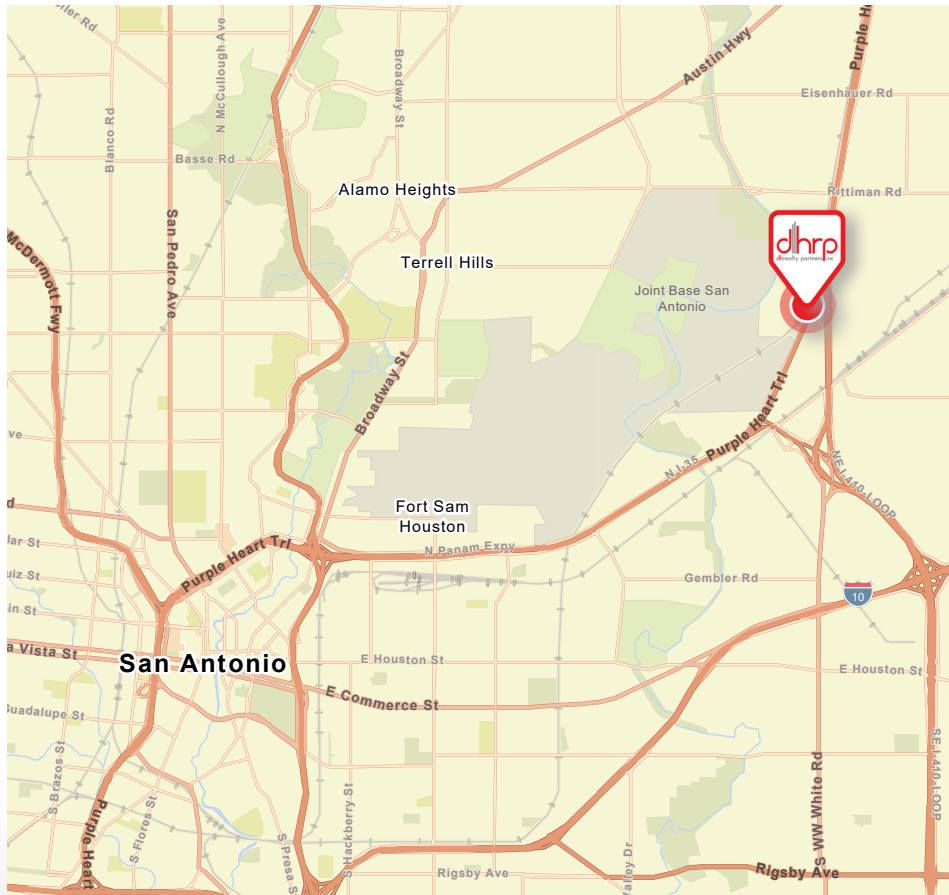

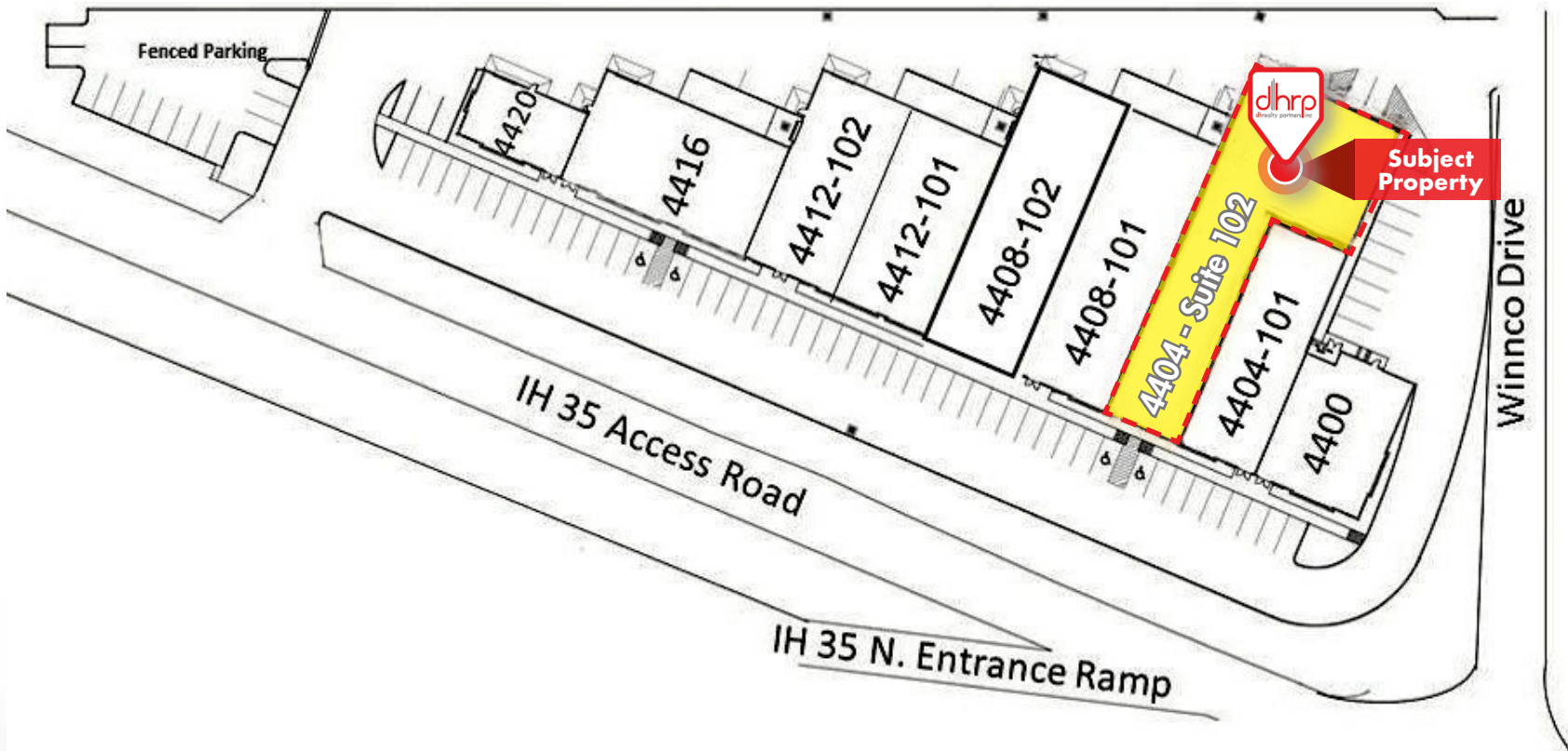

SITE PLAN

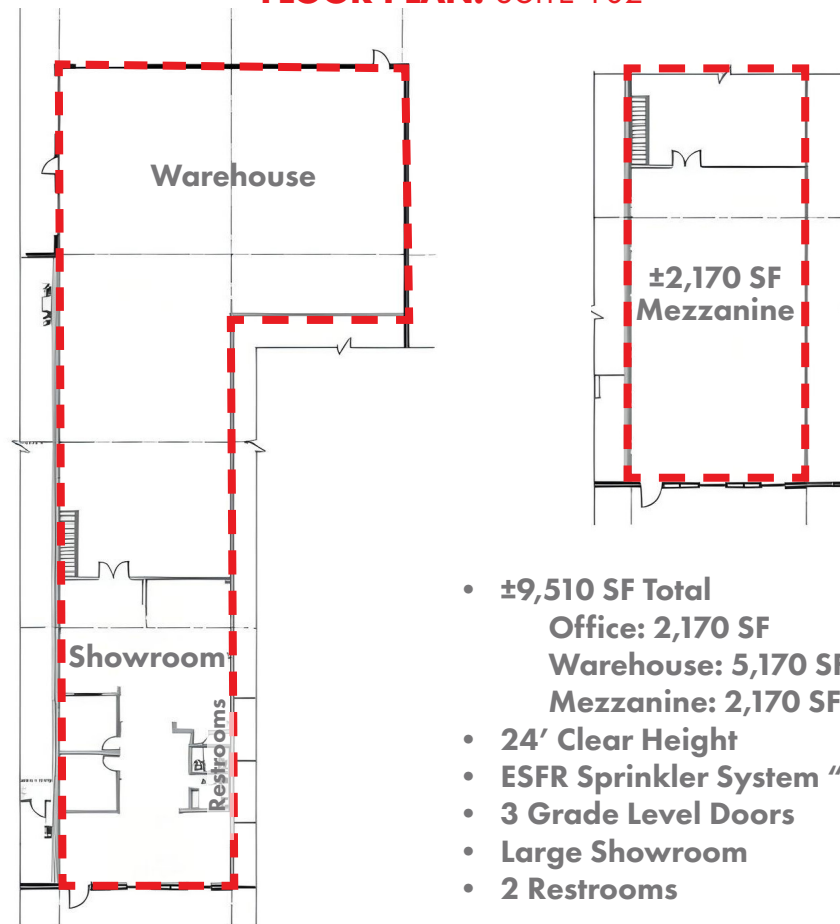

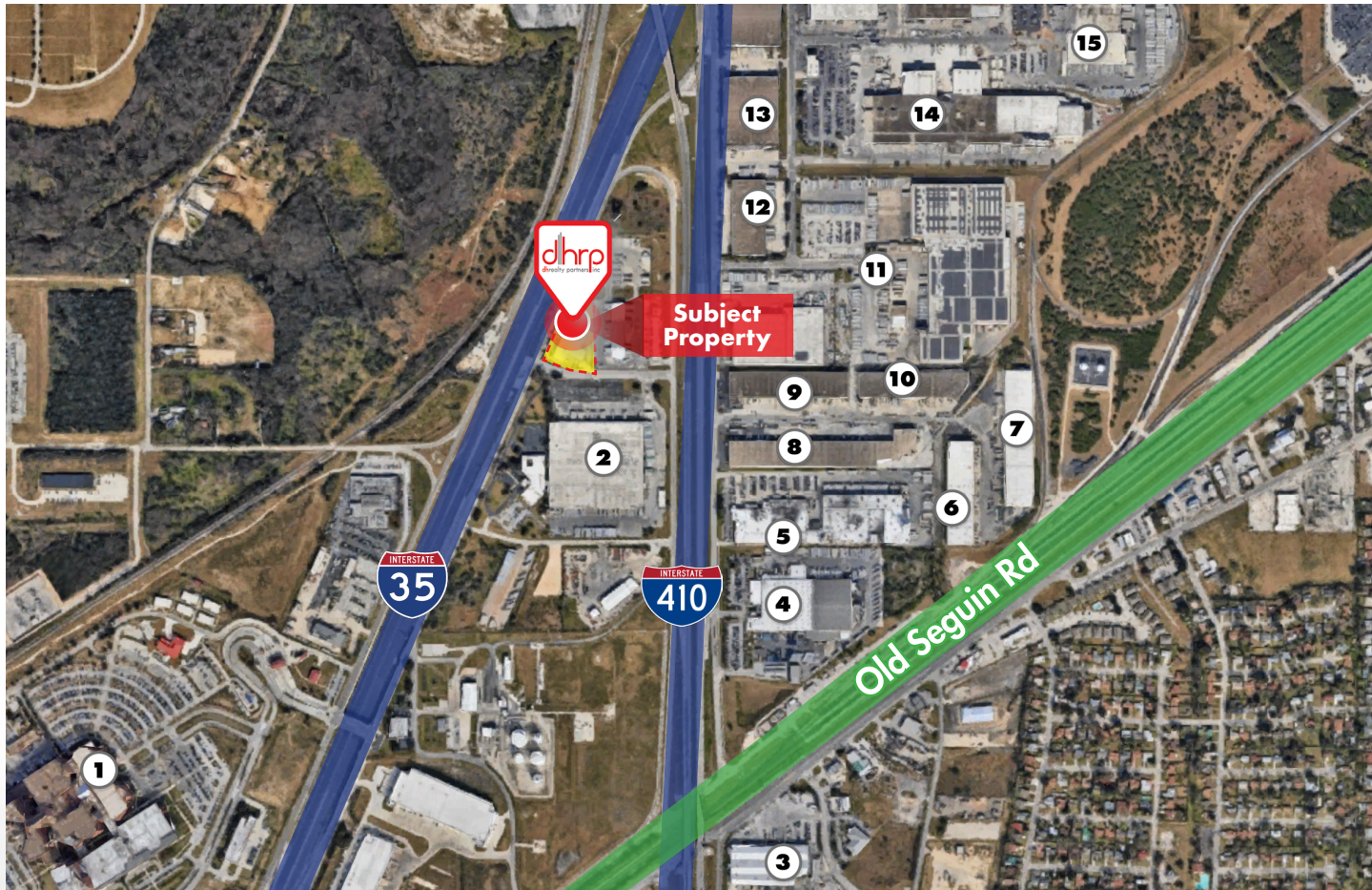

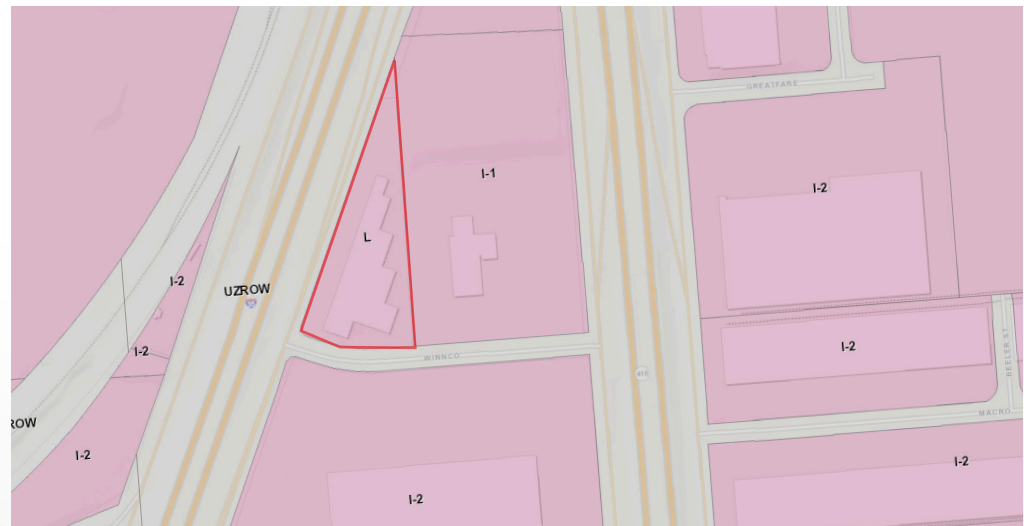
