The center also includes a new Metro Diner (opening Fall 2026) and a recently opened Verizon Wireless outparcel.

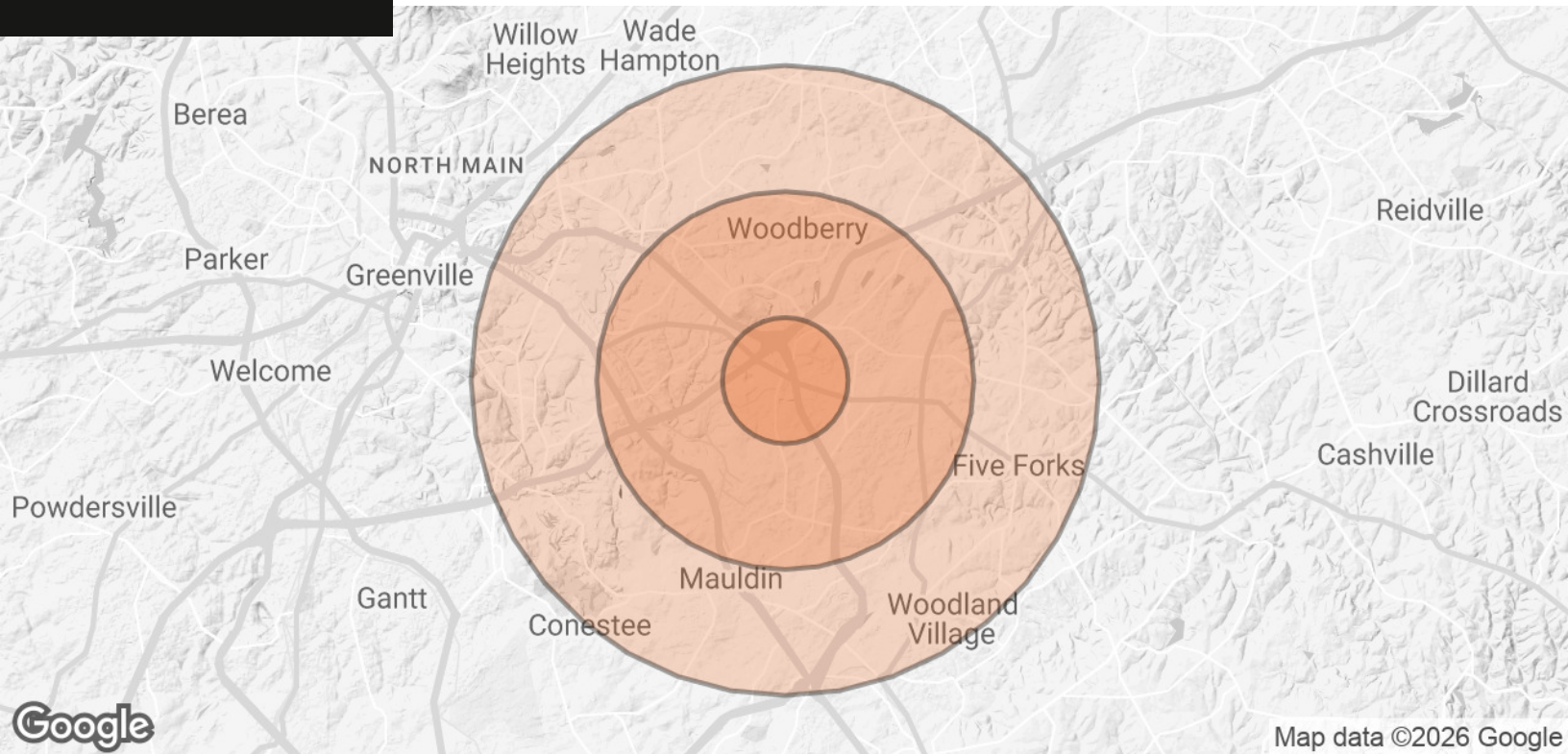
