BEGINNING, at the southwest corner of said Lot 4, within Val Verde Road (F.M. 1423) and the north line of Union Pacific Railroad right-of-way, for the Southwest corner of this tract;

THENCE N 08° 42' 22" E, along the west of said Lot 4, within said Val Verde Road (F.M. 1423) a distance of 290.65 feet, to the southwest corner of a tract of land deeded to Palm Shadows MHP LLC, recorded in Document Number 3440780, Deed Records, Hidalgo County, Texas, for the Northwest corner hereof;

THENCE S 81° 17' 38" E, along the common line of said Val Verde tract and Palm Shadows tract, at a distance of 40.00 feet, pass a ½" iron rod with a plastic cap stamped "CVQ LS" found, on the east right-of-way line of said Val Verde Road (F.M. 1423), continuing a total distance of 710.50 feet, to a ½" iron rod with a plastic cap stamped "CVQ LS" found, at the at the northwest corner of a tract of land deeded to Richard L Buhrt, recorded in Volume 2854 Page 687, Deed Records, Hidalgo County, Texas, for the Northeast corner hereof;

THENCE S 8° 42' 22" W, along the common line of said Val Verde tract and said Buhrt tract, a distance of 322.50 feet, to a ½" iron rod with a plastic cap stamped "CVQ LS" set, on the north line of said Union Pacific Railroad right-of-way, for the Southeast corner hereof;

THENCE N 78° 43' 37" W, along the north line of said Union Pacific Railroad right-of-way, at a distance of 671.17 feet, pass a ½" iron rod with a plastic cap stamped "CVQ LS" found, at the east right-of-way line of said Val Verde Road (F.M. 1423), continuing a total distance of 711.21 feet, to the **POINT OF BEGINNING**, containing 5.00 acres of land, more or less.
