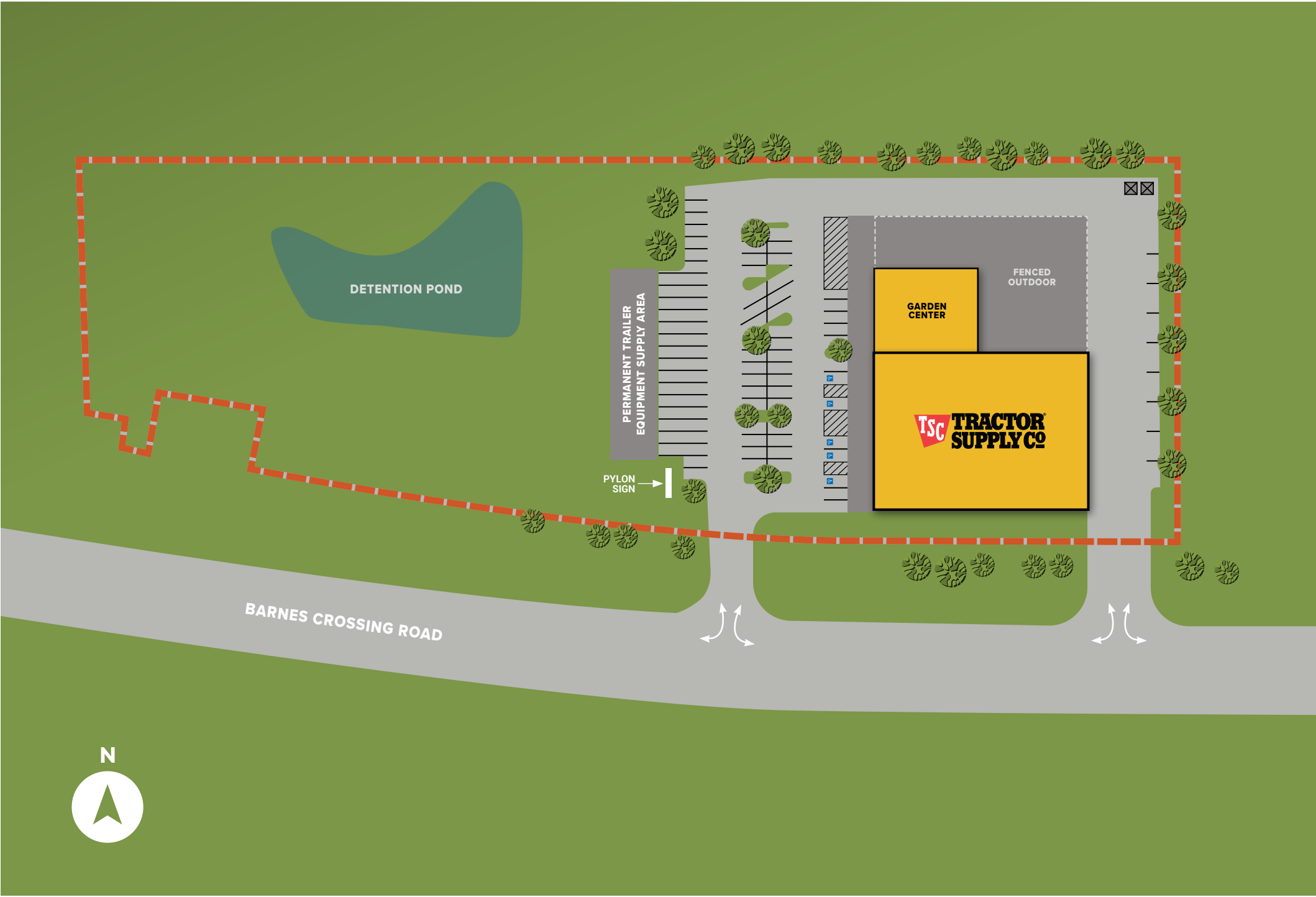

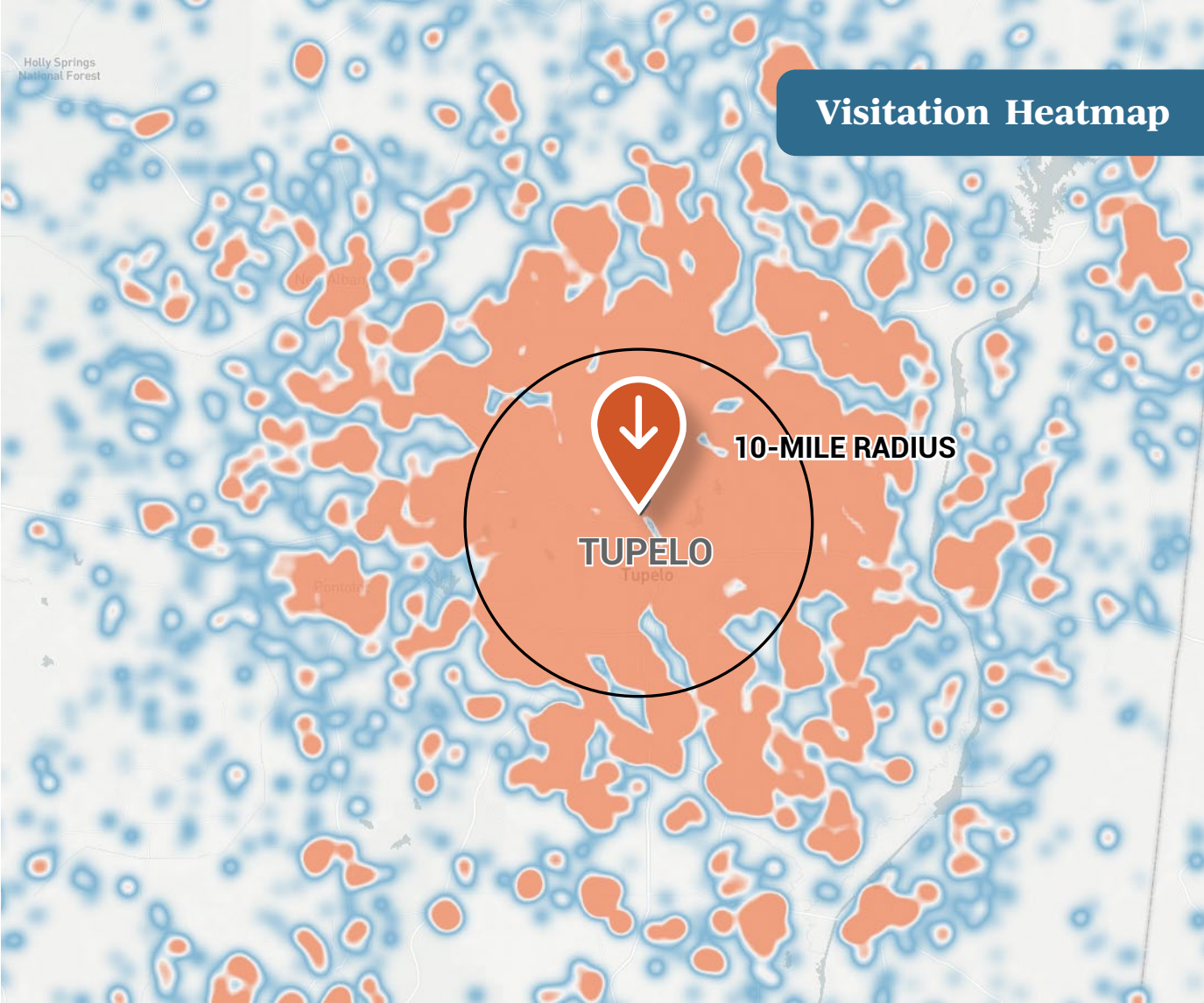

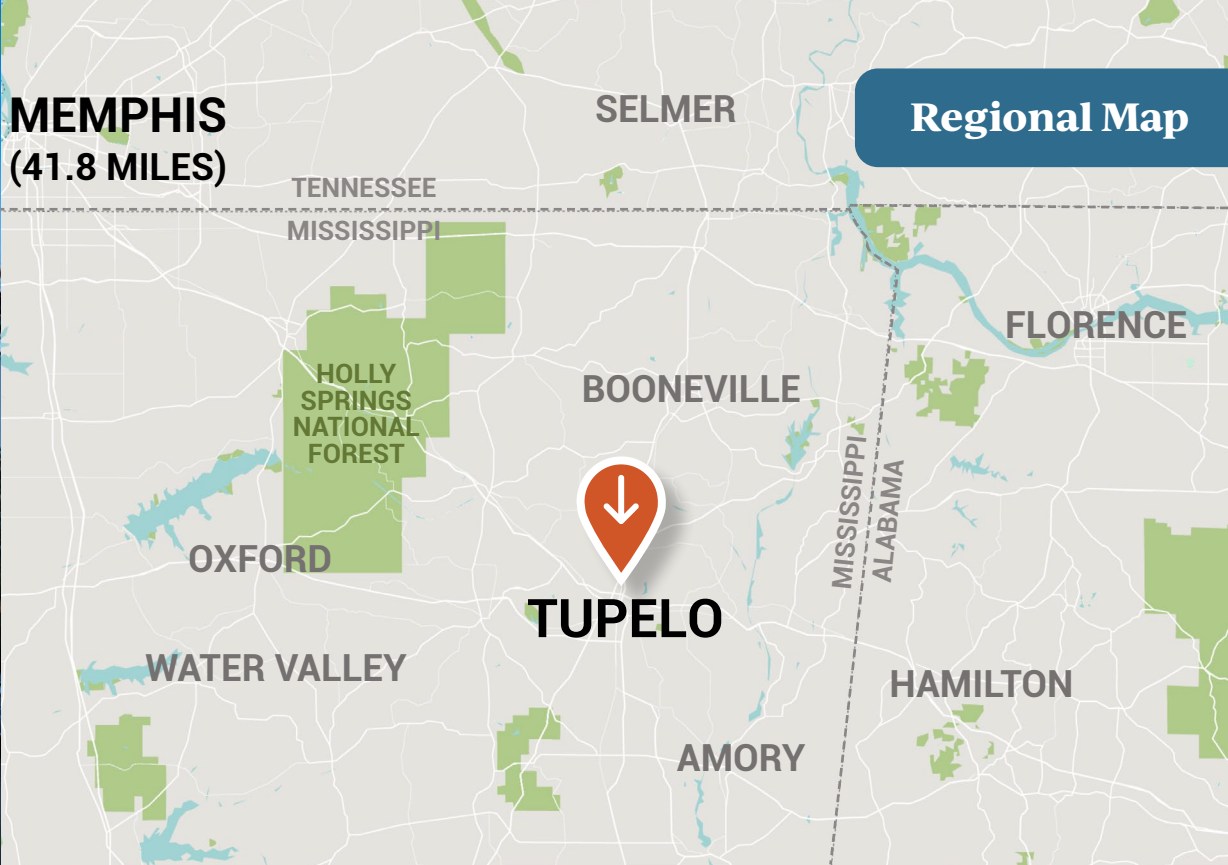
AVERAGE DWELL TIME AT THE SUBJECT PROPERTY
