While Phoenix ranks as the **5<sup>th</sup> largest U.S. city by population** as of 2024, the 2024 Population Estimate for a 5-Mile Radius boasts 504,000 people, with **2029 Population Projections pushing closer to 545,000 people**. This growth is driven in large part by the “Silicon Desert” expansion happening in the greater Phoenix area.

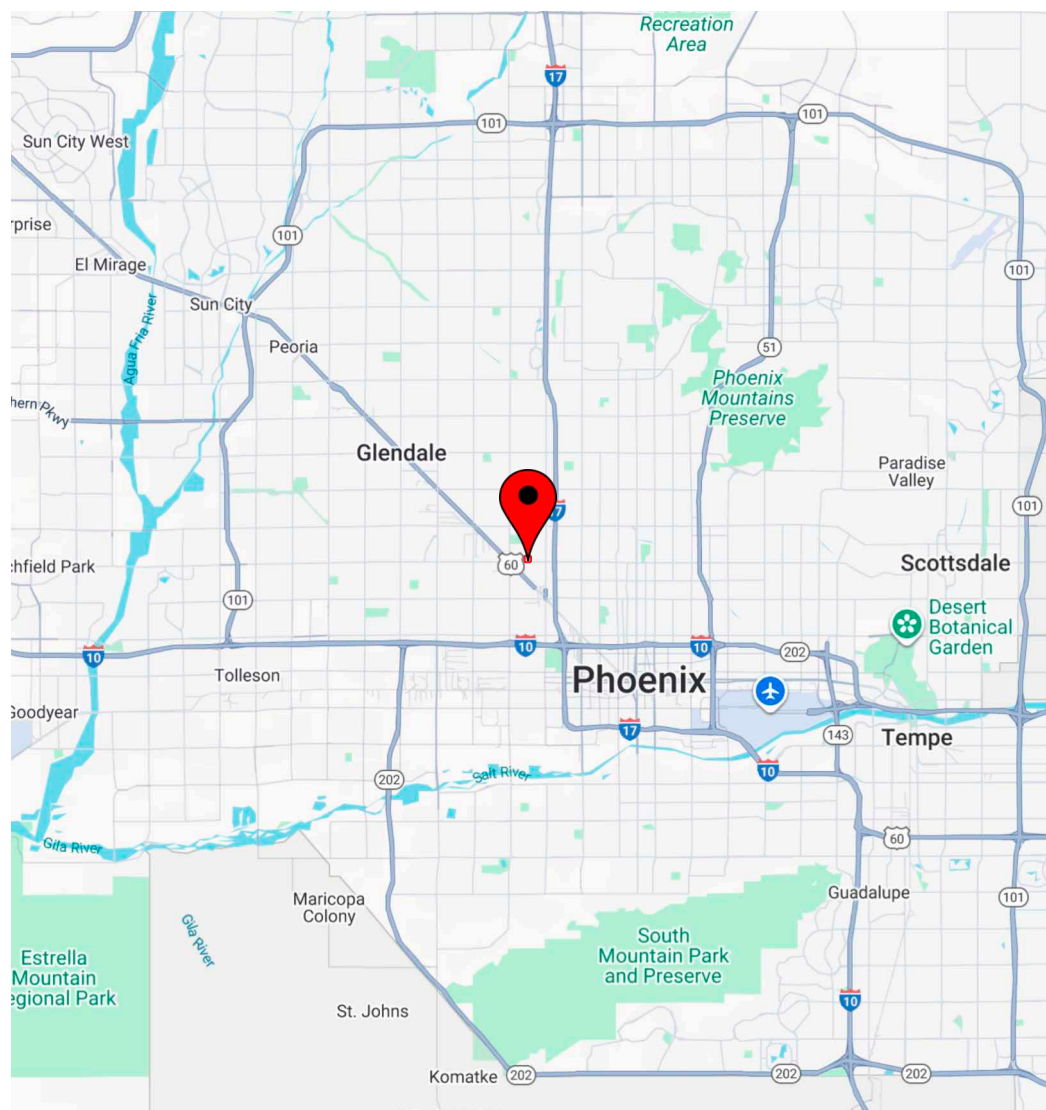

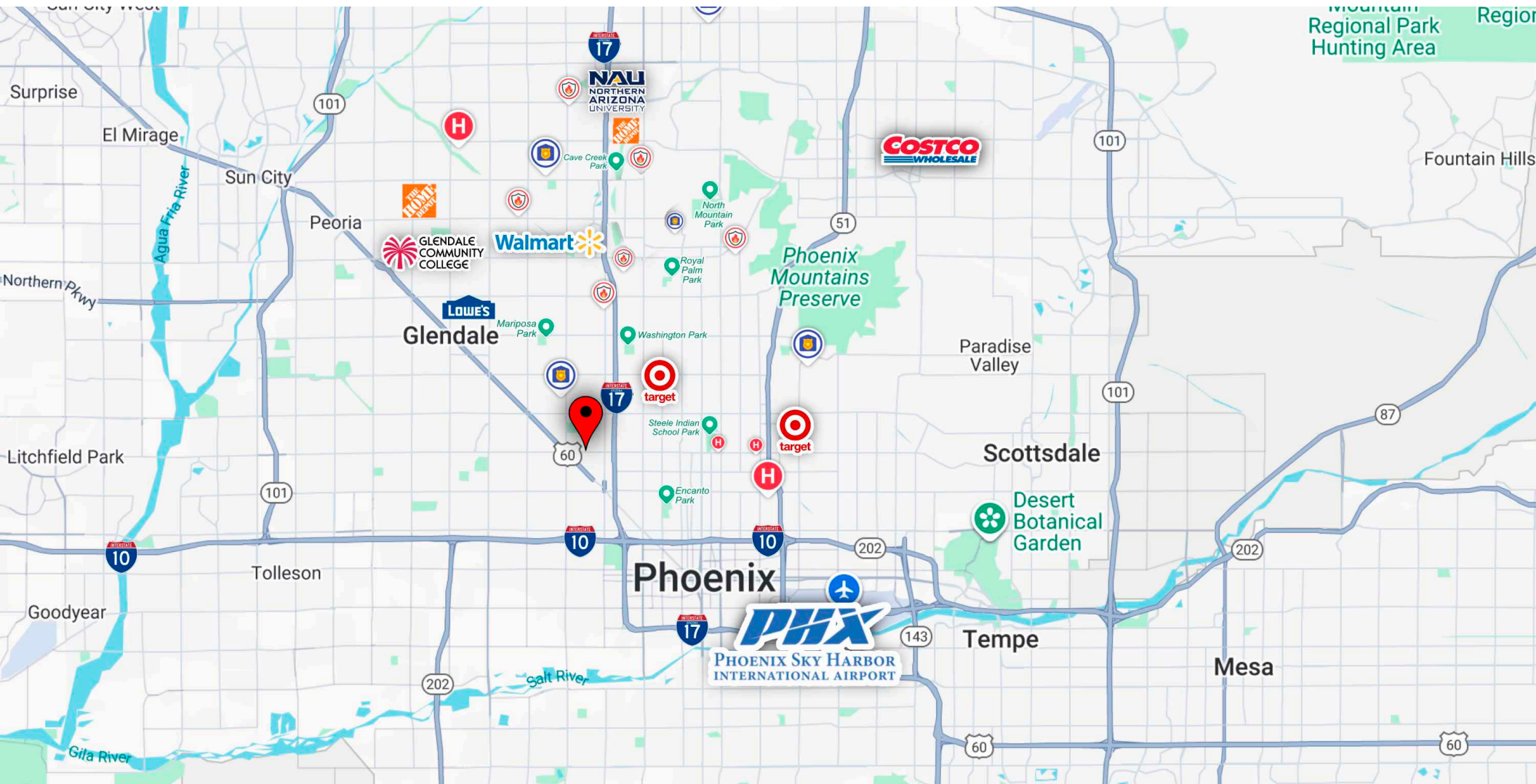

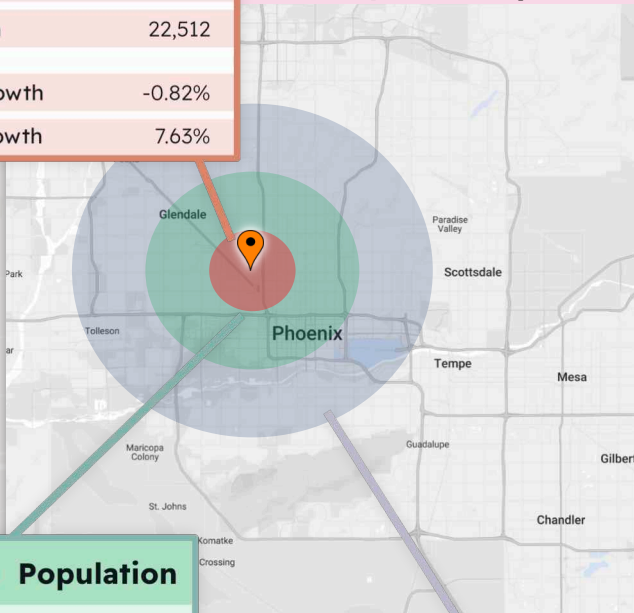

### Population by Radius



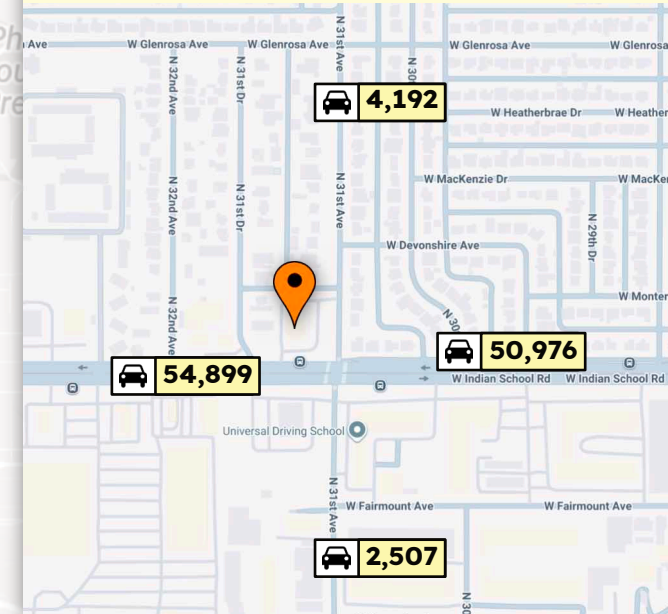
