Currently, 63.4% of the 16,543 housing units in the area are owner occupied; 27.5%, renter occupied; and 9.1% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 13,759 housing units in the area - 69.6% owner occupied, 22.5% renter occupied, and 7.8% vacant. The annual rate of change in housing units since 2010 is 8.53%. Median home value in the area is \$187,562, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 2.74% annually to \$214,697.
