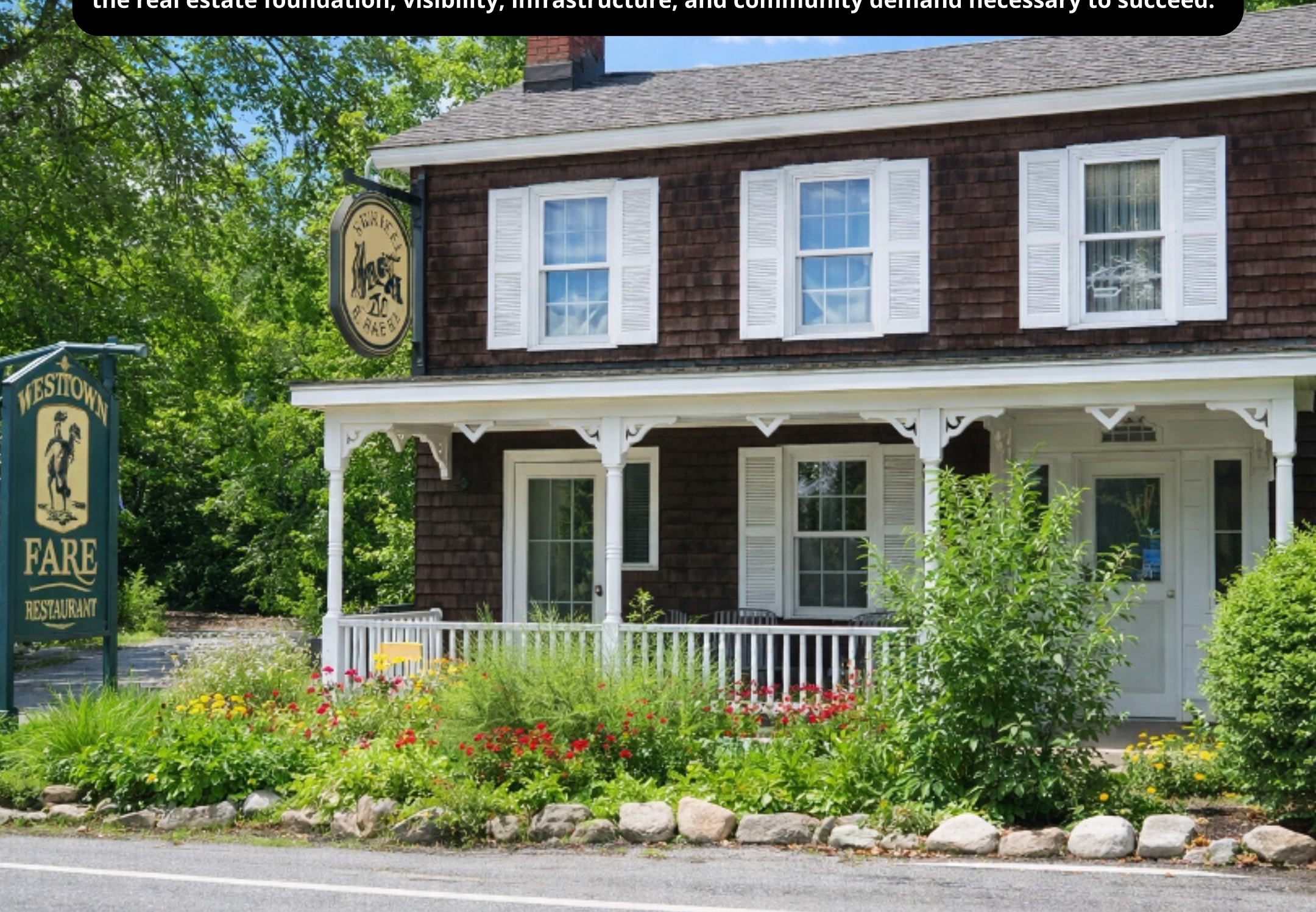

The two-story structure, originally built in 1850, offers character and charm while supporting modern restaurant operations, making it ideal for continued hospitality use or repositioning to a new food and beverage concept, café, specialty retail operation, or mixed-use adaptation subject to local approvals under its NC – Neighborhood Commercial zoning designation.
