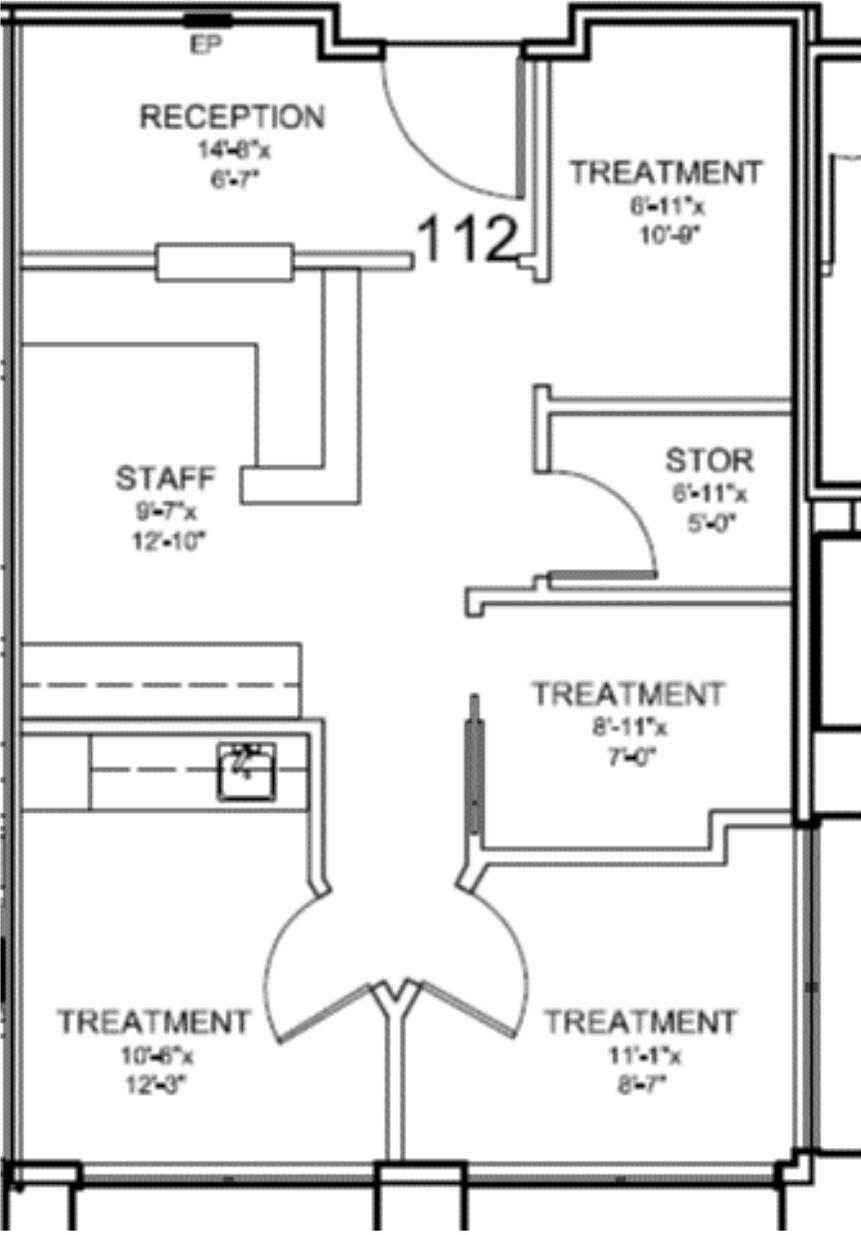

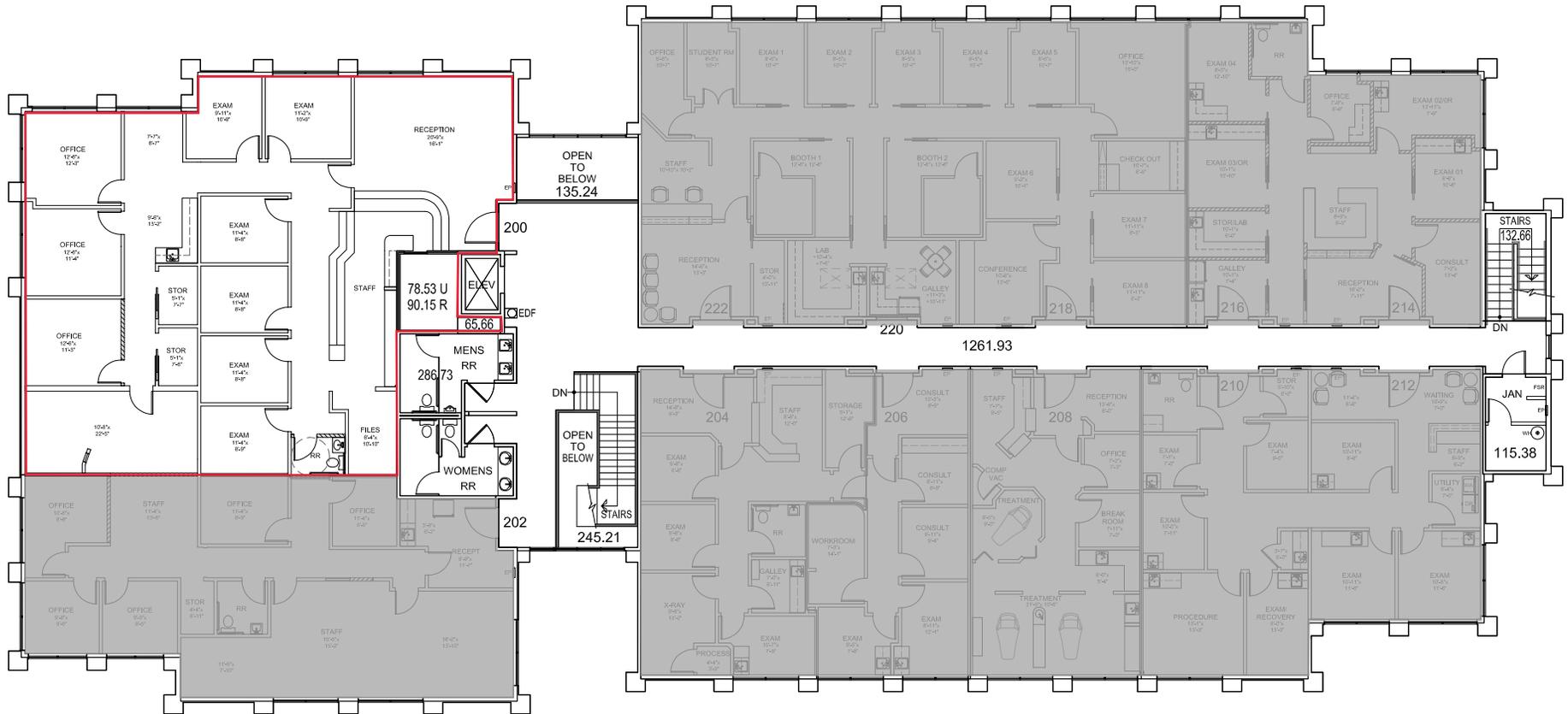

FLOOR PLAN | SUITE 112



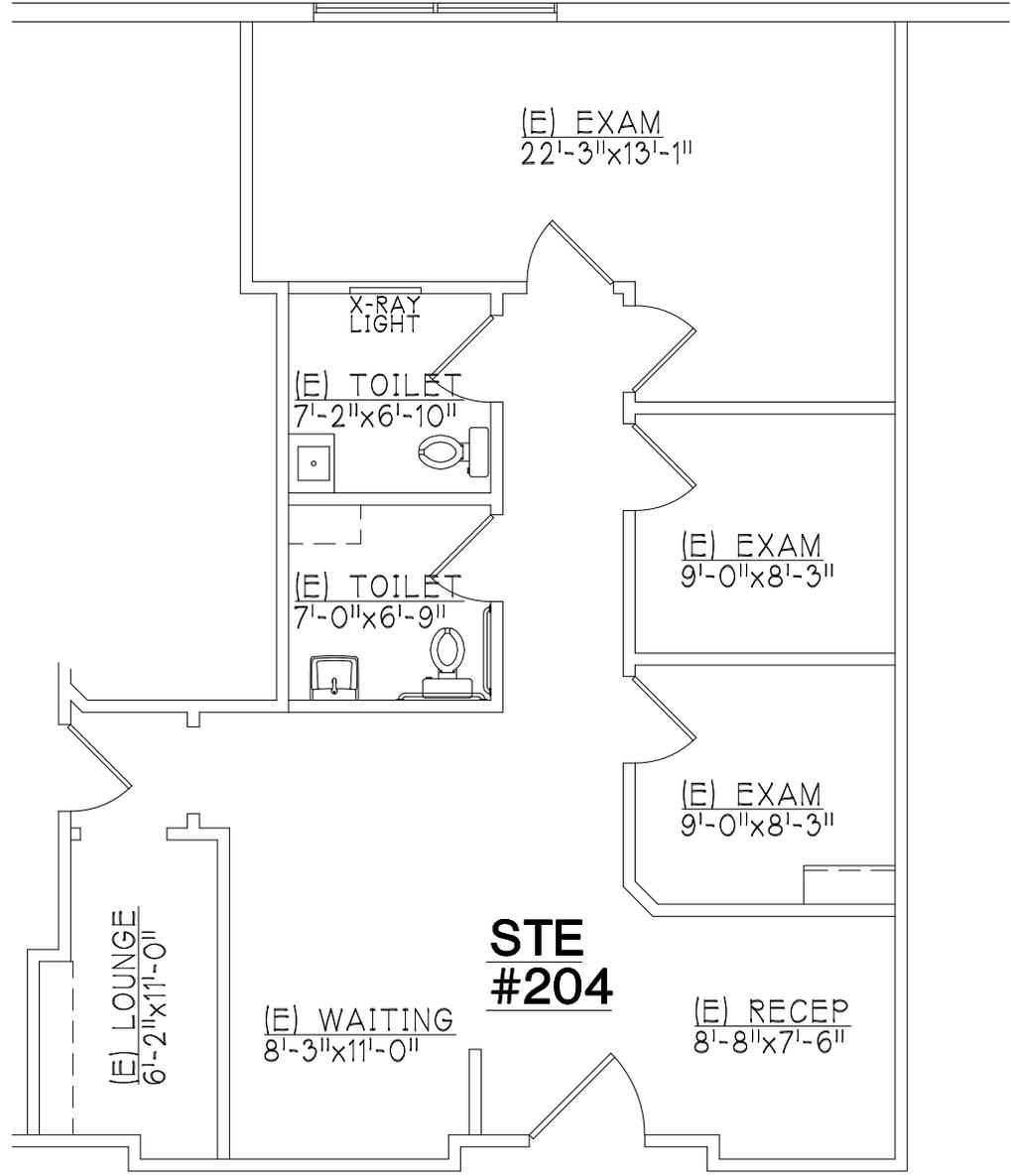
