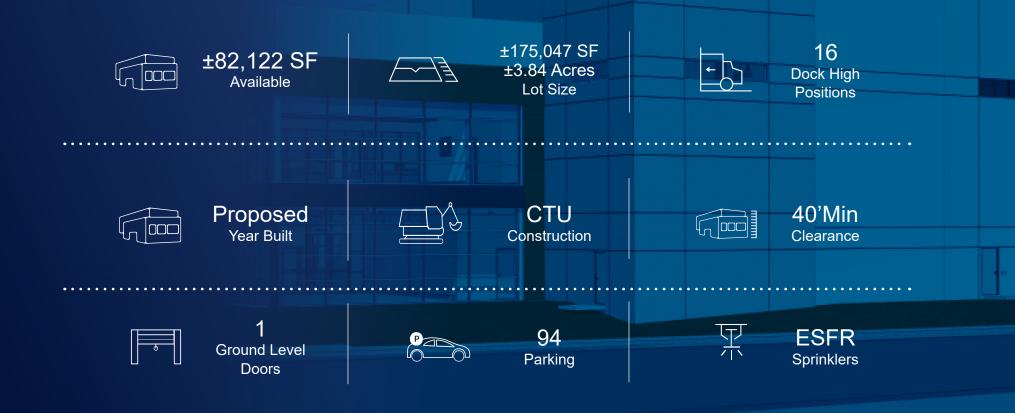

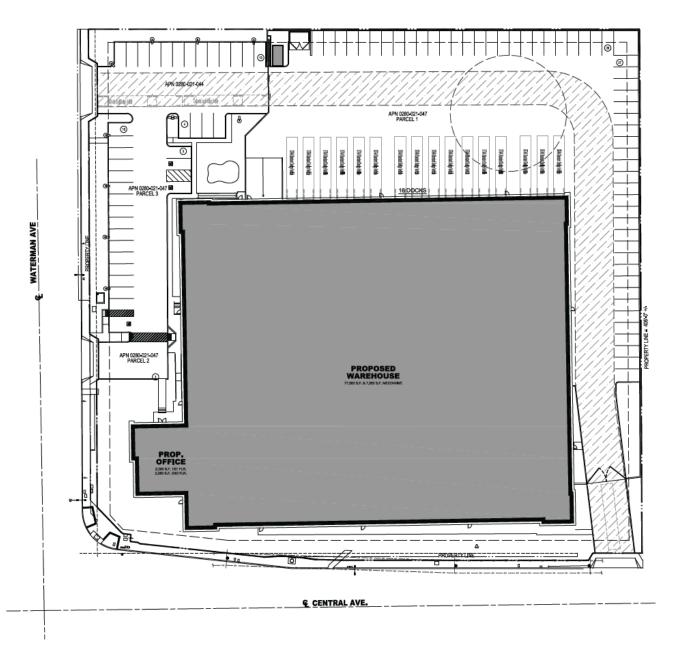

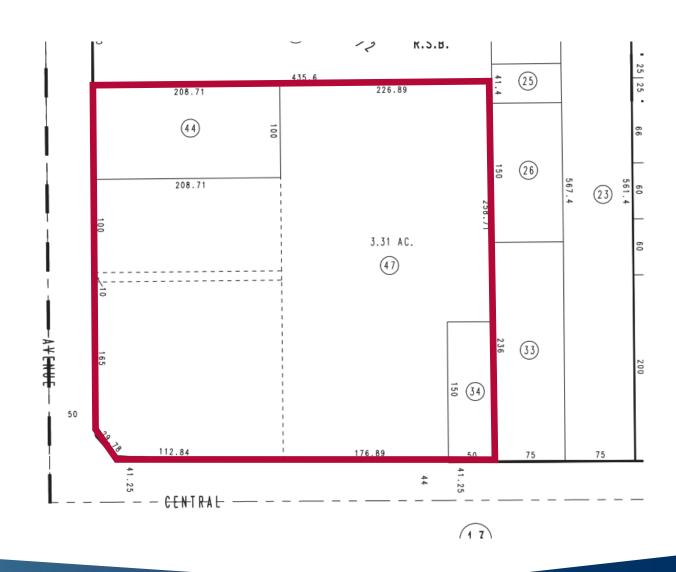




#### PARCEL MAP

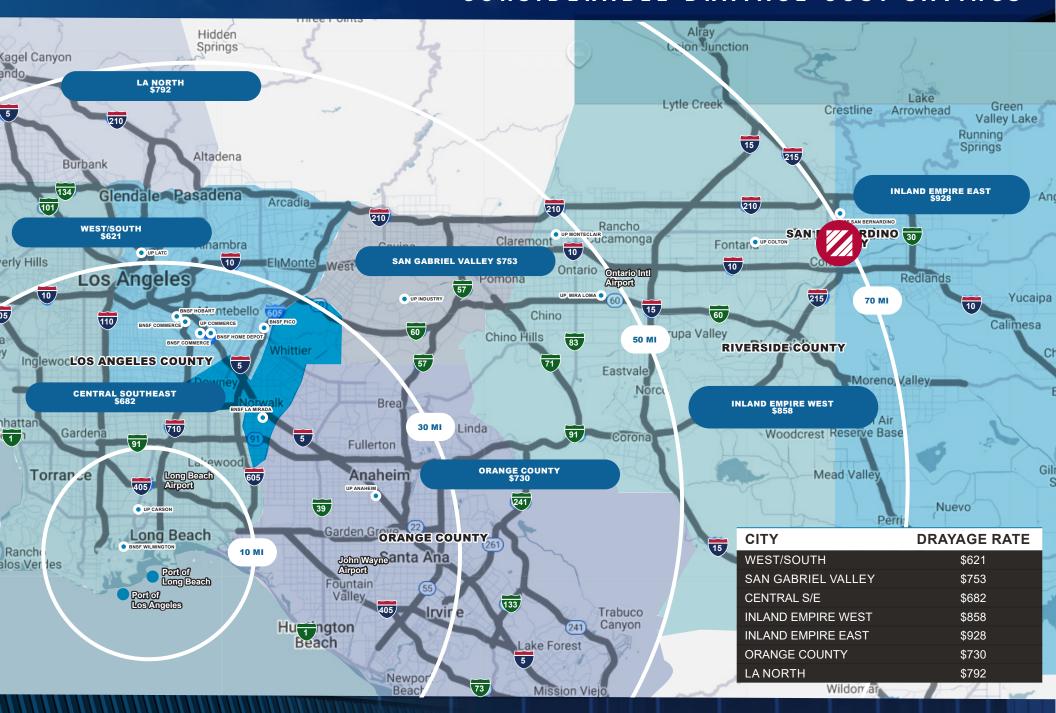
